MINUTES OF THE RECESSED MEETING OF THE LAKE LURE TOWN COUNCIL HELD WEDNESDAY, SEPTEMBER 9, 1992 AT 5:00 P.M. AT THE LAKE LURE COMMUNITY CENTER

Members present of the Lake Advisory Committee were as follows: Bob Washburn, Chairman, Dick Beeson, Mary Ann Dotson, Jack Powell, and Alva Pryce.

The first item of discussion pertained to the Request by the Trucker's Association to serve beer at their cookout Friday, September 18, 1992, from 5:00 p.m. until 12:00 midnight.

Commissioner Karr moved, seconded by Commissioner Bush, to approve the request based on the ordinance titled, <u>Ordinance Governing Consumption of</u> <u>Malt Beverages, Unfortified Wine, Fortified Wine, Spirituous Liquor, or Mixed</u> <u>Beverages on Certain Public Places</u>, that the portion of the ordinance pertaining to malt beverages, will be suspended on Friday, September 18, 1992 from 5:00 p.m. until 12:00 midnight for the sole purpose of the F-100 Truck Show.

The decision was based upon the guidelines of Section 2 of the ordinance which reads as follows: <u>Permit</u>: The Town Council of the Town of Lake Lure may grant a permit allowing consumption of either malt beverages, unfortified

wine, fortified wine, spirituous liquor and/or mixed beverages for special events on the Town Beach or within the Community Center, and the permit shall be in writing and describe the date and hours in which the operation of this ordinance shall be temporarily suspended for said special event.

Isothermal Planning and Development Commission has a vacancy on their Board of Directors involving service oriented planning. Commissioner Lehner moved, seconded by Commissioner Karr, to appoint Bill Bush to represent the Lake Lure Town Council. Commissioner Donovan voted yes, and Commissioner Bush abstained. However, Commissioner Bush accepted the position.

The Lake Advisory Committee presented to Council the third draft of the proposed policy on structures on the lake. Council discussed calling for a public hearing dealing with the policy at the September regular Town Meeting and hold the public hearing at the October regular meeting.

Council discussed the need for a committee dealing with the evaluation of the Zebra Mussel. Commissioner Bill Bush and Jack Powell, a member of the Lake Advisory Committee, were appointed as Co-Chairpersons. Council suggested that any interested parties wishing to be involved in the committee should go into Town Hall and sign up. Council recommended that the Co-Chairpersons present suggestions on the committee at the next work session.

Mr. Hord announced that the dredging equipment would soon be ready for on-site inspection and suggested that Paul Wilson, a member of the Lake Advisory Committee, and a member of the Town Council go on-site to inspect the two pieces of machinery when the time becomes appropriate.

Bob Washburn, Chairman of the Lake Advisory Committee, suggested that when we stock the lake with fish in the 1992-93 budget year, that we are sure that the waters where the fish come from are not infested with the Zebra Mussels. Approximately \$7,000 was budgeted for 92-93. Mr. Washburn suggested that the lake be stocked in the fall. PAGE 3 - MINUTES OF THE SEPTEMBER 9, 1992 COUNCIL MEETING

Council discussed the relationship between the State Wildlife and the Town Council and what exactly the Wildlife does for the Town. Council requested that Bob Washburn verify with Jervis Arledge, Attorney at Law, about the Town's ownership of the lake and what restrictions apply.

Mr. Washburn complemented Mike Souther for the job he did as Lake Patrol Officer.

With no further items of discussion, Commissioner Bush moved, seconded by Commissioner Lehner, to recess to Wednesday, September 16, 1992 at 2:00 p.m. at the Lake Lure Community Center for the purpose of meeting with the Lake Advisory Committee to review the proposed Lake Structures Policy. The vote of approval was unanimous.
