MINUTES OF THE REGULAR WORKSHOP MEETING OF THE LAKE LURE TOWN COUNCIL HELD TUESDAY, NOVEMBER 9, 1993 AT THE LAKE LURE TOWN HALL AT 9:30 A.M.

Mayor Doyle called the meeting to order at approximately 9:30 a.m.

Council briefly discussed the proposed classification, compensation, personnel plan for Town employees which was presented to them at the October 26, 1993 Regular Council Meeting by Mr. Bob Crowder, Membership Services Consultant for the North Carolina League of Municipalities.

It was the consensus of Council to table this item until a later date when the Town Manager could be present to give input into the matter.

Council discussed the importance of involving the Zoning and Planning Board with architectural plans for the Town.

Mayor Doyle announced that the food pantry for needy families would be organized again this year as was done last Christmas. Council is hoping to be able to appoint a Chairman for the project.

Martha Jane Powers would like to give a presentation at the next regular Town Meeting regarding the Children's Christmas Party. Also, if it can be arranged, Council would like to honor Devault Edgerton, retired Town Employee, for his services to the Town.

Council discussed when to hold the organizational meeting of the newly elected members of the Town Council. It was the consensus of Council to hold the organizational meeting at the November 23rd, 1993 regular meeting of Council if an agreement has been made by Council at that time on whom shall fill the seat of Commissioner Max Lehner as he takes the seat of Mayor. If an agreement has not been made prior to the November 23, 1993 meeting, the organizational meeting will be held December 14, 1993 at Fairfield Mountain's Bald Mountain Country Club.


Council agreed that the elected officials will be sworn in by Judge Loto Greenly Caviness. The vacant seat of Council will be agreed upon and that person will be sworn into office, and then the Mayor Pro-tem issue will be decided upon.


Mayor Doyle announced that McGill Associates has started the work on the Town of Lake Lure water survey.

Mary Lynne Ray, Deputy Zoning Administrator, gave a report on the status of the Lake Structure Certification process which is underway and must be completed by May, 1994. Ms. Ray said that the process is approximately 1/4 completed.

With no further items of discussion, Commissioner Bush moved, seconded by Commissioner Lehner, to adjourn. The vote of approval was unanimous.
