## **ADOPT RESOLUTION NO: 00-07-20 POLICE GRANT**

WHEREAS, the Town of Lake Lure herein called the "Applicant" has thoroughly considered the problem, addressed in the application entitled Traffic Safety Unit and has reviewed the project described in the application; and

WHEREAS, under the terms of Public Law 89-564 as amended, the United States of America has authorized the Department of Transportation, through the North Carolina Governor's Highway Safety Program to make federal contracts to assist local governments in the improvements of highway safety,

# NOW THEREFORE BE IT RESOLVED BY THE (GOVERNING BODY OF UNIT OF GOVERNMENT) IN OPEN MEETING ASSEMBLED IN THE CITY OF LAKE LURE, NORTH CAROLINA. THIS 20TH DAY OF JULY, 2000, AS FOLLOWS:

- 1. That the project referenced above is in the best interest of the Applicant and the general public.
- 2. That Police Chief Mike Bustle, LLPD be authorized to file, in behalf of the Applicant, an application in the form prescribed by the Governor's Highway Safety Program for federal funding in the amount of \$63,684.75 to be made to the Applicant to assist in defraying the cost of the project described in the contract application.
- 3. That the Applicant has formally appropriated the cash contribution of \$21,228.25 as required by the project.
- 4. That the Project Director designated in the application form shall furnish or make arrangement for other appropriate persons to furnish such information, data, documents and reports pertaining to the project, if approved, as may be required by the Governor's Highway Safety Program.
- 5. That certified copies of this resolution be included as part of the application referenced above.
- 6. That this resolution shall take effect immediately upon its adoption.
