#### CALL TO ORDER

Mayor Proctor called the meeting to order at 3:00 p.m.

Commissioner McCallum gave the invocation.

#### APPROVE AGENDA

Commissioner Watkins made a motion to approve the agenda as presented. Commissioner McCallum seconded the motion, and the vote of approval was unanimous.

## Consider Recommendations from the Lake Advisory Committee Regarding Lake Structure Regulations

Town Council and the Lake Advisory Committee discussed the draft proposal of the lake structures regulations dated July 30, 2007. Each page of the draft was reviewed for additions, changes and corrections.

Community Development Director Shannon Baldwin and Zoning Administrator/Code Enforcement Officer Teresa Reed were present to answer questions regarding the proposed changes and to provide recommendations.

Council discussed the lake structure certification tags which were developed and issued several years ago to lake front owners for each lake front structure. Council suggested they would like to see the lake structure certification tag process reinforced identifying the actual structures and displaying the actual street address from the lake front.

Town Manager Place suggested that the term board be deleted from the draft and replaced with committee based on the fact that boards are considered long term and committees are considered short term.

Under 94.02 definitions it was noted that the lake advisory committee is a committee appointed by town council to advise the town council, marine commission and administration on lake related issues. It was also noted that the lake structure certificate is a document that is issued to property owners following approval by the lake structure administrator. The definition for light trespass was added to reflect light directed or projected beyond the projected perimeter of 50 feet from any light source on the lake structures or shore.

It was unanimously agreed that the lake advisory committee would make the noted changes to the draft and that a final lake structures regulations document be presented to council for adoption at their regular meeting scheduled Tuesday, August 14, 2007.

#### **ADJOURNMENT**

With no further items of discussion, Commissioner McCallum made a motion to adjourn the meeting. Commissioner Watkins seconded the motion and the vote of approval was unanimous.
