April 7, 2016 - Decorum

During our special meeting on Apr. 11, 2016, I plan to address the decorum in our March 8 closed session. My planned statement is below. This is being done with everyone's knowledge.

Mr. Mayor, I rise to a point of order regarding Decorum in Debate. Am I allowed to state my point?

Thank you Mr. Mayor. My point of order is in the form of a prepared statement. In accordance with parliamentary procedures, no names have been mentioned and no particular members identified.

During our closed session March 8, debate became somewhat contentious and heated at moments. This is often expected in healthy, passionate debate. Unfortunately, matters went beyond healthy debate to a level of decorum that exceeded common courtesy, creating a tense and uncomfortable environment. Without expounding further on the particulars of that scenario, and without judging any individual, I wish to officially protest that behavior. I do not condone it, nor will I tolerate it, just as it would not be tolerated from me. Such activity is neither conducive to conducting Town business, nor is it in the best interest of the citizens we serve.

Moving forward, I pray such indecorum will not be repeated. However, should it occur again, it is the responsibility of each one of us to object to it immediately. We, as civilized people and public servants should never allow such behavior to occur. We can promptly challenge agregious violations of decorum in a manner that does not escalate the situation by courteously saying something like, "Check decorum please", or "Please remember courtesy".

I suggest we adopt a simple mandate to leave personal grievances and personalities at the door to our chambers, that we respect the decisions of our members regardless if we agree or not, and that we will strive to prevent this in the future. I further suggest that as a collective body, and by means of our concurrence, that this constitute an official apology to the Town Clerk, Town Manager, and Town Attorney for having to witness this uncomfortable situation.

Thank you Mr. Mayor, I yield the floor.
