# **Town Manager's Report to Council January 8, 2013**

#### 1. Golf Course

We closed out the 2012 season with a busy New Years Eve day. The month of December saw 240 golfers enjoy the course for a grand total of 4620 golfers for the eight months of operation. We lost a large pine tree on number four during one of the high wind events and are in the process of removing it. We are checking all irrigation heads for operation and identification and will soon be trimming all heads and boxes. We will be edging and trimming all bunkers, checking drainage and preparing to add new sand. We also will be aerifying and topdressing greens in late January to prepare for crabgrass pre-emergent applications in February. Kathy and Dale will be attending the PGA show in Orlando to get ideas for clothes and other items for sale. They are planning to increase their apparel selections with new companies and items for sale with the club logo. 2012 was a good beginning for us even with the problems that we experienced on the greens. There was a lot of positive vibe, we met a lot of wonderful people, and best of all we, as a family, had fun working together and seeing people enjoy the "Little Course That Could."

## 2. Fire

- Responded to 44 fire, rescue or EMS calls
- Contracted with Streetwise to provide computer data terminals in fire trucks (Facebook grant)
- Completed all testing of pumps, hydrants and hoses for the year
- Completed 309 person-hours of training
- Received word of a \$40,000 grant award for the replacement of our brush truck

#### 3. Police

- Responded to 678 calls for service (5 accidents)
- Responded to 1 reports of breaking and entering investigation led to arrest with 5 felony counts
- Officers made 1 arrest
- Officers issued 7 citations, 3 written warnings and 23 verbal warnings
- Performed 1 lake patrols and issued 0 citations
- Chief and Lt. made 30 visits with local business owners in December. All local businesses will be visited on a rotating schedule during the year as part of our community policing program.
- In January: will be returning the government Humvee (not useful) and selling a surplus Crown Vic on GovDeals.com

- Police: crime rate remains low, cases were resolved with convictions, drug bust
- Lake: another safe year of boating and events on a very healthy lake

#### **Finance**

- With assistance from Julie and department supervisors, Sam delivered improvements to the budgeting process, to the Comprehensive Annual Financial Report and to electronic utility billing.
- Achieved a small surplus for the 4<sup>th</sup> year in a row added to fund balance.
