

ORDINANCE NO. 1, 2008

AN ORDINANCE AMENDING SCHEDULE OF MUNICIPAL COMPENSATION

**WHEREAS**, the Council adopted Ordinance No. 8, 2007 establishing the Schedule of Municipal Compensation effective from July 1, 2007 through June 30, 2010; and

**WHEREAS**, it is necessary to amend Ordinance No. 8, 2007 and the Schedule of Municipal Compensation to reflect compensation changes both in the Finance Department with the hiring of the new Director of Finance and within the Recreation Department as a result of reorganization within the Department.

**NOW, THEREFORE, BE IT ORDAINED** by the Council of the City of Montgomery, Ohio:

**SECTION 1.** The Schedule of Municipal Compensation adopted by Ordinance No. 8, 2007, attached hereto as Schedule A and incorporated herein by reference, is hereby amended to establish compensation of municipal officials and employees effective upon passage of this Ordinance through June 30, 2010.

**SECTION 2.** All other parts of Ordinance No. 8, 2007 which were not amended are hereby ratified and reaffirmed.

**SECTION 3.** This Ordinance shall be in full force and effect from and after the earliest period allowed by law.
