To ensure the safety of your child, **NO CHILD WILL BE RELEASED TO ANYONE OTHER THAN THEIR PARENT/LEGAL GUARDIAN, WITHOUT PRIOR WRITTEN NOTIFICATION BY THE CHILD'S PARENT/GUARDIAN TO THE SAFETY VILLAGE STAFF.**

PLAN TO ARRIVE EARLY ON THE FIRST DAY WHEN YOU DROP OFF YOUR CHILD TO ATTEND A BRIEFING BY THE SAFETY VILLAGE COORDINATOR. The Safety Village Staff will be introduced and the events of the week will be explained.

Please make sure that the session you choose will work best for you and your family. Due to the overwhelming popularity of Safety Village, if you later find that you have a conflict, YOU WILL NOT be able to switch your child to another session.

### **Arrival and Dismissal Times: Swaim Park (Zig Zag Rd. Parking Lot)**

Drop off for Morning Sessions is anytime after 8:55 AM with session starting promptly at 9:00 AM and will conclude at Noon. Plan on picking up your child between 11:55 AM and Noon.

Drop off for Afternoon Sessions is anytime after 12:55 PM with session starting promptly at 1:00 PM and will conclude at 4:00 PM. Plan on picking your child between 3:55 PM and 4:00 PM.

PLEASE MAKE SURE THAT YOU SEND A BICYCLE HELMET WITH YOUR CHILD, SO THAT THEY MAY PARTICPATE IN THE SAFETY VILLAGE TRICYCLE COURSE!!!!
