RIDE ALONG WAIVER

The undersigned applicant has requested the Chief of Police to allow him/her to ride in a police vehicle at a specified time with a police officer for the purpose of observing the officer's activities.

The undersigned applicant (and parents/legal guardian if under 18) understand that riding in a police vehicle is an inherently dangerous activity, likely to suddenly place the rider in circumstances beyond the control of the police department or the officer.

Accordingly, the applicant (and parents/legal guardian), on behalf of himself/herself and his/her heirs, assigns or personal representatives, hereby agree to waive and release all claims he/she may have for any physical or psychological injuries, including death, sustained while participating as an observer riding along in a police vehicle. This waiver shall be for the benefit of the officer operating the vehicle, the Mooresville Police Department, the Town of Mooresville and any of its other employees or agents.

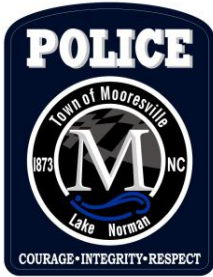

RIDE ALONG INSTRUCTIONS

Each Citizen granted permission to ride in a police vehicle will be expected to obey the following instructions:

- 1 You must dress appropriately and appear neat and clean. No uniforms, shorts, provocative clothing or other inappropriate dress will be permitted.
- 2 You shall not engage in any conduct likely to cause harm to yourself or another or provoke any individual to a breach of the peace by your conduct. You shall obey the instructions from any officer during your ride along.
- 3 You shall remain in the police vehicle during any activity unless specifically directed by the officer.
- 4 You shall not attempt to operate or utilize departmental vehicles or equipment unless directed by the officer.
- 5 Any information relating to an on-going investigation shall be considered confidential and shall not be divulged.
- 6 You shall not carry weapons of any nature during the ride.
- 7 You shall follow any instructions deemed appropriate by the on-duty supervisor or the officer driving the vehicle.
