Councilman Lesnewich presented Resolution 2012-223 approving purchase order #44321 for General Code Publishers Corp., in the amount of \$2,912.00.

Councilman Cucco presented Resolution 2012-225 authorizing payment of the attached bills payable list, in the amount of \$11,523,349.12. He stated of that total, approximately \$70,000 is being paid to the library, \$6,458,123 to the Board of Education, \$3,023,551 to County of Union, and \$94,443 for County Open Space. He stated that amounts to approximately \$9,646,269 that the Borough does not have any control over.

He stated the agreement explains if the Borough needs to dig up the ground to access the drainage easement, the Borough will not be responsible for replacement of the basketball court.

Mayor Hern introduced Ordinance 2012-11 amending the definition of "Personal Services Establishment" at Section 310-6 of the Borough Code. He stated this is an Ordinance modifying the Borough Code to add terms to the definition of "Personal Services Establishment". He stated it will add language after "beauty services" to also include spas, day spas, and massage as an accessory use. He added it excludes massage as a principal use.

Mayor Hern opened the Ordinance for discussion by Council. No further discussion.

Councilman Robinson expressed he is very pleased that this project is taking place soon and stated the project will help with the traffic control and children's safety when walking to school.

COUNCIL COMMITTEE REPORTS.

Robinson - operations normal, nothing to report.

Muñoz – spoke with residents from Tall Oaks area and reported they are very pleased that the sidewalk project is going to take place.

Cucco – operations normal, nothing to report.

Lesnewich – operations normal, nothing to report

BOROUGH ADMINISTRATOR'S REPORT.

Administrator Marvin reported on the following items:

- 1) Foley Square participated in pre-construction meeting last week on the Foley Square project. All of the buildings have been vacated. Demolition is expected to begin in September.
- 2) Sidewalk Improvements he received an inquiry from a resident asking for a possible sidewalk installation on Floral Avenue on the South side of the street. He stated he would speak with the Borough Engineer to provide an engineer estimate on the improvements, and also ask Jim Johnston to provide a list of priorities for such improvements for future years.
- 3) Community Activities he reported the Recreation 2012-2013 brochure is completed and posted on-line. The printed copies will be mailed to all residents next week.
- 4) Flooding he reported the sudden severe storms of the past few weeks have created flooding issues in several areas of town, specifically Lavina Court. He stated Jim Johnston and his crews removed 10 fallen trees as well as much debris from the stream a couple of weeks ago hoping that would resolve the issue, but unfortunately the sudden rain last week caused flooding again. He stated he would be walking the area the next day with Jim Johnston to see what other solutions might be available.
- 5) Pearl Street Project he reported the project is expected to begin on Monday, August 20th. He stated the project includes milling and paving, intersection improvements at Pearl and Union, pedestrian enhancements, and new curbing and sidewalk repairs.

Administrator Marvin to COAH – Forfeiture of Uncommitted Funds 08-11-0-12

Attorney Woodward summarized the above communication. Woodward stated the Borough received a form from COAH asking the Mayor to provide a certification regarding the Borough's affordable housing funds. He stated the Borough has collected approximately \$350,000 over the years, but has spent more than that in support of affordable housing. He added the Borough appropriated \$50,000 in the 2012 budget for affordable housing. He stated the Superior Court's recent decision was that COAH does not have the right to request this information. He stated after consulting with the other attorney involved in the litigation, the Borough will respond to the Executive Director of the Council on Affordable Housing and explain where the \$50,000 funds came from.

PUBLIC COMMENTS:

This is an opportunity for any member of the public to be heard about issues that are not separate topics, scheduled for public hearings tonight. To help facilitate an orderly meeting, and to permit all to be heard, speakers are asked to limit their comments to three (3) minutes, and may only speak once on any one topic.

Mayor Hern opened the meeting for public comments.

Joe (full name not stated) – pedestrian crosswalk on Springfield Avenue (near Academy Street). He stated the drivers do not stop for pedestrians crossing the street even when

he activates the flashing pedestrian sign. He asked if a police officer could stand at the crosswalk. Mayor Hern stated the police patrol that area to the best of their ability and unfortunately they do not have enough staff to have someone stand there. He stated some trees are to be removed in that area which will hopefully eliminate some of the shade that disguises the pedestrians when they are standing there.

Pat Moschetti – 50 Sherwood Drive

- 1) Police Department Consolidation New Providence and Berkeley Heights. Mr. Moschetti asked about the status of a shared dispatch between New Providence and Berkeley Heights, being that he read an article regarding the subject in the newspaper. The Mayor stated the Township of Berkeley Heights does not wish to participate in a shared Police Department at this time.
- 2) Union County Freeholder Liaison Mr. Moschetti asked if the Council has frequent contact with the Union County Freeholders. Mayor Hern responded he has contact with the Freeholder chair and Administrator Marvin has contact with the County Manager. Mr. Moschetti stated 19 out of the 21 counties in NJ have a combined Sheriff and county staff, but Union County is one of the 2 that have separate departments. He asked Council to contact the county regarding this matter.
- 3) Old A&P building vacant Mr. Moschetti asked if the Council knows of any plans to fill the vacant building. Mayor Hern stated there is a pending application before the Board of Adjustment for a fitness center.

Larry Corsi – 28 Eighth Street

- 1) Recycling Asked Council if recyclables could now be co-mingled. Administrator Marvin replied the recycling company is temporarily experimenting and items should still be separated at this time.
- 2) Corner of Marion Avenue and South Street Development asked Council if they knew of any reasons for delay in construction. Mayor Hern replied they have not received any correspondence regarding a delay.
- 3) Livingston Avenue house near Senior Center noticed the property was being cleaned up and asked Council if they knew the status. Councilman Robinson stated after speaking with the owner he was notified the house is going to be demolished and rebuilt.
