Borough Council Minutes New Providence, New Jersey September 26, 2016

The regular meeting of the Borough Council of the Borough of New Providence, County of Union and State of New Jersey was held on Monday, September 26, 2016 at 7:00pm at the Municipal Center. Mayor Morgan called the meeting to order.

PLEDGE OF ALLEGIANCE.

Mayor Morgan led the Pledge of Allegiance.

PUBLIC NOTICE:

Mayor Morgan stated this is a public meeting of the Borough Council of the Borough of New Providence, County of Union and State of New Jersey. Adequate notice of this meeting has been given in accordance with P.L. 1975, Chapter 231, in that an annual notice or revision was made in conformance with Section 13 of the Act.

JCP&L UPDATE:

Rob Walton, area representative from JCP&L, addressed council to give his monthly update. He discussed JCP&L's capital plan and also the PSI Institute (Lineman School). He stated they have about 1,000 retirements per year and are always looking to train more potential employees.

Mayor Morgan stated this is for a stop sign at the intersection of Kline Place and Kline Boulevard. Mayor Morgan opened the public hearing on

Ordinance 2016-13. There being no one wishing to speak the hearing was closed.

Councilman Madden moved the adoption of Ordinance 2016-13, seconded by Council President Gennaro and on Roll Call: Council President Gennaro, Councilman Madden, Councilman Kapner, Councilman Munoz, and Councilman Robinson voted "aye". Carried on Roll Call.

PRESENTATION: Lantern Hill Update – Patricia Swan, Executive Director

Patricia Swan addressed Council to give updates on the Lantern Hill project. She stated she held a meeting with surrounding neighbors and Whiting Turner Maintenance, hired by Lantern Hill, to address the neighbors' concerns. She discussed the project timeline and the replacement of trees stating over 100 new trees have been planted. She stated the final phase would be completed soon with the continuing care facility to be completed in early 2017. She also discussed their new "Hilltop Social Club" club license that was recently granted to them for serving liquor on the premises. Mayor and Council thanked Ms. Swan for her presentation and for her constant communication with them and the surrounding neighbors.

Councilman Robinson presented Resolution 2016-297 authorizing agreement between the Borough of New Providence and Animal Control Solutions for the years 2017 and 2018, in the amount of \$15,960.00 per year. He stated the Board of Health solicited RFQ's for animal control services and is recommending awarding the contract to Animal Control Solutions. He stated not only were they priced the lowest, but the Borough currently has a contract with them and the Board of Health has been very pleased with their services. He also stated there is no increase in the contract price over last year.

Councilman Kapner presented Resolution 2016-306 amending Resolution 2016-046 "Resolution Approving Purchases From Denville Line Painting, Morris County Co-Op #36, For Line Painting For The Year 2016", Adopted January 4, 2016". He stated this resolution increases the annual authorized limit for line striping with Denville Line painting to \$40,000, since the original amount authorized of \$25,000 is insufficient to complete the various projects within New Providence in 2016, most notably the re-striping of the MH RR Parking Lot.

2. Resolution 2016-307

"Resolution Accepting Bids And Awarding Contract To A A Berms, LLC, For The 2016 Sidewalk Program, In The Amount Of \$99,309.20"

Councilman Kapner presented Resolution 2016-307 accepting bids and awarding contract to AA Berms, LLC for the 2016 sidewalk program in the amount of \$99,309.20. He stated AA Berms was the lowest responsible bidder and the bid includes sidewalk installation on Pearl Street between Cameron and Hawthorne Drive, sidewalk installation on South Street between Central Avenue and Diane Court, and installation on Southgate between the MH RR Parking Lot and Knollwood Drive. He stated in addition there would also be 1500 linear feet of sidewalk repairs.

DISCUSSION ITEMS:

2017 Holiday and Meeting Schedule – Administrator Marvin discussed the 2017 dates with council members. All were agreed upon except the council meeting date of February 14th (Valentine's day) which was moved to February 15th instead.

Passaic River De-Snagging Update – Borough Administrator

Administrator Marvin stated he was in touch with a company that handled the desnagging for 13 of the surrounding communities. He stated Jim Johnston would identify the trees and the company would send a quote for de-snagging. He stated they might be able to use funds from the Clean Communities Grant. Council members discussed putting funds aside in future year's budgets to keep up with the removal of trees from the river. They also discussed possible grant opportunities to aid in the cost of tree removal.

COUNCIL COMMITTEE REPORTS.

Councilman Madden – reported on the following:

- 1) Oakwood Park construction underway and the park is currently closed.
- 2) Municipal Alliance "Chasing the Dragon" movie reel to be shown at the high school. Thanked the Board of Education for working with the municipal alliance.

Councilman Muñoz – reported on the following:

1) Voter registrations were dropped off to residents at Lantern Hill to either change their address or register to vote for the upcoming election.

Councilman Robinson – reported on the following:

- 1) Sustainability Committee Rob Keller received a letter from the Union County Freeholders & Ground Work Elizabeth asking if they would like an additional \$830 for the community garden. He stated Paul Seth would be constructing an irrigation drip system at the garden for his Eagle Scout project.
- 2) October 11th Flu Clinic at the DeCorso Community Center.

Mayor Morgan - reported on the following:

- Discussed happenings throughout the U.S. involving police shootings and commended the New Providence police and emergency services for working so well together, and commended them for working so hard to serve and protect the community during these difficult times.
- 2) Thanked Council members for handling his affairs during his absence and thanked Council President Gennaro for speaking at 9/11 ceremony.

BOROUGH ADMINISTRATOR REPORT.

Administrator Marvin reported on the following:

- 1) Seniors in Motion Grant passenger vans to be delivered in November.
- 2) Union County Infrastructure Grant stated he spoke with Amy Wagner from Union County about switching grant funding from Central Avenue to the Murray Hill Train Lot paving project since the Central Avenue project was on hold due to the DOT shutdown.
