Councilman Gennaro presented Ordinance 2017-05 on first reading, stating this ordinance increases the open space tax levy to .006 cents per one hundred dollars of assessed value.

Councilman Gennaro presented Ordinance 2017-06 on first reading, stating this ordinance provides for the 2017 capital improvement authorization as included in the 2017 municipal budget.

Councilman Gennaro presented Resolution 2017-113 approving the bills payable list with significant payments to AmeriHealth \$106,332 and VCI Emergency Vehicles \$193,897.

Councilman Gennaro presented Resolution 2017-114 which authorizes the refunding of a homestead rebate benefit to an exempt veteran in the amount of \$331.47.

1. Resolution 2017-116

Councilman Madden presented Resolution 2017-116 which approves a proposal from Maser Consulting for construction administration services related to the demolition of the Ping Wang Greenhouses not to exceed \$7,500.

2. Resolution 2017-117

"Resolution Accepting The Proposal Of Maser Consulting, P.A. For Professional Engineering And Professional Environmental Consulting Services Regarding Stormwater Outfalls"

Councilman Madden presented Resolution 2017-117 which approves a proposal from Maser Consulting to perform the state required inspections of the Borough's 164 storm sewer outfalls in an amount not to exceed \$6,500.

Councilman Madden presented Resolution 2017-118 which approves professional services of Suburban Consulting Engineers to prepare the necessary documents to separate the original streetscape project work from all of the alternate bids to expedite completion of the overall project.

Councilman Madden noted as a requirement of the grant, federal regulations require on-site inspections, at all times work is being performed, which could cost \$100,000.00. Councilman Madden requested Council have a discussion to determine if it is cost effective to accept the grant and the requirements that come with it. Council discussed the options and agreed that so long as the Borough nets out to the positive, it is still in the interest of the Borough to accept the grant.
