Borough Administrator Marvin reported Clare Wherley, Lassus Wherley Associates, P.C, called to advised that her 5 year lease extension will expire at the end of 2017 and she is reviewing her options. Administrator Marvin advised Ms. Wherley expressed an interest in purchasing the building or renewing her lease. Mr. Marvin noted that the Borough Attorney's memo addressing the two options was previous distributed with the agenda.

Council discussed the options noting what a great tenant Lassus Wherley Associates, P.C. has been and how well they have maintained the property. After discussion by Council it was the concurrence of Council to retain ownership of the property and continue to lease the property.

Council authorized the advertising for a part-time Youth Programs Coordinator In The Community Activities Department.

BOROUGH ADMINISTRATOR REPORT.

Borough Administrator Marvin reported on the following items:

- 1) Sharing Network is planning to hold the 2018 5K on June the 3rd.
- 2) Suburban Consulting has revised the Downtown Streetscape plans and have submitted them to the DOT for comments.
- 3) Mountain Avenue Traffic concerns:
 - a) Have been in touch with Union County and as part of the repaving of Mountain Avenue they will be delineating the travel lanes with white striping.
 - b) Spoke with Rob Walton, JCP&L, who advised they will replace existing street lights with LED lights at no charge to the Borough. It was further noted that Council may want to consider for this section of Mountain Avenue.
 - c) Spoke Joe Graziano, Union County, who is not opposed to having a consistent speed on Mountain Avenue in the area of concern.
- 4) Infrastructure work going on in New Providence over the summer which will include gas main replacement, water main replacement and our own paving projects.

Ira Krauss – Board of Education

- 1) Had a fire outside of A.W. Roberts School want to thank the Fire Department and the Police Department for the quick response. JCP & L responded along with representatives of the solar panel company and were able to adapt the power so that school did not have to be canceled. Solar company will be repairing all the damage.
- 2) New Providence School District was nationally recognized as a School District of Character, one of only seven districts nationwide to receive the award.

Mr. Morton addressed Council regarding pet stores, sale of animals, along with the new Jersey regulations and licensing requirements of breeders and pet stores. Mr. Morton urged Council not to move ahead with the "Puppy Mill Ordinance" suggesting there is a political agenda.

Cindy Hall, Furrylicious Whitehouse, N.J. Ms. Hall addressed Council regarding the state regulations that control humane pet breeding. Ms. Hall stated the ordinance Council has been asked to adopted would prohibit pet owners from purchasing a dog which is a good fit for them and would put pet stores and pet boutiques out of business. Ms. Hall requested council not act on the proposed ordinance.

Gus Gallinnot – 53 Charnwood Road. Mr. Gallinnott asked Council about the removal of a tree behind his home in the Passaic River, which fell During "Sandy". Mayor Morgan advised the tree will be removed, however, the Public Works Manager is working on a date for the contractor to be in down to do all the tree removal work.
