Borough Council Minutes New Providence, New Jersey August 27, 2012

The regular meeting of the Borough Council of the Borough of New Providence, County of Union and State of New Jersey was held on Monday, August 27 at 7:00 PM at the Municipal Center. Mayor J. Brooke Hern called the meeting to order.

PLEDGE OF ALLEGIANCE:

Mayor Hern led the Pledge of Allegiance.

PUBLIC NOTICE:

Mayor Hern stated this is a public meeting of the Borough Council of the Borough of New Providence, County of Union and State of New Jersey. Adequate notice of this meeting has been given in accordance with P.L. 1975, Chapter 231, in that an annual notice or revision was made in conformance with Section 13 of the Act.

APPROVAL OF MINUTES:

Councilman Cucco moved the minutes of the August 13, 2012 Council Meeting be approved as submitted, seconded by Councilman Muñoz and unanimously approved.

PRESENTATION:

1. JCP & L Stan Prater, Municipal Representative

Stan Prater, Municipal representative from JCP&L, updated Council regarding the upgrades JCP&L has been making since last year's storms (Hurricane Irene and October snowstorm). He stated the old form of fax communication has been changed to email communication, and the company has also made new smartphone enhancements. He also stated the website has an outage map with estimated restoration times per area and stated customers can report outages online. He also updated Council on JCP&L's tree trimming program and stated tree trimming inquiries would be handled on a case by case basis. He added they are installing laptops in all vehicles so workers will have live data and can more efficiently respond to outages. He stated the full implementation of the laptop installation should be completed by the end of 2013.

Councilman Cucco asked Mr. Prater about streets that lose power consistently. Mr. Prater stated it could be due to the amount of trees in the area and limbs that occasionally fall on the wires, but he would look into the streets in question and let him know the outcome of his findings.

Councilman Muñoz asked if a representative from JCP&L could be available in person if another major outage situation occurs. Mr. Prater answered they do not have enough staff to be available in person in all the municipalities they service, however they do send a representative to every County Office of Emergency Management when an emergency situation occurs.

Councilman Robinson asked if the company has hired any new employees since the last storm. Mr. Prater responded that even with the tough economic climate they have still managed to hire new employees to work in the field.

Robinson – reported on the following:

- 1) Congratulated Board of Education on NPHS being ranked #1 high school in NJ.
- August 17th Flash Concert "Random Acts of Kidness" sponsored by the Municipal Alliance.
- 3) Micropaving stated he received some complaints about the recent micopaving and explained micropaving only seals cracks and lasts approximately 5 years as opposed to milling and paving which is a complete resurfacing and is much more costly.

- 4) Central Avenue stated NJ American Water has agreed to pave some of Central Avenue after much persistence from Administrator Marvin and complaints from residents.
- 5) Board of Health stated he received complaints from residents near Foley Place regarding recent rat sightings. He discussed with members of Council the upcoming demolition of houses near Foley Place and the new construction in that area. They discussed having Keith Lynch speak with the contractor of the new development to make sure they would perform an extermination before the demolition.

Joe (last name not given) – asked Councilman Cucco why there is 1 garbage truck in the Borough, but 2 trucks for recycling. Cucco stated there is one truck per day and each section of the Borough has different garbage days. He stated if the truck has a mechanical problem the company may send out a second truck. He said there are 2 trucks for recycling since one is for metal and one is for paper. He added however recently there is only 1 truck for recycling since they are commingling on a temporary experimental basis.

There being no one else wishing to speak this portion of the meeting was closed.
