CAPITAL ORDINANCE OF THE COUNTY OF UNION, NEW JERSEY AUTHORIZING THE PROVIDING OF FUNDING TO THE UNION COUNTY IMPROVEMENT AUTHORITY IN CONNECTION WITH THE UNION COUNTY GOVERNMENT COMPLEX PROJECT IN, BY AND FOR THE COUNTY, APPROPRIATING THEREFORE THE SUM OF \$16,750,000 AND PROVIDING THAT SUCH SUM SO APPROPRIATED SHALL BE RAISED FROM THE CAPITAL IMPROVEMENT FUND AND CAPITAL SURPLUS OF THE COUNTY.

BE IT ORDAINED by the Board of County Commissioners of the County of Union, New Jersey, as follows:

Section 1. The County of Union, New Jersey (the "County") is hereby authorized, pursuant to N.J.S.A. 40:37A-79, to provide funding to the Union County Improvement Authority (the "Authority") in connection with the Union County Government Complex Project being undertaken by the Authority.

Section 2. The sum of \$16,750,000 is hereby appropriated to the payment of the cost of the improvement authorized and described in Section 1 hereof (hereinafter referred to as "purpose"). Said appropriation shall be raised from the Capital Improvement Fund and Capital Surplus of the County. The sum of \$9,750,000 is hereby appropriated from the Capital Improvement Fund of the County to the payment of the cost of said purpose. The sum of \$7,000,000 is hereby appropriated from Capital Surplus of the County to the payment of the cost of said purpose.

Section 3. Said improvement is a lawful capital improvement of the County having a period of usefulness of at least five (5) years. Said improvement shall be made as a general improvement, no part of the cost of which shall be assessed against property specially benefited.

Section 4. The capital budget is hereby amended to conform with the provisions of this capital ordinance to the extent of any inconsistency therewith and the resolutions promulgated by the Local Finance Board showing full detail of the amended capital budget and capital program as approved by the Director, Division of Local Government Services, is on file with the Clerk of the Board of County Commissioners and is available for public inspection.

Section 5. This ordinance shall take effect at the time and in the manner provided by law.
