It is the recommendation of the undersigned that this contract be awarded to the low bidder, Yarussi Construction, Inc. in the amount of \$445,400.00. Please note that this amount is funded by a combination of both CHIPS (\$210,000.00) and casino revenue (\$235,400.00) sources. Funding is available in codes A.5110.0200.0300.000 and H0621.2006.0621.0449.599 respectively.

Additionally, the Contractor has agreed to extend the unit prices of his bid to complete sidewalk replacements for the Niagara Falls Water Board, up to a not-to-exceed amount of \$20,000.00, pending the execution of a standard inter-agency agreement between the City and the Niagara Falls Water Board. Therefore, the City of Niagara Falls will enter into a contract with Yarussi Construction, Inc. for a total of \$465,400.00 at this time.

**Council Members:**

The Community Development Department has identified prior year's funds from the federal Emergency Shelter Grant (ESG) program which must be reprogrammed and expended by September 15, 2015. These funds were appropriated by Council to two agencies which were unable to utilize the grants. Community Development has subsequently ceased to fund the agencies.

It is proposed that the sum of \$18,997.57 in 2010 ESG funds be reprogrammed to Community Missions of Niagara Frontier, Inc. for emergency shelter operations activities, to be expended prior to September 15, 2015. Community Missions is instrumental in providing shelter operations in Niagara Falls, and will be able to expend the funds in accordance with the required timeline.

**Sign Encroachment Conditions: 300 Third Street**

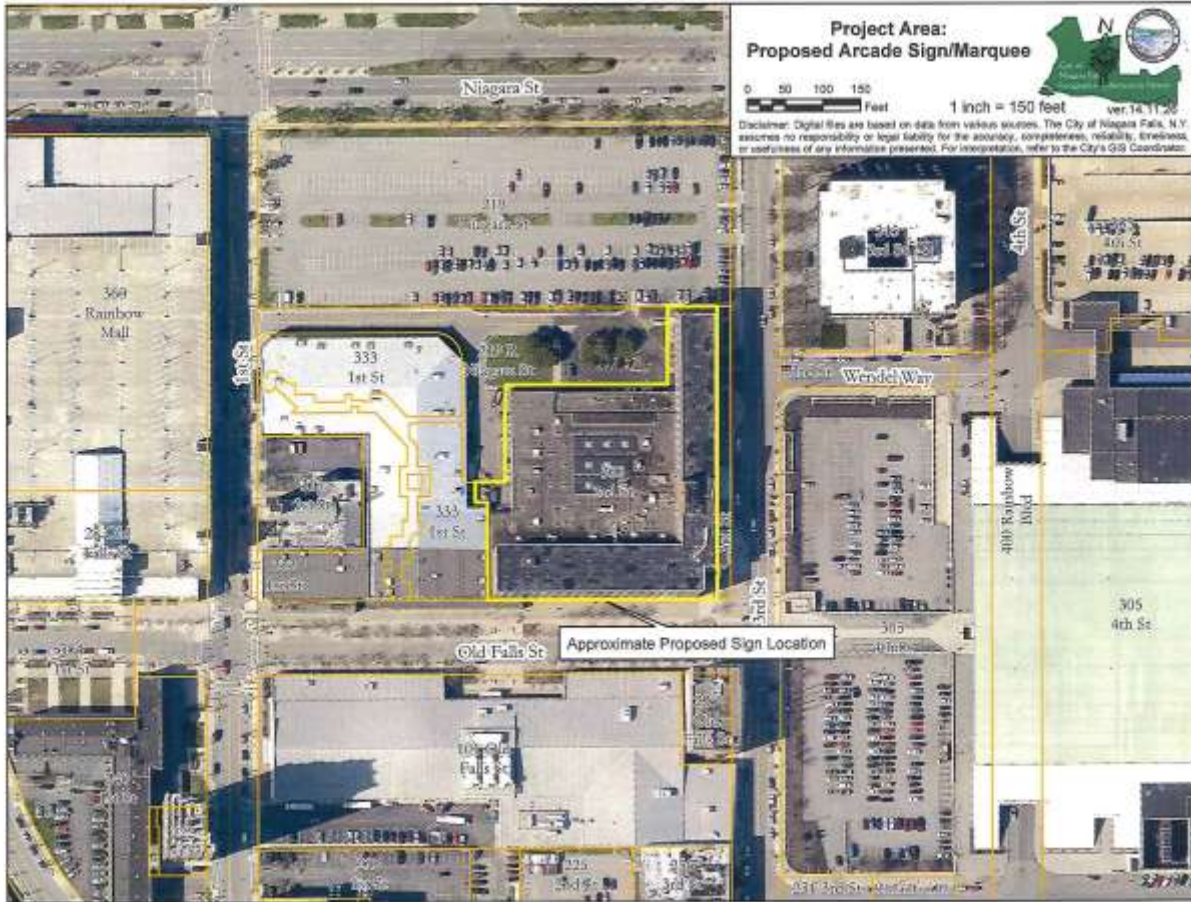
- 1) The owner/applicant will add the City of Niagara Falls as an additional insured on its liability insurance policy for any and all such encroachments approved by City Council
- 2) The owner/applicant will agree to defend and indemnify the City from liability related to the encroachment
- 3) The City can revoke the license for the encroachment on sixty (60) days' notice
- 4) The owner/applicant shall comply with any conditions imposed by the City Engineer with regard to sufficient space for pedestrian passage on the sidewalk right-of-way and to insure that no damage occurs to the City's right-of-way
- 5) The owner/applicant must obtain all applicable permits and inspections and shall comply with the National Electrical Code.

The owner/applicant shall comply with the Downtown Urban Design Standards and the City Zoning Ordinance accordingly:

1. Section 3.7.4 of the USA Niagara Design Standards sets forth size/placement standards for projecting signs. The subject sign is proposed to project 71.95' (~6 feet) from the façade of the building. The maximum permitted is 5 feet (60 inches), inclusive of a minimum six inches spacing from the façade wall (the proposed sign is proposed to be spaced 25.34' from the façade). The sign should be 5 feet from the façade.
2. Both the City Zoning Ordinance and the USA Niagara Design Standards state that signs are required to be designed to complement the overall design of a façade. The subject design proposes that the top mounting bracket of the projecting sign be placed on top of one of the blue pilasters on the façade, with the other two attached to the brick fascia and brick column respectively.

Visually, this is likely to appear awkward. The design of the sign should be refined, further from proposed drawings. At a minimum, do not mount on the blue pilasters. Mounting brackets/arms shall be of a color consistent with other projections on the façade, and to the extent feasible, be positioned in such a manner to appear to "fit" into the design of the façade. (For example, as shown in the photo provided by the applicant, all of the black exterior lighting fixtures extend from the brick soldier course along the façade. This suggests one possible location for brackets.) Re-submit to the Planning Office for final location approval.

3. Section 1319.2.3 of the City Zoning Ordinance states that signs "should not detract from the use and enjoyment of proposed buildings or surrounding properties". The images suggest that the sign may include the use of "racing" lights or other similar flashing or blinking components. This should not be permitted; such a characteristic would most likely disturb hotel guests and would detract from patron use of the Conference Center banquet room (which would be directly across the street from the sign).
