Provided that the attached information meets with your office's approval, please take the necessary steps to place Rupal Hospitality Group's request before the Planning Board for consideration at its next meeting.



Thank you for consideration our encroachment request at the above referenced boutique hotel project at 200 Rainbow Blvd, Niagara Falls, NY. This Letter of Intent accompanies our site plan to further describe the nature and form of the proposed encroachment and offer supporting documentation wherein.

As our hotel renovation has progressed our concept development has evolved substantially for the restaurant and live music component of the project at 200 Rainbow Blvd. Since initially announcing the projects, we have received substantial interest from many, musicians, and stakeholders in the community very excited about the first outdoor live music/restaurant venue in Downtown Niagara Falls. Given the site's logistical constraints, expanding the patio into the right of way adjacent to the building is the best solution to accommodate these demands for restaurant patrons, live music performances, and already pre-booked private parties / special events. In doing so, we will be adding a new dynamic to Rainbow Blvd activating what was once the hotel's parking lot with performances, markets, and other desired events and activities to keep visitors coming back. Year round, we envision a lively dynamic upscale boutique hotel featuring live music, private parties, community activities and more. In the end, this project will greatly improve the lodging offerings; enhance the streetscape, and ultimately further cement Downtown Niagara Falls as a destination for our visitors and locals alike.

In addition, the hotel's primary entrance porte cochere is encroaching 15.8ft (dimensions specified in site plan) into the right away to provide adequate covering for the hotel patrons as their arriving to the facility and to also facilitate quick access to the city's parking lot of which the hotel will be using for its guests.
