AN ACT relating to authorizing the city of Niagara Falls, county of Niagara, to reduce the speed limit in downtown Niagara Falls

The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. Notwithstanding any general, special or local law or code
2 to the contrary, the city of Niagara Falls, Niagara county is hereby
3 authorized and empowered to lower the speed limit to not less than twenty-
4 five miles per hour in downtown Niagara Falls, Niagara county. For
5 the purposes of this section, the term "Downtown Niagara Falls, Niagara
6 County" shall mean the land area described as follows:
7 COMMENCING in the city of Niagara Falls, Niagara County, New York;
8 The TRUE POINT OF BEGINNING is the point of intersection of the
9 Westerly right of way of John B. Daly Boulevard and the Southerly right
10 of way of Buffalo Avenue;
11 THENCE, leaving westerly along the Southerly right of way of Buffalo
12 Avenue, proceeding until its intersection with the easterly edge of
13 Riverside Drive;
14 THENCE, leaving southerly and westerly along the boundary of Riverside
15 Drive until its intersection with the Westerly boundary of Holly Place;
16 THENCE, leaving westerly along the line of land appropriated by and
17 for the People of the State of New York in 1885, now known as Niagara
18 Falls State Park, then following said property boundary westerly and
19 northerly, proceeding until its intersection with the Northerly right of
20 way of Niagara Street;
21 THENCE, leaving easterly along the right of way of Niagara Street,
22 proceeding until its intersection with the Westerly right of way of
23 Rainbow Boulevard;

*Upon review of all the received bids, there were a number of irregularities found in the low bid from Henwood Construction Inc. Specifically their bid bond was not endorsed, their total bid price was entered in differing amounts in their proposal, and no acknowledgement was made of Addendum 1, which was a cost-adding addendum. Based on these irregularities we have rejected their bid.

Therefore, it is the recommendation of the undersigned that this project be awarded to the second low bidder Scott Lawn Yard Inc. at their total bid of \$191,515.00. Funding is available from the following sources; \$50,000.00 from tourism fund balance and \$141,515.00 from tribal revenue reserves.

Notice that bids were to be received was advertised in the Niagara Gazette and bid packages were sent to ten (10) vendors. Two (2) responses were received. One of the responses was rejected following a review of the vendor's qualifications by the Department of Public Works, which revealed that the vendor lacked the required New York State Pesticide Applicator's License. AGREEMENT FOR RETIREE DRUG SUBSIDY RE-OPENING SERVICES

THIS AGREEMENT FOR RETIREE DRUG SUBSIDY RE-OPENING SERVICES ("Agreement") is entered into by and between RDS Services, LLC, a Michigan limited liability company ("RDS") and City of Niagara Falls ("Plan Sponsor") and/or ("Plan Authorized Representative") and shall be effective as of _____, 2019 ("Effective Date").

Definitions and Contract Amendment:

The term "Plan Authorized Representative" shall mean: City of Niagara Falls

The term "Plan Sponsor" will have the same meaning as "Plan Authorized Representative" in the contract's terms and conditions.

The term "Plan Authorized Representative" will have the same meaning as "Plan Sponsor" in the contract's terms and conditions.

By substituting the "Plan Authorized Representative" for the "Plan Sponsor", the "Plan Authorized Representative" City of Niagara Falls agrees to pay the agreed upon gross remuneration of 25% of the subsidy recovery to RDS Services, LLC. All other terms of the compensation agreement with the producer will remain the same.

Terms and conditions:

Plan Sponsor, through the ("Plan Authorized Representative") maintains a group health program (hereinafter referred to as the "Plan") under which eligible individuals are able to obtain certain retiree health care benefits. Plan Sponsor desires to engage RDS to assist Plan Sponsor with certain requirements and opportunities with respect to the Re-Opening of previously closed RDS Application plan years, and RDS desires to provide such assistance, all on the terms and subject to the conditions set forth in this Agreement.

NOW THEREFORE, the parties agree as follows:

**SECTION 1
SERVICES AND RESPONSIBILITIES**

RDS Services. During the term of this Agreement, RDS shall provide to Plan Sponsor the services described on Exhibit A to this Agreement (collectively, "RDS Services"). In performance of the RDS Services, RDS shall rely on any communication and/or data reasonably believed by it to be genuine, including necessary information received from Plan Sponsor in a timely manner and in good order. For purposes hereof, "timely manner" means a reasonable period of time as may be necessary for sorting, processing, analyzing, entering and/or posting of information received.

Responsibilities of Plan Sponsor. Plan Sponsor (or its designee(s) other than RDS) shall serve as the administrator, fiduciary and primary decision maker for the Plan, with all of the rights and responsibilities for administering the Plan in connection with the Retiree Drug Subsidy Program, and RDS shall have no such authority or responsibility except as may be specifically provided in this Agreement. The People of the State of New York, represented in Senate and Assembly, do enact as follows:

1 Section 1. The real property tax law is amended by adding a new
