## Economic Development Update

### **Illinois Science + Technology Park**

In March 2005 a 24-acre Downtown Skokie parcel, formerly occupied by G.D. Searle/Pfizer, was purchased by Forest City Enterprises, a Cleveland, Ohio-based firm with previous experience developing office research parks.

Forest City named the property the Illinois Science + Technology Park (IS+TP) and demolished a majority of the site's buildings, retaining the state-of-the-art research facility previously known as Building Q and three other buildings with newer or versatile office/research space. Village staff spent over a year working with Forest City on a master plan development. The Plan Commission approved the plan after several months of consideration, and the Appearance Commission approved design guidelines.

In January 2007, the Village Board gave the plan final approval and a new zoning district was created for the campus. The new IS+TP is designed to integrate into an expanded and rejuvenated Downtown Skokie.

The master plan for the park balances taller buildings with open spaces and pedestrian ways. A zoning district provision stipulates a minimum 25%

of open space that is accessible to the public. The site plan includes a provision that limits retail uses in the ground floor of each building to 20% of the building footprint, thus creating an environment where park employees venture away from the campus for meals and services.

Currently, the campus has approximately 800 employees. Tenants include: Astellas, Evanston Northwestern Healthcare, Forest City, Midwest BioResearch, NanoBusiness Alliance, NanoInk, Nanotope, Polyera, Fisher Scientific and World Courier.

In total, the park is projected to have up to two million square feet of office and laboratory space for a total project cost of about \$500 million. The completed development should result in 3,000 to 5,000 on-site jobs. Analysts project that the IS+TP will generate \$1.8 billion annually in statewide economic activity, with park employees spending \$2 million annually in Downtown Skokie, just at lunchtime.

### **West Dempster Street Development**

The Mayor and Village Board have adopted/implemented several programs to address the

problems with the West Dempster Street Commercial District. The district is generally defined as Dempster Street from Kilpatrick Avenue on the east to Edens Expressway on the west. Problems include excess vacancies, lack of private investment/development, and building obsolescence and other aesthetic issues.

First, a transit-oriented district zoning plan was adopted. This plan allows additional height and density for properties along the corridor. The hope was that the new zoning would spur "mixed-use" development that features commercial uses on the first floor and residential on floors above. Secondly, the Skokie Swift property was completely renovated and this resulted in better transit connections, parking and the restoration and moving of the historic train station building. This structure now contains a very popular Starbucks facility. Finally, the Village undertook a \$3.5 million streetscape and landscape enhancement project. This was funded 50% by the Village and 50% by the adjacent property owners.

Typically these actions would spur the private sector to purchase the older, tired-looking properties and redevelop them

utilizing the new zoning incentives. Despite these aggressive efforts by the Village this redevelopment has not yet happened to the extent desired. A mixed-use development was built on Niles Center Road between Dempster Street and Skokie Boulevard and redevelopment is currently occurring at two properties located at Dempster Street and Lockwood Avenue and Dempster Street and Gross Point Road. There also will soon be a façade improvement at northeast Dempster Street at Bronx Avenue. While this is a good start, the Village hopes for more substantial development at several other sites along the corridor.

The Village has filed lawsuits against two properties (south-east Niles Center Road/Dempster Street and southwest Skokie Boulevard/Dempster Street) to acquire these properties, combine them and then invite redevelopment proposals. The Village has met with a number of the property owners to try to motivate them to develop their properties. The Village will continue to utilize all available economic development tools to invigorate this important commercial area.

## Community Development Block Grant Program

The Village of Skokie recently conducted three public hearings to determine its Community Development Block Grant (CDBG) projects for the 2008-09 fiscal year. The Village receives CDBG funds from the U. S. Department of Housing and Urban Development (HUD) each year to use for a variety of capital improvements, housing rehabilitation and social services that principally benefit low- and moderate-income Skokie residents.

A standard application process is conducted by the Village to annually determine the most worthy funding requests within the confines of the total grant amount. Administration expenses are also paid from the grant but are capped at 20% of the annual entitlement. General support to social services is also limited to 15% of the new grant plus any program income that has been generated throughout the year. The program is designed so that most of the funding must go toward capital improvements and rehab activities.

The Village's grant for 2008-09 will be \$489,574. The Village also has \$3,214 of program income and will reprogram

\$39,116 of grant funds that have not been spent from previously completed projects for a total 2008-09 budget of \$532,084. CDBG proposals from both Village staff and outside agencies totaled \$697,966, necessitating a reduction of \$165,882 through the public hearing process. Following are the approved activities, funding allocations and descriptions of each project:

### Administration

#### **Program Administration and Planning, \$97,870:**

Funding to administer the Village's CDBG Program, implement and monitor all projects, submit all required documentation to HUD and coordinate all planning activities relative to the Village's community development efforts.

### Public Services

#### **Disability Services, \$49,900:**

Funding to staff and administer the Disability Services Office of the Village's Human Services Division, including administration, planning, and coordination of programs related to individuals with disabilities.

#### **Maine-Niles Association of Special Recreation, \$3,000:**

M-NASR provides scholarship assistance for children and adults with developmental disabilities enabling them to participate in special recreational, social and exercise programs.

#### **Children's Advocacy Center, \$2,000:**

The Children's Advocacy Center serves child victims of abuse, and non-offending parents and siblings. Services include abuse investigation, expert child interviews, medical evaluations, court advocacy, crisis intervention, and ongoing support. The agency served 22 Skokie clients last year.

#### **Access to Care, \$7,000:**

The Access to Care Program is sponsored by the Suburban Primary Health Care Council in Westchester, Illinois. The organization served over 13,000 clients last year, of which 302 were Skokie residents and all are considered low income. Access to Care helps to provide basic medical services to uninsured low-income residents who are not eligible for Medicare or Medicaid.

#### **Center for Enriched Living, \$3,000:**

The Center for Enriched Living is a non-profit, social-enrichment and skills-development center for people with developmental disabilities.

## Downtown Skokie Swift Station

**The Village continues to work with the State of Illinois and the Chicago Transit Authority on plans to construct a new Skokie Swift station in Downtown Skokie on Oakton Street just west of Skokie Boulevard and adjacent to the IS+TP. To date, the Village has received over \$10 million in Federal funds for the project. Currently, the project is in the design engineering phase.**

Funds will be used to offset expenses of the Center's Independent Living Skills Programs providing vocational skill development, fitness and nutritional programming, social skills development, health and hygiene management, personal safety and interpersonal communication building.

### **North Shore Senior Center, \$6,000:**

Funding will assist in providing long-term case management and counseling services to Skokie's homebound, low-income elderly and their families. Services include formal assessments, counseling services, case management, and follow-up home visits. The majority of clients also have multiple medical problems which affect daily functioning.

### **The Harbour, Inc., \$3,000:**

The Harbour, Inc. is a Park Ridge-based agency serving the needs of runaway, neglected and homeless girls and young women ages 12-21. The agency's Transitional Living Program (TLP) serves 16 to 21 year-old homeless girls in the north and northwest suburbs by providing supervised living while they complete high school and work part-time, and make the transition to self-sufficiency. The program served 41 girls last year, including two from Skokie who received 410 nights of TLP care.

## Capital Improvements and Rehab

### **Multi-Family Area Sidewalk Replacement, \$199,314:**

This funding will enable the Public Works Department to do extensive sidewalk replacement in all CDBG-eligible multi-family residential areas in Skokie. A small amount of curb and gutter replacement also will be performed in conjunction with this activity. Public Works plans to replace all defective sidewalks in the multi-family areas in 2008.

### **Sidewalk Grant Program, \$5,000:**

This program provides for grants to homeowners meeting low/moderate income eligibility who are required to participate in the Village's mandatory 50/50 sidewalk replacement program. As the Village implements its Mandatory Sidewalk Replacement Program, low/moderate income property owners are able to apply on an individual basis for CDBG funds to cover their 50% share. The area of concentration for this program in 2008-2009 will be from Oakton Street north to the corporate limits.

### **Housing Repair Program, \$80,000:**

Funding will enable the Village to continue the program of repairing single-family homes owned and occupied by low/moderate income residents. This program began in 1983 and has operated continuously ever since. Low-income households (less than

50% of area median family income) are eligible to receive grants up to \$8,000 to pay for building materials or contractors' services, and moderate-income households (50 to 80% of median family income) can receive loans from local banks with the entire interest charges being subsidized through the program. The program generally serves about 15 to 25 households per year.

### **Council for Jewish Elderly, \$20,000:**

This project will involve the replacement of kitchen equipment at the Lieberman Geriatric Health Center at 9700 Gross Point Road. Lieberman is a 240-bed skilled nursing facility that served 354 frail, elderly residents in 2007, all considered to be low-income. The center provides skilled nursing care, Alzheimer's care, short-term rehabilitation and hospice/end-of-life care.

### **SHORE Community Services, \$15,000:**

The recommended funding will assist SHORE in remodeling a kitchen in a group home, housing four men with severe developmental disabilities.

### **Orchard Village, \$15,000:**

Funds will be used to replace the deteriorated flooring and renovate the kitchen at Orchard Village's Seniors Group Home housing eight people with developmental disabilities.

### **Search Developmental Center, \$12,000:**

Search Developmental Center will replace the roof, soffits, gutters and downspouts at a group home housing four developmentally disabled women.

### **Metropolitan Family Services, \$4,000:**

Metropolitan Family Services provides counseling and a variety of social services to primarily low- and moderate-income clients. Funds will be used to replace the building's deteriorated air conditioning unit.

### **Housing Opportunity Development Corporation \$10,000:**

The funding will assist HODC with most of the cost of resurfacing the driveway and parking lot and replacing some broken windows at an apartment building in Skokie. All of the apartment units are rented at below-market rates exclusively to low-income residents.

## Harvest Water With Rain Barrels

Besides helping the environment, an obvious reason for harvesting rainwater is to save money. A rain barrel collects and stores rainwater from your rooftop which you later can use in many ways. For example, rainwater is naturally soft and devoid of minerals, chlorine, fluoride and other chemicals. It is the perfect source for watering your garden or maintaining your landscaping.

Additionally, rain barrels help slow down rain runoff so it can drain naturally into the ground. That helps keep excess water out of the sewer systems and keeps rain runoff from collecting pollutants on its trip to nearby waterways. Rain barrels also provide water during dry weather when you can set them to slowly release water over a period of time after rains have subsided. The slow release of water will allow it to seep into the soil and be used by plants. Be sure to check your barrel at least once a week to be sure that all openings are screened to prevent mosquito breeding.

Rain barrel programs are being implemented in communities across the country, including here in Cook County. The Metropolitan Water Reclamation District of Greater Chicago (MWRD) is selling rain barrels for Cook County residents. Rain barrels are \$40 each and can be ordered and paid for on the MWRD website, [www.mwrld.org](http://www.mwrld.org). There are three pickup locations, one of which is in Skokie. ## Recent Village Board Action

The Village Board approved a new Administrative Hearing for parking tickets. Since 1998 the Village has operated an Administrative Adjudication Program for Community Development and Health Code violations. Many surrounding communities, including Evanston and Niles, process parking tickets through Administrative Adjudication. The goal of moving parking tickets to an Administrative Hearing is to increase compliance with parking regulations and streamline the process. The new Administrative Hearing for parking tickets program will be implemented beginning May 1, 2008.

The Board approved water system funding improvements in the Williamsburg Subdivision. These improvements are part of the Fiscal Year 2008 Capital Improvement Plan.

The Board approved three resolutions and three ordinances as they relate to the Illinois Department of Transportation (IDOT) Emerson Street Bridge over North Shore Channel Improvement Project. Along with the replacement of the bridge, the roadway will be widened and resurfaced. Traffic signals also will be modernized and construction of curb and gutter and relocation of storm sewers, drainage structures will be provided. The three resolutions are: a resolution approving an agreement between the Village and the IDOT; an Motor Fuel Tax resolution in the amount of \$30,000; and a resolution for the appropriation of funds. The three ordinances approved are: a Village ordinance providing for restrictive parking along Golf Road and McCormick Boulevard within the project limits; a Village ordinance prohibiting sanitary and industrial waste discharge into any storm water structure; and a Village ordinance pertaining to encroachments within the State of Illinois right-of-way.

## Skokie Hosts Compact Fluorescent Lightbulb Recycling Program

Did you know that Compact Fluorescent Lightbulbs (CFL) produce the same amount of light as regular lightbulbs, but use 2/3 less energy and can last 10 times longer? To be an efficient light source CFLs contain a small amount of mercury sealed within the glass tubing and should not be disposed in the garbage.

In February the Village of Skokie began a recycling program to help residents properly dispose of spent CFLs. Sponsored by the Solid Waste

Agency of Northern Cook County (SWANCC), the program is for residentially generated, spent CFLs. Please note that for safety reasons, four-foot bulbs will not be accepted. To learn how to dispose of larger-sized bulbs please visit the SWANCC website at [www.swancc.org](http://www.swancc.org).

Residents may bring spent CFLs, contained in zip-lock-type baggies for extra protec-

tion, to the Skokie Health Department located on the lower level of Village Hall, 5127 Oakton Street, between the hours of 8:30 a.m. and 5 p.m., Monday through Friday.

## What You Should Know About E. Coli

Food borne outbreaks caused by Escherichia coli (E. coli) O157:H7 are becoming a more common occurrence in this country. The Skokie Health Department provides the following information so you can be better informed about this potentially dangerous bacteria.

### What is E. coli?

E. coli is an emerging cause of food borne illness. While most strains are harmless and live in the intestines of healthy humans and animals, the E. coli O157:H7 strain produces a powerful toxin that can cause severe illness. The combination of letters and numbers in O157:H7 refers to specific markers found on the bacterium's surface that distinguish it from other E. coli, which have other O and H markers.

### How is E. coli spread?

Most E. coli infections come from undercooked ground beef. The infection also can result from drinking raw unpasteurized milk or drinking or swimming in sewage-contaminated water. The bacterium is present in the stools of infected persons, and it can be passed from one person to another if hygiene and hand washing habits are inadequate.

### How does food become contaminated?

The organism can be found on a small number of cattle farms, where it can live in the intestines of healthy cattle. When the

animal is slaughtered, the meat may be contaminated by intestinal contents. When this meat is ground, fecal organisms that were on the outside of the meat are then thoroughly mixed throughout the ground beef. These bacteria can survive unless the meat is thoroughly cooked.

### How common is the infection?

One laboratory that regularly tests for E. coli O157:H7 suggests that annually an estimated 20,000 cases may occur in the United States. The infection is being increasingly recognized in Canada, Europe, South Africa, the southern regions of South America, Australia and Japan. In Illinois, 100 to 200 cases of E. coli O157:H7 are reported each year.

### What sort of illness does it cause and how is it treated?

Persons infected with the bacterium often develop severe diarrhea and painful abdominal cramps, although some people show few or no symptoms. The diarrhea can be very bloody. Because there is usually little or no fever, a person may think some other condition is causing the bowel to bleed, and this infection may go unrecognized. Most persons recover without antibiotics or other specific treatment in five to 10 days. Antidiarrheal agents should be avoided. In some persons, particularly children younger

than 5 years of age and the elderly, the infection can lead to destruction of red blood cells (hemolytic anemia) and acute kidney failure (also known as uremia). These complications can lead to stroke, seizures and death.

### Are there any long-term consequences?

Persons with diarrhea alone usually recover completely, although it may be several months before bowel habits are entirely normal.

Among those who develop complications, about 8 % have a poor outcome, such as chronic kidney failure, high blood pressure, stroke, paralysis, bowel resection, blindness or seizures. A decline in kidney function may appear years later in about one-third of

those persons who have had complications. Thus, this infection may be a preventable cause of chronic kidney failure.

### What can you do to prevent this illness?

One of the most important ways to reduce your risk for E. coli is proper handwashing. Additionally raw unpasteurized milk can transmit many diseases, including E. coli. Consume only pasteurized milk and pasteurized milk products. Since hamburger and ground beef may be contaminated with this bacterium, thorough cooking is essential to prevent illness. These discounted prices appear below.*

Cholesterol screening is being offered for \$2.50 on a walk-in basis on Monday, April 7 from 9 a.m.-1 p.m.; Wednesday, April 9 from 5-8 p.m.; and Thursday, April 10 from 1-4 p.m. The Lipid Profile test is being offered for \$6 by appointment only on Monday, April 7 and Wednesday, April 9 from 5-8 p.m., and Thursday, April 10 from 9 a.m.-12 p.m. Body Composition Analysis is being offered for \$2 by appointment only on Monday, April 7 from 2-4:30 p.m.; Wednesday, April 9 from 5-8 p.m.; and Thursday, April 10 from 9 a.m.-12 p.m.

## Village Clerk Offers Regional Transportation Authority Photo Identification Cards

The Regional Transit Authority (RTA) recently announced that beginning Monday, March 17, 2008 senior citizens ages 65 years and older can ride buses and trains for no charge as long as they have a valid photo identification card issued by the RTA.

Seniors ages 65 years and older, both Skokie residents and non-Skokie residents, can obtain an RTA photo identification card from the Skokie Village Clerk's Office, located at Skokie Village Hall, 5127 Oakton Street, from 8:30 a.m. to 5 p.m. Monday through Friday. The photo costs \$1 and the service is open to all individuals ages 65 years or older. After the application is filed by the Clerk's Office the Fare Card will be mailed directly to the address provided by the applicant within about three to four weeks.

Seniors who currently have a valid Reduced Fare Card need not apply for a new card. The Reduced Fare Card automatically became a "free" card on March 17, 2008.

The RTA free ride program coverage area includes McHenry, Lake, Kane, Cook, DuPage and Will Counties.

### State Treasurer's Office Offers Green Rewards Rebate Program

Did you know that the Illinois State Treasurer's Office offers a Green Rewards hybrid vehicle rebate program? Consumers who buy a hybrid, all-electric, or fuel cell vehicle (others may become eligible) and finance their car loan through a participating financial institution\* will receive a \$1,000 rebate per car.

#### How the Program Works

When a consumer finances their car loan through a participating financial institution, the Treasurer's Office will deposit \$25,000 with the financial institution. The Treasurer's Office will accept 4% less in interest earnings in exchange for the financial institution passing on that \$1,000 savings to the consumer in the form of a rebate. The hope is that by adding this incentive, people will be more likely to consider purchasing a hybrid or other eligible vehicle. There is no income limit nor any purchase price restrictions. Purchasers are eligible for a \$1,000 per vehicle and up to \$50 million in deposits will be made available for this program, or a total of 2,000 rebates.
