2010 Crime Statistics Show Decrease in Total Offenses

In its recently released 2010 Annual Report, the Skokie Police Department reported that overall offenses declined by one percent during the year, marking the third consecutive year showing a decrease in offenses.

Of particular note were declines in the number of homicides, with none in 2010; burglary and theft, both with 4% decreases; burglary

and theft to motor vehicles, with a 20% decline and a 9% reduction in criminal damage. During 2010, the total number of burglaries reported in the community declined by 16 incidents. This marks the fourth consecutive year with a decline in burglaries.

“While overall offenses, including burglaries, were reduced in

2010, the Police Department service calls rose by one percent, maintaining demand levels 12% higher than the 10-year average,” explained Village Manager Albert J. Rigoni. “The Village consistently encourages residents to call the Police Department whenever even the slightest thing looks or sounds unusual, and residents are, increasingly, being proactive in reporting suspicious activity to the Police. This cooperation and vigilance helps the Police Department maintain a safe community.”

In January, 2010, residential burglaries spiked, which is uncharacteristic for winter months. In response, Skokie Police Department investigators and members of its Tactical Mission Team worked to identify patterns, trends and suspects. This led to the arrests of

23 suspects believed to be responsible for 30 burglaries, and recovery of proceeds from numerous burglaries in Skokie and other area towns.

Drug-related offenses rose by 24 incidents, to a total 295 offenses for 2010, continuing the upward trend in these types of offenses that began in 2000. The increase coincides directly with establishment of the Department’s Tactical Mission Team to focus on crime trends (such as the January 2010 residential burglary spike detailed above), gang activity and narcotics/drug-related offenses. The Tactical Mission Team investigates suspected drug-related crimes and the individuals and groups involved, and the upward trend in arrests correlates directly to the Team’s interdiction with

A wrap-up thank you coffee for all hosts will be held at the new Skokie Police Headquarters during July 2011.

All KYN hosts will receive a host ‘kit’ that includes invitations, maps of Skokie and the world, name tags, conversation starters and a coupon redeemable for a free coffee cake (Kosher or traditional) to serve at their coffee. The Village held KYN programs in October 2008 and May 2010, and over 100 resident hosts opened their homes to thousands of their Skokie neighbors and friends.

What is the Village Doing to Attract Businesses?

Economic Development Update

The Village of Skokie is actively engaged in recruiting new businesses for both Downtown Skokie and West Dempster Street. Staff in the Economic Development Division, Community Development Department, Village Manager’s Office and other departments and divisions continue to work with existing property owners and businesses regarding the appearance and functionality of both unoccupied and occupied commercial sites.

Since the beginning of 2010, the Village has supplied Downtown property owners and real estate brokers with updated marketing and demographic materials for use in attracting new tenants or buyers for their properties. Fifteen storefronts

along Oakton Street and Lincoln Avenue experiencing lengthy vacancies have been transformed into Downtown marketing opportunities via bright, new window coverings with leasing information and the new Downtown Skokie logo. Village staff is working with vacant property owners regarding their leasing and marketing efforts and, in many instances, has advised property owners of additional marketing opportunities.

In summer and fall 2010, Village staff contacted over 500 local, regional and national retailers and brokers promoting the Downtown Skokie and West Dempster Street areas. This outreach resulted in meetings or additional contact with over 45 potential new restaurant/retail users, many of who are considering a Skokie location.

Downtown Skokie

New businesses that have opened in Downtown Skokie include Sanford Brown College, Kabul House, Eclissi Italian Restaurant, Skokie Club, Drive Cleaning, Bob's Magazine Museum, NY Nails & Spa, New Nails & Hair Obsession and CuraLink. A new restaurant, Libertad, featuring 'global dining with a Latin twist', is scheduled to open soon on Lincoln Avenue. Several new tenants moved into the Illinois Science + Tech Park in 2010, including AAP Pharmaceuticals, LLC. The tech park now contains 18 companies employing approximately 1,200 people.

Ongoing communications with Downtown Skokie property owners and businesses regarding available financial incentives for Downtown re-

tail and restaurant uses have recently produced the following rehabilitation projects: Ace Hardware, Skokie Paint and Wallpaper, Kabul House, Sweetie Pies and 4837-4845 Oakton (Drive Cleaning building). Significant improvements also are planned for the former Desiree Restaurant building on the northwest corner of Oakton Street and Lincoln Avenue. Village staff has also launched a "visual merchandising" program to assist existing Downtown Skokie businesses with updating their window displays. As a result, a number of retail and restaurant establishments will soon feature fresh, updated window treatments and displays.

In fall 2010, the Village launched a Downtown Skokie website, www.skokiedowntown.org, that contains resources for residents, businesses and prospective new companies interested in visiting, expanding or locating in Downtown Skokie.

West Dempster Street

The Village received numerous inquiries from developers and retailer/restaurant representatives regarding West Dempster Street following the major outreach effort during the second half of 2010. A Tax Increment Financing (TIF) District was established in late 2010 for the area bounded by Gross Point Road on the west and Kilpatrick Avenue on the east, encompassing the majority of commercial properties along West Dempster Street. Three

primary site acquisitions have been completed by the Village at 4811, 4904 and 4945 Dempster Street, and structures on those parcels have been cleared to prepare the area for new development.

In addition to extensive direct mail marketing, the Village sent email contacts to executives at over 200 companies attending the October 2010 International Council of Shopping Centers Dealmaking event at which the Village had a booth. A number of developers have contacted the Village with preliminary proposals for all three Village-owned sites along West Dempster Street, and inquiries continue regarding several other potential West Dempster Street redevelopment sites. Certain elements of the Downtown Skokie TIF-funded facade renovation program are being considered to assist existing property owners and businesses on West Dempster Street. The Village also is in the process of retaining a consultant team to address circulation, parking, land use and zoning, site development and design issues along West Dempster with recommendations anticipated for summer 2011.

Medical Reserve Corps

The Health Department is developing a Skokie Medical Reserve Corps of volunteer health professionals to enhance emergency preparedness and response capabilities. This unit will have periodic training sessions, and be able to assist the Village during a local disaster by volunteering in mass community clinics to dispense medications or vaccinations, providing support for emergency shelters or other major public health needs.

The Skokie Medical Reserve Corps activities would include participation in annual seasonal flu vaccination clinics as well as in local and regional drills and exercises. The Unit is recruiting licensed health and medical personnel at this time. The first training program is scheduled to begin in May.

How many years have you been Chair of the Human Relations Commission?

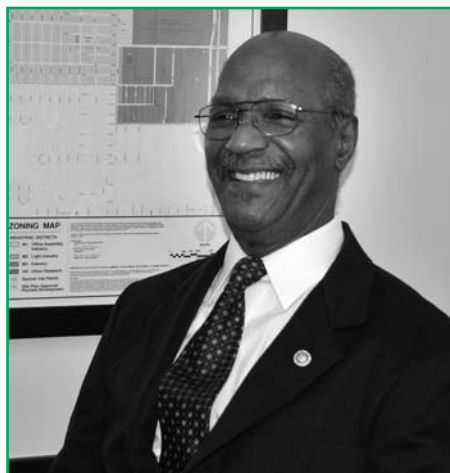
I became Chair of the Human Relations Commission in 2006.

Village Board Action


The Village Board voted to reconsider Plan Commission Case 2010-31P regarding Walgreens relocation to Dempster Street and Crawford Avenue. The case will go back to the Plan Commission for review and approval.

The Village Board invited comments from the public on potential uses for the former Skokie Police Station at 8350 Laramie Avenue.

The Village Board approved Plan Commission case 2010-36P and 2010-37P regarding a subdivision and a Zoning Map Amendment at 9300 through 9350 Weber Park Place. The Park District plans on expanding the parking lot at the Weber Leisure Center to incorporate an extra 32 spots.

The Village Board approved the adoption of the 2009 International Property Maintenance Code (most current). The new code deals strictly with the maintenance of existing buildings, structures and properties. 

2011 Yard Waste Collection Quick Facts

- Brush and other yard debris will be collected on Wednesday of each week **by request only** from April 6 through November 2, 2011.
- To schedule a collection of brush or other yard debris, residents must call 847/933-3333 by noon on Monday to request collection for the coming Wednesday. This is an automated system and messages can be left during daytime, weekend and evening hours. Residents also can request collection at www.skokie.org.
- Grass clippings are no longer collected. Skokie residents are asked to mulch their grass clippings by letting them lay on the lawn after weekly mowing. Residents who wish to bag their grass clippings will need to contact a private landscaper for disposal options.
- Other yard debris eligible for collection includes bush trimmings, thatch from raking (in spring only) and old flower or vegetable plants. Leaves remaining from fall 2010 also will be collected in spring only. Other yard debris must be placed in a 30-gallon kraft paper bag for collection.
- Residents who do not request collection will not receive service.
- Brush should be bundled with string, rope or twine, with branches not exceeding 5 feet in length and 3 inches in diameter.
- The fall leaf collection program begins in mid-October and continues through early December, weather permitting.

drug-related crimes. The trend also reflects the Department's continued emphasis on youth activities in and around parks and an increasing community awareness of the dangers of drugs and drug-related activities.

The number of robberies reported in 2010 increased by five incidents from 2009. This increase is attributable to an increase in both strong-armed and aggravated robberies in which no weapon is used. By contrast, armed robberies fell by 19 incidents in 2010, which is a 50% decrease from 2009. This statistic places 2010 armed robbery incidences at 21% lower than the ten-year average.

The Skokie Police Department received reaccreditation from the Commission on Accreditation for Law Enforcement Agencies (CALEA) in 2010, and was recognized as a Flagship Agency. This distinction recognizes not only the quality of the CALEA on-site assessments, but the high level of professionalism exhibited by the Skokie Police Department and its staff.

The Police Department's Neighborhood Watch program continued positive growth in 2010 with the enrollment of 18 new active blocks. Now in its 28th year, the program updates citizens on crime trends, provides crime prevention tips and encourages neighbors to look out for the safety of each other's homes and their neighborhood. A total of 181 blocks, representing approximately 4,100 households, participate in the Neighborhood Watch program.

In summer 2010, the Police Department launched the Nixle web-based community messaging system. The Department now sends important community updates and messages via email and/or text to those registered for the service. Nixle supplements the Community Messaging system featured on the Police Department page of the Village web site, www.skokie.org, on which crime alerts are posted for specific areas of the community.

Community Development Block Grant Program

The Village of Skokie recently conducted three public hearings to determine its Community Development Block Grant (CDBG) projects for the 2011-2012 fiscal year. The Village receives CDBG funds from the U.S. Department of Housing and Urban Development each year to use for a variety of capital improvements, housing rehabilitation and social services that principally benefit low- and moderate-income Skokie residents.

An open, competitive application process is conducted by the Village annually to determine the most worthy funding requests. Administration expenses also are paid from the grant, but are capped at 20% of the annual entitlement. General support to social services is limited to 15% of the new grant plus any program income that has been generated throughout the year. The CDBG program is designed to primarily fund capital improvements and rehabilitation activities.

The estimated grant for 2011-2012 is \$550,000. The Village will also re-program \$29,430 of grant funds that have not been spent from previously completed projects, and \$14,707 in program income from homes sold in the past year that were improved through the Village's Home Improvement Program, for a total 2011-2012 budget of \$594,137. The total CDBG public service proposals exceeded 15% of the new grant and program income amount, necessitating a \$23,894 reduction during the public hearing process.

Following are the approved activities, funding allocations, and descriptions of each project:

Program Administration and Planning - \$110,000

Funding to administer the Village's CDBG Program and coordinate all planning activities relative to the Village's community development efforts.

Home Improvements Program - \$135,000

Funding to continue the Village's program of repairing single-family homes. This program began in 1983. Low/moderate-income households are eligible to receive grants and loans up to \$8,000 to pay for building materials or contractors' services.

Street and Alley Resurfacing - \$175,000

Funding to resurface three street sections and one or two alley sections in the low/moderate-income multi-family residential area immediately south of Downtown.

Sidewalk Grant Program - \$4,000

Funding to provide grants to homeowners who are required to participate in the Village's mandatory 50/50 sidewalk replacement program, and meet the low/moderate income eligibility requirements.

CJE SeniorLife - \$13,087

Funding to assist with the refurbishment of the walk-in produce cooler at the Lieberman Center for Health and Rehabilitation at 9700 Gross Point Road.

SHORE Community Services, Inc. - \$12,000

Funding to assist with the replacement of unsafe kitchen and dining room floors, windows and exterior doors; and bathroom upgrades at a group home for six women with developmental disabilities at 8900 Central Park Avenue.

Search, Inc. - \$24,750

Funding to assist with the replacement of windows and doors at a group home for eight men with developmental disabilities at 8556 Central Park Avenue.

Niles Township Food Pantry - \$5,300

Funding to assist with the purchase and installation of a back-up generator for the Food Pantry refrigeration units in the Township Annex building at 5255 Main Street.

Orchard Village - \$23,000

Household Alkaline Batteries – AA, AAA, C, D and 9V. No special preparation is needed for these batteries prior to bringing them for recycling.

Rechargeable Batteries – NiCad, NiMh, lithium ion and lithium polymer. All rechargeable batteries must have their contact points covered with masking tape or be placed in an individual self-locking plastic bag prior to bringing them for recycling to prevent contact with other batteries which can cause a fire hazard.

Batteries can be brought to the Skokie Health Department, 5127 Oakton Street for recycling any time Monday through Friday between the hours of 8:30 a.m. and 5 p.m.
