Skokie Police Department Strives for Green

The new Skokie Police Department Headquarters was designed and built to be a truly special facility, both for its employees and the community they are dedicated to protect and serve. Through its spacious and generously landscaped front plaza, brightly sunlit lobby and approachable information desk, the facility more than meets its goal to remain warm and welcoming to the public. With a state-of-the-art Communications Center, modern firing range and well-equipped work areas, the building similarly exceeded the objective of being operationally efficient and functional for employees. But the Village and the Police Department wanted more from the building than that: they wanted to shoot for “green.”

Consistent with the Village’s commitment to energy efficiency and the preservation of the earth’s natural resources, the Police Headquarters was designed to achieve LEED certification as a “green” building, as defined by the U.S. Green Building Council. Every key construction and design question was judged against this lofty benchmark, from the decision to preserve and re-use the structural elements of the pre-existing building to the integration of a cistern-based rainwater reclamation and irrigation system. The environmentally friendly building was constructed with recycled-content and regionally sourced materials, landscaped with water-efficient plantings and designed to integrate natural daylight with energy-efficient light fixtures and occupancy sensors throughout the 80,000-square-foot building. From the reflective roof to the under-floor air distribution system and the insulated, low-E glass in between, the Skokie Police headquarters was built from top to bottom to be “green.”

As a direct result of the remarkable energy savings and resource preservation realized through the building’s design and construction, the Department also was able to secure another type of “green” in the form of grant funding. The Police Department aggressively pursued and received a number of grants from local, State and federal sources, including the Illinois Clean Energy Community Foundation which generously provided the Village with a substantial grant award. The Police Department also applied for and received Electric Efficiency and Thermal Energy Efficiency grant funds through the Illinois Department of Commerce and Economic Opportunity. The result of these collective efforts resulted in a total of almost \$230,000 in energy-related grant funding alone.

Oakton Street “Road Diet” Summary

At the October 17, 2011, the Village Board meeting, the Village board voted unanimously not to implement a “Road Diet” on Oakton Street. A test of the “Road Diet” took place during May and June, 2011 to gauge traffic patterns both on Oakton Street and surrounding roadways. While the test was successful, both in terms of diverting both truck and car traffic from Oakton Street, and slowing traffic that remained, the Village Board determined that the community, as a whole, did not favor the project and questioned the economic development benefits that might result from implementation.

The public comments received during the project clearly demonstrated a community wide goal and desire of a revitalized, vibrant Downtown area. Although the road narrowing project will not move forward, the Village Board requested that staff present plans for significant roadway improvements,

Alternate-Side Parking Program

The Village of Skokie would like to remind residents, business owners and visitors about the Village's Alternate-Side Parking Program. When there is snow accumulation of two inches or more on the pavement, the Village's Alternate-Side Parking Program goes into effect



from 8 a.m. to 6 p.m., seven days a week. The snow removal program is a minimum two-day operation. On even-numbered days of the month, after a snowfall of two inches or more, all vehicles must be moved to the side of the street with even-numbered addresses. On odd-numbered days of the month, after a two inch or more snowfall, all vehicles must be moved to the side of the street with odd-numbered addresses.

There are numerous ways to learn if Alternate-Side Parking is in effect:

- **Call the Village's 24-hour Snow Hotline at 847/675-7669;**
- **Listen to 1660 AM Skokie Radio;**
- **Visit www.skokie.org and look for a notice near the top of the home page;**
- **Tune to SkokieVision cable and look for the crawl message at the bottom of the screen (Channel 25 on RCN systems, Channel 17 on Comcast systems); or**
- **Listen for the emergency siren that sounds at 7 a.m. to signal that the program is in effect from 8 a.m. to 6 p.m. that day.**
- **Sign up for SkokieNews to receive email notification on the first day Alternate-Side Parking is in effect.**

In addition to the emergency siren sounding at 7 a.m. to signal that Alternate-Side Parking is in effect from 8 a.m. to 6 p.m. that day, the siren sounds again at 6 p.m. to signal that the program has ended for the day. Please note that the Village no longer activates the emergency cable interruption to announce the start of Alternate-Side Parking (see article below).

The Village does have certain streets that are exempt from the Alternate-Side Parking Program but only on Saturday, Sunday and some holidays. There also are streets in Skokie that are under the jurisdiction of the Illinois Department of Transportation or Cook County.

The Village plows its entire network of sidewalks when snow accumulations exceed four inches. After streets are cleared of snow, special, smaller plows are dispatched to clear sidewalks. Alleys are plowed after a 6" or greater snowfall. This operation is predicated upon that all other operational aspects of snow removal have been completed and personnel and equipment are available.

The *TeenLink* program list provides contact information for Skokie teens available to do seasonal yard work. The list includes the name and address of the teen, days available, type of work they are willing to do and their expected rate of pay. Residents can receive the list by mail or email.

The resident is responsible for contacting the teen and for making financial and scheduling arrangements.

Village Stops Cable Programming Interruptions to Announce Alternate-Side Parking

Beginning with the 2011/2012 winter season, the Village will no longer activate emergency cable programming interruptions to announce the start of Alternate-Side Parking.

In prior years, this approximately 30-second interruption was instituted several times each morning, and again in the evening to announce an 'all clear'. Last year, a cable system modification made it impossible to confine the interruption to just Skokie cable viewers, and cable service was interrupted in

homes throughout the region by Skokie's announcements. As there are so many other methods available to Skokie residents and businesses to learn if alternate-side parking is in effect (see article above) the Village will no longer activate the emergency cable programming interruption to announce the program start or conclusion. Please note that a crawl announcement on alternate-side parking will appear at the bottom of the screen on Channel 25 on RCN systems and Channel 17 on Comcast systems. ∞

Not content to stop there, Police Department staff spearheaded lengthy and complex efforts to secure additional grant funding with which to construct and equip what has become among the finest law enforcement facilities in the State. These dedicated efforts met with truly remarkable results. For example, with only \$12 million competitively allocated nationwide, the Police Department was able to secure a \$1,000,000 grant award from the U.S. Department of Homeland security for the construction of a state-of-the-art Emergency Operations Center. Similarly, the dispatch capabilities of the Communications Center are being modernized through a \$465,000 Department of Justice COPS Technology grant, and the acquisition of a virtual firearms training system was achieved with other federal grant funds. Together with the energy-related grants received, the Police Department's pursuit of "green" was right on the mark, resulting in over \$1.9 million dollars awarded toward the creation of Skokie's operationally effective and energy-efficient law enforcement facility.

Village Board Action

The Village Board recently approved a contract with sculptor Evan Lewis to create a kinetic sculpture for the CTA Yellow Line Oakton Street Station in Downtown Skokie. Evan Lewis is an accomplished artist who has created outdoor kinetic sculptures throughout the United States since 1984.

The Village Board approved a contract with A Lamp Concrete Contractors for the construction of a one-mile, multi-use path along the former Union Pacific Right-of-Away from Oakton Street to Dempster Street. A \$200,000 federal grant has been secured to help pay for a portion of this project. The remaining funding will be provided from the TIF fund.

The Village Board recently approved a contract with North American Salt Co. for the purchase of 4,400 tons of bulk rock salt at \$63.05/ton for total price of \$277,420. The price of bulk rock salt was \$68.54/ton in 2009 and \$62.31/ton in 2010.


The Village Board approved a contract with Baxter Woodman, Inc. for the design and construction engineering services of a streetscape improvement project along Oakton Street from Skokie Boulevard to Lowell Avenue. The improvements include decorative roadway and pedestrian lights, new sidewalk and brick pavers, landscaping and benches. The Village received \$992,280 in federal transportation enhancement funds toward the project. The remaining costs will be paid through the TIF fund. 

Did You Know?

The Skokie Police Department wants to remind residents of common traffic laws that are sometimes forgotten. These lesser-known laws often have a huge effect on whether or not crashes occur.

- You must drive with your head lights on at all times when rain, snow, fog or other atmospheric conditions require the use of windshield wipers in addition to the period from sunset to sunrise.
- No person may turn any vehicle without giving an appropriate signal. A signal of intention to turn right or left must be given continuously at least last 100 feet before turning within a business or residential district.
- When two vehicles approach or enter an intersection from different roadways at approximately the same time, the driver of the vehicle on the left must yield the right-of-way to the vehicle on the right.
- Under a new Illinois law drivers must come to a complete stop for pedestrians in any crosswalk that is marked, unmarked, signaled and un signaled.
- It is also unlawful to use a wireless telephone at any time while operating a motor vehicle on a roadway in a school zone or on a highway in a construction zone.

Village of Skokie Fine Arts Commission Grants

The Village of Skokie Fine Arts Commission offers grants to Skokie schools that promote arts and cultural diversity in the community.

The Cultural Arts Grants are available to Skokie schools for in-school performing arts programming, and Project Grants are available to Skokie arts organizations.

Skokie public and private schools that host professional visiting artists are eligible to apply for a Cultural Arts Grant. Programs should have an emphasis on fine arts, music and dance while also promoting cultural diversity. The maximum grant amount is \$500. In 2011, over \$3,500 was awarded to Skokie schools for various projects, author visits and educational performances.

Project Grants are available to organizations for visual, audio and creative projects. These competitive grants provide larger funding amounts and Skokie not-for-profit arts organizations and institutions are encouraged to apply.

The Commission is transitioning to a calendar year and as such, projects taking place between May 1, 2011 and December 31, 2012 are eligible to apply. The Fine Arts Commission offers a grants workshop on Wednesday, January 11, 2012 at 7:30 p.m. at Village Hall, 5127 Oakton Street.

The deadline for both grants is Monday, April 2, 2012.

Winter Time in Skokie

There has rarely been a winter in our area without two or more severe storms. The Village of Skokie would like to help you become more prepared with the following information.

Prepare Your House for Cold Weather

Use the following suggestions to prevent pipes from freezing or ice dams from occurring in severely cold weather.

Frozen Pipes

Frozen pipes usually occur for one of three reasons: when cold outside air leaks into the house and freezes the water in pipes, when a homeowner lowers the thermostat in their house to 55 degrees or less when they are out of the house or when the pipes in crawl spaces or attics are not properly insulated.

When a pipe is frozen only a trickle of water comes out when the faucet is turned on. If you choose to thaw the pipe yourself do not use a blowtorch, kerosene or propane heater or any open flame device. It is advised that you have a licensed plumber assist if you cannot immediately locate the frozen pipe or cannot make the necessary repair.



Ice Dams

Ice dams are the result of melting water and ice entering attics via the roof shingles. Dams primarily occur after a cycle of melting-freezing days. Water from ice dams may damage ceilings, walls, floors and household items. To reduce the chances that an ice dam will form be sure to clean out all gutters and downspouts, replacing or repairing those which are damaged, and do not allow ice or icicles to accumulate in or around gutters.

Is Your Car Ready for Winter?

Reliable transportation is especially important during the winter. If you have a vehicle, make sure it is ready for whatever winter weather may bring.

Not only should your vehicle be kept in top operating condition all year round for safety and fuel economy, it is especially important to get it winterized to avoid any unpleasant or dangerous situations while traveling in inclement weather.

Items to check include the ignition system, fuel system, brakes, exhaust system, wiper blades, snow tires, tire tread, defroster, proper grade oil, cooling system, battery, lights and antifreeze. ∞



Winter Emergency Kit

Be prepared for weather-related emergencies by having an emergency kit in both your auto and home. At a minimum the kit should include the following:

- Non-perishable food and bottles of water
- Flashlight with spare batteries
- Portable battery-operated radio with spare batteries
- Warm clothing and a blanket
- First aid kit
- Spare cell phone battery

- Small tool kit, flares for an auto
- Phone numbers of relatives, physicians, etc.
- Copy of prescriptions and an emergency supply of medication taken on a daily basis
- Extra credit cards or travelers checks
- Writing materials
- Extra car keys

Food Pantry Donations Needed

Due to increased demand from area residents in need and federal government cutbacks, the Niles Township Food Pantry has much less food to distribute to the over 3,000 individuals who use the pantry each month.

To assist the Niles Township Food Pantry the Village of Skokie has an ongoing non-perishable food drive.

A large food collection box is located at the main entrance of Village Hall, 5127 Oakton Street. Please consider donating non-perishable goods while purchasing a vehicle sticker, dropping of a permit application or doing other business at Village Hall.

Acceptable items include:

- Boxed cereals
- Canned vegetables and fruits
- Canned stews, soups, pork and beans
- Canned meats (tuna, chicken, etc.)
- Boxed juices and milk
- Pasta, rice, etc.
- Peanut butter and jelly (plastic jars only)
- Pudding cups
- Fruit cups, fruit bars, raisins, etc.
- Crackers

Glass jars and perishables items are not accepted.

License Plate Covers

License plate covers, whether tinted, colored, painted, marked, clear or illuminated are illegal in the State of Illinois. Drivers using license plates covers may be ticketed. This type of ticket is considered a non-moving violation. ∞

Household Hazardous Waste Disposal

The Illinois Environmental Protection Agency offers a household hazardous chemicals disposal facility at Goose Island, 1150 North Branch Street in Chicago. For more information or for drop-off times, please call 312/744-7606.

The Village of Skokie Health Department recycles various other household items as a way to support a green community.

Items accepted by the Health Department include:

- Compact fluorescent light bulbs sealed in a zip lock plastic bag. (fluorescent tubes are not accepted);
- Medications, except for narcotics and non-prescription liquids (the name of the medication must be left on the bottle);
- Used syringes/needles in puncture proof containers; and
- Household batteries (rechargeable batteries must have their contact points taped over prior to bringing in for recycling)

These services are for households only, business and clinic recycling is not a part of this program. For further information, please contact the Health Department at 847/933-8252.

Cold Weather Safety Tips for Your Pets

Unless your pet has adequate shelter and is under your supervision, living outdoors can be hazardous for your pet. Compare the amount of exercise your dog receives during the colder months to that received during the warmer months. If your dog is indoors more during the cold months, he is probably getting less exercise and may need less food. However, if your pet is outside often in the winter months, he may need more food to provide the calories necessary to produce more body heat.

If your dog must be outdoors, then you will need to provide them with a dry, elevated doghouse. The house should be small enough to keep your dog warm by trapping the dog's body heat, but large enough for the dog to stand up in and turn around. The doghouse should have insulation, straw for bedding, a door flap and it should be faced away from the wind so that your dog will be protected against the cold. You need to make sure that snow does not pile up high next to your fence because it can provide a boost for your dog to jump over and escape.

When the temperature is below 20 degrees Fahrenheit, it is best to keep all dogs indoors, even if a doghouse is provided. Short-haired dogs and puppies should always be kept indoors when the weather is 40 degrees Fahrenheit or below. Regularly check your pet's water to make sure it is not frozen. When your pet is outside, make sure there is plenty of fresh drinking water available. Ice

and snow do not provide enough liquid for an animal. Your pets can't burn calories without a fresh supply of water, and if they can't burn calories they will get cold.

If you let your cat outdoors - BEWARE - in their search to keep warm they may crawl into a warm car engine or lie next to a tire. To alert an animal that may be in your vehicle, slap the hood before starting your car. This is another good reason why cats are best kept indoors. You should always keep your pet's coat well groomed, but especially during the winter months. If your pet's fur becomes matted it will not properly protect them from the cold.

Skokie's 'Going Green' Village Hall Energy Efficiency Upgrades

Thanks to an Energy Efficiency and Conservation Block Grant (EECBG) from the U.S. Department of Energy, a complete replacement of all existing lighting took place during the summer at Village Hall.

The new fixtures selected as replacements provide over 60% efficiency when compared to the previous lighting. Light and motion sensors were installed throughout the building to improve light usage. In addition, new window installations that provide light harvesting are planned. The new windows will also significantly reduce natural gas consumption by the Village's HVAC system.
