Skokie Snow Plowing Efforts Underway *Streets Plowed Today; Alleys and Sidewalks Plowed on Saturday*

By 11 a.m. on Friday, 15 Skokie Public Works snow plow units were clearing snow from Skokie streets and were joined by another 11 units at 1 p.m. A total 26 snow plow units will be clearing Skokie streets until 11 p.m.

At 3 a.m. Saturday, two snow plow units will begin clearing Skokie alleys. At 7 a.m., 24 additional units will begin plowing alleys and streets as necessary.

Skokie is one of the few municipalities that provides sidewalk snow plowing throughout the community, and sidewalk snow plowing will begin at 5 a.m. on Saturday.

It is anticipated that the Village's alternate-side parking program will be in effect on Saturday, January 21 and Sunday, January 22, 2012. To verify that alternate-side parking is in effect, after 6 a.m. on January 21, residents and business owners are advised to either:

- Call the 24-hour automated snow hot line at 847/675-SNOW (7669).
- Visit www.skokie.org and look for information on the home page.
- Within Skokie Village limits, tune into 1660 AM Skokie radio.
- Announcements also are posted on Skokie's cable television channels 17 and 25.

The alternate-side parking program requires that on odd-numbered dates, vehicles must park on the odd-numbered side of the street from 8 a.m. to 6 p.m. On even-numbered dates, vehicles are required to park on the even-numbered side of the street from 8 a.m. to 6 p.m. For information on Skokie streets that are exempt from the program, visit www.skokie.org.

The Village does not have jurisdiction over a number of major thoroughfares, including Skokie Boulevard, Crawford Avenue, sections of Gross Point Road and other large streets that are plowed by either Cook County or the Illinois Department of Transportation.
