  - Joint meeting with Land Use Boards & Commissions, Economic Development Commission, and Board of Finance Members to discuss Plan of Conservation and Development (POCD) Mr. Pinney reviewed the goals of the meeting, and Ms. Devlin guided the conversation using key points from the POCD. Each Board/Commission discussed what has been accomplished and what steps remain. All individuals present thought it would be a good idea for each area to document and share the completed actions for which they have been responsible. Road; and, \$2,700 from Historic Records grant funds to 10-12.520.1 to purchase a mylar map file. Motion unanimously carried.
