# BOARD OF SELECTMEN Tuesday, December 21, 2010 SPECIAL SELECTMEN'S MEETING MINUTES

**Call to Order – Mrs.** Pellegrini called the meeting to order at 7:43 PM

**Members Present** – First Selectman Lisa Pellegrini, Selectmen Kathy Devlin and Joe Tolisano. Operations Manager Doug Minich – recording.

**Pledge of Allegiance** – was not recited since it was done at the Public Hearing.

Animal Control Services Cost Sharing Agreement by and Between the Towns of Somers and east Windsor. – A motion was made by Mrs. Pellegrini to approve the Agreement and was seconded by Mrs. Devlin. The vote to approve the Agreement was unanimous.

Anti Blight Ordinance – A motion to lay the ordinance on the table for one month was made by Mr. Tolisano. The Zoning Commission will be asked to discuss this at the January 13, 2010 Selectmen's meeting.

Ordinance to Create and Become a Member of the Central Connecticut Solid Waste Authority ("CCSWA") – A motion to approve the Ordinance was made by Mr. Tolisano and seconded by Mrs. Devlin. The motion was passed unanimously.

An Ordinance Establishing Fees for Significant Land use Applications and Affordable Housing Applications. – Mr. Tolisano offered an amendment to the ordinance restating it to read, "An Ordinance Establishing Fees for Technically Complex Land Use Applications and Affordable Housing Applications." His amendment further stated that Article I should read "The purpose of this ordinance is to establish the authority of certain land use boards and commissions, pursuant to CGS §8-1c, to pass through the cost of engaging outside engineering and consulting services in connection with a technically complex application and beyond the expertise of the town resources." Article II should read, "Certain applications for extraordinarily technically complex projects may pose environmental, traffic, and/or other problems beyond the expertise of the Planning, Zoning or Wetlands Commissions' staff to evaluate and make appropriate recommendations. In such instances, if these Commissions with the concurrence of the Board of Selectmen, after reviewing the matter with staff, reasonably conclude that an outside, independent study or consultation is necessary for the Commission to decide the issue before it, the Commission may require an applicant, as a condition of processing its application, to pay for the cost of such study or consultation. In such cases, the applicant will be required to place a sum not to exceed \$10,000 total into fee account to be used for payment for such studies or consultation. The balance of the funds, if any, will be returned to the applicant after the study and/or consultation is completed. Mrs. Devlin seconded the motion and it was approved unanimously.

Design Advisory Board Ordinance – Mrs. Devlin made a motion to fix the date for the Design Advisory Board Ordinance which was seconded by Mr. Tolisano. A vote to approve the motion was unanimous.
