Call to Order: Mrs. Pellegrini called the board of Selectmen meeting to order at 6:28pm.

Opportunity to add agenda items:

Discontinuance of Hampden Road:

Mrs. Devlin made a motion for the discontinuance of Old Hampden Road in its entirety and to forward the matter to a future Town Meeting, seconded by Mrs. Pellegrini. The motion passed.

Internship with Bay Path:

The Board of Selectmen discussed what projects an intern from Bay Path College might be able to complete in the Finance Department. CFO Kim Marcotte recommended the intern create an asset inventory system the Board agreed this was a suitable project. Ms. Marcotte agreed to provide a job description with estimated hours and tasks. Mrs. Devlin will work with Bay Path College to coordinate.

Policy Regarding Sale of Town Owned Property/Equipment:

The Board of Selectmen and Mrs. Marcotte had a brief discussion regarding the Sale of Town Property. Mrs. Marcotte is going to research what other Towns have in place for a Policy.

Correspondence:

Mrs. Pellegrini received a letter from Library Director Francine Aloisa requesting the hiring of up to two individuals for part-time substitute help. Mrs. Aloisa stated the individuals would replace staff that had resigned and it would not impact the salary line budget.

Senator Kissel and Representative Bacchiochi will also be attending. Mrs. Pellegrini is also inviting Congressman Courtney.

Recording Secretary Position:

Charter Revision Resolution:
