TOWN OF SOMERS BOARD OF SELECTMEN REGULAR MEETING MINUTES

Call to Order: Selectman Lisa Pellegrini called the meeting to order at 6:00pm.

Members Present: First Selectman Lisa Pellegrini and Selectman Bud Knorr. Also in attendance: CFO Michael Marinaccio, Rotary President and Somers Education Foundation Vice President Dr. Paul Salva and Town Engineer Jeff Bord. Selectman Kathy Devlin was not available.

Pledge of Allegiance: All members participated in the Pledge of Allegiance.

Great Escape Road Race Recap: Dr. Paul Salva thanked the Selectmen, Public Works and the Police Department for their help and assistance in ensuring that Ninth District Road would be open during the Great Escape Road Race. The Road Race was a great success netting \$9,000.

Somers Education Foundation: Dr. Paul Salva was pleased to announce that this year is the 10th Anniversary of the Somers Education Foundation (SEF) and that the Foundation was voted Connecticut Foundation of the year, beating out a total of 90 other Foundations in the State of CT. He said SEF has awarded \$250,000.00 in grants to the school. The recent SEF Wine Tasting at the Knights of Columbus was very successful in raising \$11,500.00. He also shared recent news that Mr. and Mrs. Presley Blake recently donated \$100,000 to the Somers Education Foundation. Dr. Salva presented the Selectmen with a Banner which will be hung at the entrance of Town Hall.

Dr. Paul Salva left the meeting at this time.

Stebbins Road Right of Way (R.O.W.) Transfer:

Mr. Knorr made a motion to accept the transfer of Stebbins Road Right of Way (R.O.W.), seconded by Ms. Pellegrini. The motion passed.

Staffing:

Ms. Pellegrini received an email from Todd Rolland, Director of Public Works requesting to hire Mr. Robert O'Brian and Mr. Gene O'Reilly as two seasonal on-call snow fighters.

Mr. Knorr made a motion to approve the recommendation from Mr. Rolland to hire Mr. Robert O'Brian and Mr. Gene O'Reilly as seasonal on-call snow fighters, seconded by Ms. Pellegrini. The motion passed.

Ms. Pellegrini requested the Board of Selectmen accept the resignation of Recreation Coordinator Timothy Larocca as he has accepted another job.

Mr. Knorr made a motion to accept the resignation of Recreation Coordinator Timothy Larocca, seconded by Ms. Pellegrini. The motion passed.

Boards and Commissions:

Clarification was made regarding Cultural Commission members. At a previous meeting the BOS appointed Virginia Lockwood to the Cultural commission, however Ms. Abbott is not

resigning until December therefore the Board of Selectmen will delay the appointment of Virginia until December or at such a time there is another vacancy.

Attorney Erik Ness joined the meeting at this time.

Opportunity to Add Agenda Items:

Electric Procurement Pricing:

The Board of Selectmen and Attorney Ness reviewed current agreements with CCM Energy, Bay State Consultants and TransCanada and discussed electric procurement pricing and pricing agreements and options.

Mr. Knorr made a motion to terminate the CCM Energy Purchasing Program and Bay State Consultant relationship with the Town effective immediately and to continue on with the current TransCanada contract until the end of the agreement in December 2015, seconded by Ms. Pellegrini. The motion passed.

Mr. Knorr made a motion to authorize First Selectman Lisa Pellegrini to work with Secure Energy Solutions in determining the best Electric Procurement Pricing Agreement Option for the Town and to sign all necessary documents associated with such agreements, seconded by Ms. Pellegrini. A unanimous vote followed.

CFO Update:

CFO Mike Marinaccio requested the Board of Selectmen approve a resolution authorizing the temporary establishment of the Town's Pension Fund Investment accounts with Morgan Stanley Smith Barney LLC. (See attached.)

RESOLVED, that the Town execute and deliver to said advisor the attached duly signed original of the completed Authorized Persons and Enabling Resolutions for Municipalities and Certain Other Unincorporated Entities, and that the authority to transact business, including but not limited to the maintenance of these accounts be granted to Lisa Pellegrini, First Selectman, Michael D. Marinaccio, Chief Financial Officer and William Fitzpatrick, Chairman of the Pension Committee whose names and signatures are contained in the resolution as persons who are authorized act on behalf of the Town.

Further, The Board of Selectmen authorizes the temporary establishment of these funds with the advisor for a period not to exceed 6 months in duration pending the completion of an RFP process to select the Town's permanent pension investment advisor.
