CONSERVATION MINUTES REGULAR MEETING WEDNESDAY, December 5, 2007 TOWN HALL – 7:00 P.M.

I. CALL TO ORDER

Joan Formeister called the regular meeting to order at 7:05 p.m. Members Candace Aleks, Henry Broer, Joan Formeister, Todd Whitford, Dan Fraro, and Lise Wood (seated for Karl Walton) were present and constituted a quorum. Also present was Erosion Control/Wetland Enforcement Officer, David Askew.

II. OLD BUSINESS:

a. DISCUSSION/POSSIBLE DECISION: WETLANDS APPLICATION #580, FILL & EXCAVATION WITHIN WETLAND, 164 HAMPDEN ROAD, GROWER DIRECT FARMS

Mr. Askew informed the Commission that the Applicant called his office to inform him that he was not ready to proceed. Mr. Askew also stated that he had an extension letter which allowed for an extension until January 22, 2008; which is the applicant's limit.

b. OTHER – There was none.

III. NEW BUSINESS

a. WETLANDS APPLICATION #584, NEW HOUSE, DRIVEWAY & FILL IN UPLAND REVIEW AREA, 265 MOUNTAIN VIEW ROAD, WYSOCKI

This lot was part of the Whitaker property that the Town of Somers purchased and subdivided into three lots. Upon review of the revised plan for one of the lots on Mountain View Road, Mr. Askew noted that there was proposed grading closer to the wetland than initially approved.

Mr. Wysocki, the owner of the property, reviewed the site plan. He explained that wetlands were originally delineated in the late 1980's and discussed a minor revision to the location of the wetland that was delineated in the field by Mr. Askew. The revised location is shown on the site plan. With the revised location, the corner of the proposed garage would be approximately 50 feet from the wetland and the slope extension would be about 25 feet.

Mr. Askew mentioned that he had no issue with the proposal as long as there was 25 feet of an undisturbed buffer. The Commission requested that permanent markers for the wetlands be made using the tags

provided by the Land Use Office. Mr. Wysocki had no issues with this request.
