### Piedmont Coffeehouse:

Purchase of new chairs. Commission members agreed there was a need to replace the existing chairs. S. Grabierz researched options and proposed purchasing the chairs through Costco. Members unanimously agreed to purchase 80 chairs through Costco at a cost of \$1999.98.

J. Batchelor has mailed the brochure with application to potential entrants. The two jurors have been selected and confirmed they will judge the works on April 24, 2016 in preparation for the show opening on May 1, 2016.

<u>Summer Concert:</u> Selection of artists has been completed. J. Reed working with the Schools Business Manager has negotiated using the Elementary School as the alternate site should we encounter bad weather. A motion was made to pay the custodians a minimum 2 hour fee for each week the concert is scheduled regardless if the school is used. The members unanimously voted to approve the motion. Given this decision, contracts will go out this week to each of the artists confirming their appearance.
