SomersNow.com

The chairman distributed an email from Dr. Paul Salva requesting the commissions assistance assuring the survival of SomersNow.com. The idea of appropriate high

Motioned by Rick Cheney and seconded by Vicki Clark that the commission engage Mrs. Reed as coordinator for the 2013 business directory project and that the chairman be authorized to move forward with this action. Passed unanimously. Commissioner Reed abstained.
