Fire Department Budget Comparison, attached hereto, distributed and reviewed. 1. Biggest line increase: Part-Time line item. Need to pay an individual to cover 0000-0600 shift every night, as department having extreme difficulty getting volunteers for that time frame.	1920

- 3. Personal Protective Equipment reduced because of new equipment obtained (see above).
- 4. Volunteer Stipend reduced because of reduced membership.
- Gas Allowance: Currently \$2.00 per call. Given price of gas and distances driven, members incur personal expense to volunteer services to town. Line item reduction based on 1st two quarters of this year.
- Total increase, including additional \$24,400 increase in Part Time line account, is only \$6,560 1.08% (Other line items reduced approximately \$18,000 per year)
