Task 2.4. Shawn Burgmyer has cleared the portion of the Lakeside Trail between the Aya Po parking area and the Hurds Lake dam as his Eagle Scout community project. The trail will be blazed when the remainder of the trail is complete.

Richard Bailey will meet with Ann Moses and Dom Wilson to lay out the route for the trail connecting the top of Perkins Mtn. with the Lower Trail. Richard will also flag the Old Shenipsit trail connector so that clearing can begin.

- Task 2.7. A temporary trail map has been posted at the Aya Po parking area.
- Task 3.0. Vegetation that was cleared from the North and South Forest View Trails in May has resprouted. Ann will arrange another RRRC work party to clear these trails.
- Task 3.6. The DEEP grant application for improvements to the South Forest View Trail has been submitted. A funding decision is expected this fall.
