**PLANNING MINUTES  
SPECIAL MEETING  
THURSDAY, DECEMBER 8, 2009**

**I. CALL TO ORDER**

Chairman Brad Pellissier called the regular meeting to order at 7:00 pm. Members Brad Pellissier, Greg Genlot, Bill Salka, and alternates Tim Carravella (seated for Cliff Bordeaux) were present and constituted a quorum. Also present: Town Engineer, Bob Cafarelli and Selectmen Lisa Pelligrini, Kathy Devlin and Joe Tolisano and Town Attorney Karl Landolino (7:10).

*A motion was made by Mr. Genlot; seconded by Mr. Salka and unanimously agreed to proceed to Item III. Old Business.*

**III. OLD BUSINESS**

**a. FRANKLIN WOODS DRIVE EXTENSION AND LOUBIER DRIVE EXTENSION  
ACCEPTANCE**

Mr. Cafarelli presented the site plans for the Franklin Woods Drive and Loubier Drive Extensions. He explained that the extension for Franklin Woods will be 2,250 feet, two-way from Franklin Wood Road to Scully Road. No deeds will be needed. The plan for Loubier Drive Extension is dated from 1977. The road is 30 years old.

*A motion was made by Mr. Salka; seconded by Mr. Genlot and unanimously voted to recommend acceptance of the following roads to the Board of Selectmen:*

**Loubier Drive** as shown on Plan "Section VI, Plan Prepared for Blue Ridge Estates Inc., Loubier Drive, Somers, Connecticut "prepared by A. Bowen Davies & Co., Land Surveyor, 96 Ridgewood Road, Glastonbury, Conn. 06033, dated 5-15-75, revision date 11-14-76.

**Franklin Woods Road** as shown on plan "Subdivision Plan prepared for Richard Pollio, Somers, Connecticut" prepared by Gardner and Peterson Associates, 576 Old Post Road, Tolland, Connecticut, dated 12-8-86, revision dates 1-5-87, 1/17/87, 4-21-87, 5-6-87, and 9-30-87.

Mr. Cafarelli notified the Board that he requires information for the filings for the other Town roads that are complete. He provided the commission with copies of his requests to the developers for Applewood Drive, Brittany Lane, Harvest Hill Drive, Bobolink Lane, Barn Swallow Drive and Aspen Ridge.
