CALL TO ORDER:

Chairman Bradley Pellissier called the regular meeting to order at 7:00 p.m.

Plan of Conservation and Development

Mr. Jorge extensively reported on updates on the "Address Community Needs" in the Town of Somers. The State Trooper's office has been converted to the Multi-purpose Room in Kibbe Fuller. The Firehouse has been constructed to better serve the Town. New fire hydrants have been installed on Field Road and Egypt Road (the industrial roads).

Mr. Jorge added Woodcrest is currently being worked on. State and federal funding should be pursued to purchase land for the income assisted elderly housing. Mr. Pellissier said the money is coming in to subsidize the elderly homes at Woodcrest. Mr. Bordeaux reported Phase 1 has been developed.

Mr. Jorge explained that a grant to expand the Senior Center was approved. It is expected to expand by June 2012. Mr. Bord mentioned that the funding for the Battle Street sidewalk has also been approved. Mr. Jorge said a part-time assistant has been hired for the Senior Center. Discussion continued.

Mr. Pellissier suggested scheduling another meeting to discuss this further.
