**MINUTES**

- Charles Colby asked for an update on the repairing of the pot holes on Bilton Road. Warden Tarascio responded that his letter to the Town of Enfield about this matter has not resulted in any action or even a reply. Tom Clark volunteered to contact an acquaintance in Enfield who might be in a position to help in this matter.

**NEW BUSINESS:**

- Tom Clark has been appointed to the board by the town selectmen at their December 2011 meeting.
- Questions were raised about how a town resident could get their telephone number added to the DOC emergency call list and how would someone even know that such a list exists. After a brief discussion, it was agreed that although the town's website does provide residents the opportunity to have their number added to the call list, Chairman Minch and Charles Colby would look at the website and investigate possible ways of improving it.

- **Review of Significant Incidents or Policy Changes in Prisons**

- Osborn CI: Warden Chapdelaine reported that there are no longer any inmates being housed in the gymnasium, due to the drop in inmate population.
- Northern CI: Warden Maldonado reported that about fifteen people attended a two hour tour of Northern that was conducted that morning.

Willard/Cybulski CI: Warden Tarascio had nothing to report.
