II. Review estimates for recreation facility upgrades

Tennis Courts

The following quotes for tennis court repair were presented at the meeting:

Hinding Tennis - 4 options offered:

- 1. Clean and crack repair \$41,000
- 2. above with net posts and anchors \$50,000
- 3. 4 tennis courts reconstruction \$113,000
- ice rink option would have to be engineered prior to quoting

M&M Tennis

- 1. reconstruction 4 courts \$135,900 includes net posts fence
- 2. reconstruction with ice rink \$165,000
- 3. owner to supply process \$127,300
- 4. town work with ice rink \$139,000

Vermont Tennis

Verbal quote \$50,000 per court

Basketball Courts

M&M

Repair and repave includes posts and backboards \$18,000 Replace completely includes posts and backboards \$24,250

Lane construction 1.5 inch overlay w/o painting \$11,880

Skate Park

Dreamland \$50,000-\$70,000 would get 1700-2100 ft2 of skate area Who Skates has a skate park that could be done for \$75,000 California Skate Parks can do something in a range of \$50,000-\$70,000

Skate park needs quote with scope of work for \$50k multi phase need before Thanksgiving

The board members agreed to move forward with a recommendation to reconstruct the 4 tennis courts (not the practice court and no additions for the skate rink) and to repair and repave the basketball court and replace the posts and nets. JJ would ask M&M for a new quote to do the tennis and basketball courts with the expectation of cost savings by using one vendor. The expectation is that both could be done for \$150,000 or less. The remaining funds would be recommended to put toward the skate park provided a vendor could provide a quote that would show that a park could be built for the remaining \$50,000. Karen Murdoch has the action to retain quotes for a skate park for under \$50,000. JJ has the action to get a new quote for both tennis and basketball.
