 - i. Mike Rogers / Elaine Beebe were curios where the Rec Commission was at regarding the proposed 2014 Field Use Policy. Fees were discussed in detail and options were discussed pertaining to additional opportunities for the Somers associations to pool their resources in presenting a larger future initiative for the town.
 - ii. Concerns surround the availability of fields for all organizations, specifically Somers LL and Lacrosse. Rec Commission members continue to remind the area associations that the commission in jurisdiction stops at the town field locations, schools are the school board jurisdiction. The Commission can recommend options but is unable to propose any recommended changes.
 - iii. Development behind the high school could become a reality as it has for the baseball associations in the development of the modified 46/60 and 50/70 field at Field Rd. Park and a T-Ball field at town hall fields.
 - . Special meeting required with the sports associations to discuss the long term plan including, required resources, costs, benefits, area opportunities, schedule and timeline.
