Update:

- 1. Field #5 (50'/70' field):
 - a. Clay for the infield is stockpiled, we will install the infield in the spring
 - b. Grading continues in bonus area between field #5 outfield and High School softball field
- 2. Park gate has been relocated to allow parking along the roadway during the winter
- 3. Bathrooms and kitchen of the Gazebo are being repainted
- 4. Intersection improvements Ninth District Road / Main Street:
 - a. CL&P has completed moving of the power lines, communication companies should finish

moving their lines over the next two months;

- b. Roadwork is schedule to begin in the spring;
- c. Ninth DST Road closure is scheduled for July & August of 2014.

*Clarification:

There has been some misinformation about the expansion of the 20 acres of Town land adjacent to the

Park / School complex. I'd like to clarify the issue:

o Two and a half years ago while we were looking for ways of relieving the pressure on our existing

fields, we "discovered" 20 acres of unused Town land next to the Park / School complex. Δ fter

discussions with members of the Recreation Commission, Town staff and Board of Education staff, the

Town Engineer produced a preliminary first draft of possible recreational uses for this land.

 $\circ~$ During our discussions, members of the Recreation Commission expressed an interest in making

better use of field #5 and Board of Education staff expressed an interest in solving an issue of

Handicapped access to the School track and fields.

 Upon learning of these issues, the DPW agreed to perform the expansion of field #5 for Park use, and

install a new accessible parking lot behind the High School to help comply with the Handicapped

access issue at the request of the Board of Ed staff.

 $\circ~$ All of that work is nearing completion as is noted in update #1 above and has been noted in all of my

Parks reports over the two years.

The question of what to do with the 20 acre parcel, if anything, is still in early stages.

If we move forward with any use of that land we will have to:

- o Produce a workable design
- o Gather public input

- o Receive a recommendation from the Recreation Commission
- $\circ\;$ Submit the design and recommendation to the Board of Education and the Board of Selectman
- o Procure funding
- o Apply for and receive all required permits from the State and Town
- o Go out to bid, Select a contractor...

As you can see this is a long term project that is still "on the drawing board".
