1. Field Road Park:

- a. Sprinkler head replacements continues
- b. Dug-out repairs and improvements are continuing
- c. Grass is establishing well at field five, and along the banks of the new parking lot,
- d. After aeration and fertilization, new field eight is showing considerable improvement.

2. High School gate:

High School gate is now closed and locked.

3. Intersection improvements Ninth District Road / Main Street:

Construction is nearly complete. The remaining bridgework, guiderail and pavement markings are scheduled to be completed within the next two weeks.

4. Library Repairs:

The Parks department replaced the roof on the shed behind the Library. The Library irrigation system has been repaired.
