### **V. Coordinators Report:**

Chris Boucher reviewed the Coordinators Report which included the following:

1. Permits – all permits were approved with 1 tentative approval for Connecticut Celtic FC Soccer Clinic. Chris will be contacting them to confirm all the dates requested.
2. Somers Rec Fiscal Year 2016 Program Report  
All programs were reviewed & discussed. After a lengthy discussion by the Recreation Commission & all those in attendance it was unanimously agreed that the Recreation Department will end involvement with and hosting of Co-Ed Softball. The decision to end this program came after careful consideration of a number of concerns including:
  - The small percentage of Somers Residents that participate
  - The increasing number of injuries to players during play on Town property
  - Increasing incidents of player misconduct including one that ended in a fight
  - Liability exposure to the town
  - The amount of administrative time necessary to maintain the program.

Todd Rolland will be sending a letter to all parties concerned.
