I. CALL TO ORDER:

III. Somersville WPCF – Expansion Update:

Steve Jacobs said work is continuing to complete the disinfection chamber. The valve chamber is complete. Pump will be installed next week and the tanks will be hooked up. By next week, we should be running on the new system. Tree clearing has been finished. The town crew will do the regrading next week. Dan Hinckley will also finish up and it appears we will meet the 5/15/08 completion date. Training needs to be set up for Hank Anderson and Steve Jacobs on the new electronics. The fence will be the final thing. Dan Hinckley has not given Steve Jacobs a quote for the water service. Steve did ask the State about funding for this public water service, but it does not look promising at this time.

IV. Sunset Drive – PCE Contamination:

Steve Jacobs talked with David Pinney, First Selectman who stated that Town Attorney Carl Landolina has been corresponding with the DEP regarding the completion of the final consent order.

V. <u>Correspondence/Audience Participation:</u>

Steve Jacobs received a report from Lea Engineering with an update of the monitoring wells on Rye Hill Circle. All contamination levels remained about the same during this quarter.

George VanTasel questioned the location of the new well at the prison which is located near the spot where gas contamination was discovered.
