The letter withdrew their application for a size variance on the sign for the business. Chairman Torres explained that the applicant will install a sign in compliance with the Zoning ordinance. He said that the Zoning Enforcement Officer will need to follow up to make sure that a multitude of small signs do not continue to be used to advertise the business.

Chairman Torres opened the floor to public comment.

John Cutter of Olmstead Manor Drive, objects to the gaudiness of the business signs that have been proliferating in Somers. He said that he chose to live in Somers because of its colonial atmosphere. He asked the ZBA to consider the effect of any proposed business signs on the appearance of the Town before approving them. He said that the Town is beginning to look like Coney Island.

The Commissioners concurred with Mr. Cutter's concerns and recommended that he contact the ZEO and also that he review the Zoning regulation regarding sign restrictions.
