NOTICE OF SPECIAL TOWN MEETING
Thursday, October 24, 2013
6:30pm
Town Hall Auditorium**

All electors and persons eligible to vote in town meetings of the Town of Somers, Connecticut (the "Town") are hereby warned that a Special Town Meeting of the Town is to be held at the Somers Town Hall Auditorium, 600 Main Street, Somers, Connecticut on Thursday, October 24, 2013 at 6:30 p.m., for the following purposes:

1. To elect a moderator.
2. To consider and discuss (but not vote on) resolutions to:
 - I. authorize an appropriation of \$2,471,000 for the costs of roof replacement at the Somers Elementary School, the Somers High School and certain school maintenance buildings, fire alarm system improvements at the Somers Elementary School and the Somers High School and the replacement and installation of a generator at the Somers Elementary School and the financing of said appropriation by the issuance of general obligation bonds and notes in an amount not to exceed \$1,053,000 and the use of grants and such other sources of funds.
 - II. authorize an appropriation of \$3,105,000 for the costs of road improvements to Mountain Road and Somerset Lane and the financing of said appropriation by the issuance of general obligation bonds and notes in an amount not to exceed \$2,605,000 and the use of grants and such other sources of funds.
 - III. authorize an appropriation of \$565,000 for the acquisition of an ambulance and a tanker truck for the Somers Fire Department and the financing of said appropriation by the issuance of general obligation bonds and notes in an amount not to exceed \$565,000.
 - IV. authorize an appropriation of \$53,000 for the acquisition of a shuttle bus for the Somers Senior Center and the financing of said appropriation by the issuance of general obligation bonds and notes in an amount not to exceed \$53,000.

The full text of the foregoing authorizing resolutions are on file and open to inspection at the office of the Treasurer, Town Hall, Somers, Connecticut for the use or inspection of any interested person.

Pursuant to Section 7-7 of the Connecticut General Statutes, as amended, the Board of Selectmen by resolution adopted at its meeting on August 29, 2013, removed the foregoing resolutions from the agenda of this Special Town Meeting for submission to the voters for vote by voting machine to be held on Tuesday, November 5, 2013, at the times and at the polling places to be noticed.

3. To adjourn the meeting.
