The Capitol Region Council of Governments (CRCOG) invites sealed bids for four (4) eziQC® (EZ Indefinite Quantity Construction) contracts for use by Members of the Capitol Region Purchasing Council, a program of CRCOG. These are indefinite quantity, indefinite location construction contracts for renovation, repair and upgrade projects. There is one contract for each geographic area in Connecticut (Northwest, Northeast, Southwest and Southeast). Each contract has an estimated annual value of \$1,000,000. A **mandatory pre-bid conference** will be held on **Wednesday, October 22, 2014 at 10:00** at the **MIRA Trash Museum, 211 Murphy Road, Hartford**. Bid documents will be available at the pre-bid conference. A \$50 non-refundable deposit (in the form of cash, certified check or company/business check) is required to obtain the bid documents. Personal checks will not be accepted. Bidders must have at least \$1,000,000 in available bonding capacity to qualify for award. Bids are due as follows:
