City staff is looking for approval to sell vehicle 3136-17, a 2017 Dodge Charger used by the Police Department. This vehicle is to be replaced by the new Police Dodge Durango approved for purchase by the Commission at the August 12<sup>th</sup> meeting. The Charger will be sold when the new vehicle is placed in service. This vehicle has been chosen based on its current valuation for resale and maintenance history.

### 8D. "Summer's End" DDA Car Cruise-In Request

The Downtown Development Authority is planning Summer's End, another car cruise-in and food truck activity for Friday, September 18<sup>th</sup> in the downtown area. As with the previous event, this is intended to be loosely arranged to avoid being an outdoor gathering in violation of the Governor's Executive Orders. Classic cars will be parked downtown with food truck vendors on North St.

### 8E. PA 425 Property Transfer Request – Lifecare Ambulance

On August 4, 2000 the City of Sturgis entered into an Act 425 Agreement for the "Conditional Transfer of Property" from Sturgis Township to the City of Sturgis. As provided for in this agreement, a parcel may be transferred into the City if the property owner requests the transfer.

Lifecare Ambulance Real Estate Holding Company has purchased three adjoining parcels along West Chicago Road, next to NAPA Auto Parts. They

have requested to transfer the two parcels, currently in Sturgis Township, into the City of Sturgis. Lifecare has submitted an Exhibit B petition requesting the township properties be transferred into the City. Sturgis Township will consider a similar resolution at their September 8<sup>th</sup> board meeting.

In accordance with State law and as stated in the PA 425 agreement, Sturgis Township and the City Commission may pass resolutions approving the transfer. If Sturgis Township does not act on the request for transfer within 60 days, the City Commission may pass a resolution to transfer the property to the City and file it with the State of Michigan.

### A. Cemetery Rates and Section Development

**Staff: Rick Miller** 

### **Cemetery Rates**

City staff recently reviewed the rates for Oak Lawn and Sturgis Memorial Gardens Cemeteries and found that costs have risen to the point that an increase is warranted. The transfer from General Fund to the Cemetery Fund has been increased in recent years to maintain a positive fund balance.

The rates were last increased in 2012 and Staff is proposing a 5% increase each year for the next two years to bring rates back into alignment with costs. Included in the packet is a copy of the proposed fee schedule.

Most rates in the current fee schedule include discounts for City of Sturgis residents; these discounts vary from 10% to 45% based on the service. Along with the increase, staff is proposing that the discount for City residents on services be a consistent 20%. Certain rates, including for foundations, lettering, and overtime have not previously included a discount rate and a discount rate is not proposed. Rates for a deed duplicate and a transfer deed are recommended to not include a resident discount in the proposed rates.

Also included in your packet is a comparison of the City's current and proposed rates to those of other local communities. Not all rates had equivalent comparisons, but generally the City's rates seem in line with other area communities.

The Parks and Cemetery Board reviewed the proposed rate increases at a recent meeting and recommended them to the City Commission.

### **Section Development**

### **B.** Social District Permits

**Staff: Andrew Kuk** 

Following the City Commission's approval of a Social District and Commons Area at the last Commission meeting, City staff has received requests for recommendation of two Social District Permit applications. The first is from Wings of Sturgis, LLC (DBA Wings Etc.), located at 111 W. Chicago Rd., and the second for the City of Sturgis, located at the Sturges-Young Center for the Arts, 201 N. Nottawa St. As part of Michigan Liquor Control's permit application, the governing body of the Local Government Unit must supply a recommendation on all applications.

Both locations are contiguous to the City's Commons Area and both have a Class C liquor license which qualifies them to receive a Social District Permit. Wings Etc. has stated that they are willing to enter into a License Agreement with the City for use of the Commons Area logo as outlined in the Downtown Social District Plan; Sturges-Young Center for the Arts would be subject to the same arrangement.

### REGULAR MEETING - STURGIS CITY COMMISSION WEDNESDAY, AUGUST 12, 2020 ELECTRONIC/VIRTUAL

Mayor Hile called the meeting to order at 6:00 p.m.

Assistant City Manager Andrew Kuk provided information on the City of Sturgis Electronic/Virtual Meetings Policy.

### AMENDMENT TO THE ORDINANCES OF THE CITY OF STURGIS ALLOWING SOCIAL DISTRICTS IN PARKS AND PUBLIC PROPERTY

An ordinance to amend Chapter 38, Article V, of the Ordinances of the City of Sturgis regarding the prohibition of alcoholic beverages in parks and on public property to allow for Social Districts and Commons Areas consistent with Public Act 124 of 2020 (MCL Section 436.1551).

WHEREAS, Public Act 124 of 2020 establishes Section 436.1551, which authorizes the issuance of Social District Permits for the sale of alcohol by the MLCC, under which the governing body of a local governmental unit may designate a Social District within its jurisdiction and establish Commons Areas; and

WHEREAS, the City of Sturgis has determined that it is in the best interest of the residents of the City to amend the current prohibition against the consumption of alcoholic beverages in parks and on public property to allow for the establishment of Social Districts and associated Commons Areas by the Sturgis City Commission.

NOW, THEREFORE, the City of Sturgis, St. Joseph County, Michigan, ordains:

Part II – Chapter 38, Article V, Sec. 38-124 is hereby amended as follows, effective as of September 16th, 2020:

Sec. 38-124. - Consumption of alcoholic beverages prohibited in parks and on public property.

No person shall consume any alcoholic liquor, beer, wine or spirits in any park, upon any sidewalk or public highway, or in any place of amusement not licensed by the state to furnish alcoholic liquor, beer or wine for consumption on the premises, nor shall any person consume any alcoholic liquor, beer, wine or spirits in or upon any lands owned by the city or by any other public or semipublic corporation or entity, except as such consumption of alcoholic beverages may be specifically allowed by the city commission in conjunction with an application made to the state for a permit or license to serve alcoholic beverages. This provision does not apply to the legal consumption of alcoholic liquor, beer, wine or spirits in a Commons Area of a Social District established by the Sturgis City Commission in compliance with MCL Section 436.1551.

City Manager Michael Hughes provided an update on the State's new Water Assistance Program. Discussion followed.

City Controller Holly Keyser and Chris Lund, Utility Financial Solutions, provided details of the proposed 2020-21 electric rates. Discussion followed.

Moved by Comm. Klinger and seconded by Comm. Bir to approve the electric rates for billings beginning on October 1, 2020 as presented.

Voting yea: Eight Voting nay: None MOTION CARRIED

Moved by Comm. Klinger and seconded by Comm. Mullins to go into Closed Session to consider the dismissal, suspension, or disciplining of an employee at the request of the employee and purchase of property.

Meeting recessed at 8:10 p.m. Meeting reconvened at 9:33 p.m.

Moved by Comm. Good and seconded by Comm. Klinger to approve the Resignation and Separation Agreement with Public Safety Director Geoff Smith and authorize City Manager Michael Hughes to sign the agreement as presented subject to attorney final review.


