#### 10. New Business

#### A. Re-Zoning of 118 & 120 S. Monroe St.

**Staff: William Prichard** 

A zoning district change has been requested by Jamie Crites for the properties located at 118 S. Monroe Street and 120 S. Monroe Street. The request is to change the zoning district of the properties from Central Business (B-C) to Residential 4 (R-4).

If the rezoning is approved, the owner would change the use of 118 S. Monroe from a business use to a single-family residential dwelling. The use of 120 S. Monroe would remain unchanged and continue as a two-family dwelling (duplex).

The Future Land Use Map identifies these properties as Central Business District. Despite the Future Land Use designation, these properties are adjacent to residential uses and the property at 120 S. Monroe is currently a two-family residential dwelling. The property at 118 S. Monroe was previously a residential property which had been used as a commercial office.

The Planning Commission held a public hearing at their December 15, 2020 meeting regarding the rezoning of the property. At that meeting the Planning Commission voted to recommend the rezoning to the City Commission.

#### B. Fire Department Aerial Apparatus Bid

#### **Staff: Ryan Banaszak**

The City staff is proposing the purchase of a new aerial fire apparatus to replace the 2000 Pierce, 95' aerial apparatus currently in the fleet. The purchase of the apparatus is planned to be included in the proposed budget for fiscal year 2021-2022.

Under the current fleet plan, the replacement of the 2000 Pierce aerial apparatus is set at 20 years. As with any piece of aging equipment, this unit is starting to develop costly issues. Since 2017 the apparatus has been repaired 11 times. Another factor to consider is the ladder warranty expires on December 31, 2021. As part of NFPA 1911 and OSHA standards, for emergency vehicle use, the apparatus must be inspected annually. Should the ladder fail the annual inspection for any reason, the truck would be placed out of service and repairs to the ladder could reach up to one million dollars. It should also be noted that if the ladder fails, the value of the apparatus diminishes to near scrap value.

City staff proposes proceeding with a bid process for a new aerial apparatus. Staff is working with City Mechanic, Dennis Hetman, on recommendations for the engine and transmission. Included with your packet is a list of proposed bid specifications as well as a letter from Director of Public Safety, Ryan Banaszak.

WHEREAS, Aaron Miller, a Sturgis native, who graduated from Sturgis High School in 2006 and Western Michigan University in 2010, was elected to serve the 59<sup>th</sup> District in the Michigan House of Representatives in 2014, 2016, and 2018 for the Constitutional maximum of three terms; and

WHEREAS, during his time in office, Representative Miller made service to his constituents, including residents of the City of Sturgis, St. Joseph County, and all those in the 59<sup>th</sup> District a top priority; and

WHEREAS, Representative Miller was always willing to meet, listen and learn about constituent concerns and issues; and

WHEREAS, Representative Miller helped pass notable legislation making water withdrawal based on more science, establishing the first-ever state dark sky preserve on county property at Lawless Park in Cass County, protecting the mental health counselor profession, and passing auto insurance reform; and

WHEREAS, Representative Miller always made himself available to the City of Sturgis regarding issues of impact to our local government; and

WHEREAS, Representative Miller's final term in office ended on January 1<sup>st</sup>, 2021.

### AMENDMENT TO THE ORDINANCES OF THE CITY OF STURGIS PROVIDING AN EXTENDED TIMEFRAME FOR TAX EXEMPTIONS FOR ST. JOSEPH STREET LOFTS AND MONROE STREET LOFTS

An ordinance to amend Chapter 2, Sections 2-307 and 2-308 of the Ordinances of the City of Sturgis regarding the date of automatic repeal of the tax exemptions for St. Joseph Street Lofts and Monroe Street Lofts and to provide for an effective date of this Ordinance.

WHEREAS, the City of Sturgis has determined that it is in the best interest of the residents of the City to add tax exemptions and set a fee in lieu of taxes for St. Joseph Street Lofts, a development providing housing for individuals and/or families of low to moderate income, and Monroe Street Lofts, a development providing housing for seniors of low to moderate income; and

WHEREAS, both projects require an extended timeframe to apply for low income housing tax credits through the Michigan State Housing Development Authority due to COVID-19.

NOW, THEREFORE, the City of Sturgis, St. Joseph County, Michigan, ordains:

Part II – Chapter 2, Article IV, Division 1 is hereby amended as follows, effective as of January 15<sup>th</sup>, 2021:

#### Sec. 2-307. - Tax exemption for St. Joseph Street Lofts and fee in lieu of taxes.

(a) Purpose. It is acknowledged that it is a proper public purpose of the State of Michigan and its political subdivisions to provide housing for its low income persons and families and to encourage the development of such housing by providing for a service charge in lieu of property taxes in accordance with the Act. The City of Sturgis is authorized by this Act to establish or change the service charge to be paid in lieu of taxes by any or all classes of housing exempt from taxation under this Act at any amount it chooses, not to exceed the taxes that would be paid but for this Act. It is further acknowledged that such housing for low income persons and families is a public necessity, and as the City of Sturgis will be benefited and improved by such housing, the encouragement of the same by providing real estate tax exemption for such housing is a valid public purpose. It is further acknowledged that the continuance of the provisions of this section for tax exemption and the service charge in lieu of all ad valorem taxes during the period contemplated in this section are essential to the determination of economic feasibility of the housing development that is constructed or rehabilitated with financing extended in reliance on such tax exemption.

The City of Sturgis acknowledges that the sponsor (as defined below) has offered, subject to receipt of an allocation under the LIHTC Program by the Michigan State Housing Development Authority, to construct, own and operate a housing development identified as St. Joseph Street Lofts on certain property located at 303 St. Joseph Street, parcel identification number 052-040-101-00 in the City of Sturgis to serve low income persons and families, and that the sponsor has offered to pay the city on account of this housing development an annual service charge for public services in lieu of all ad valorem property taxes

(m) Effective date and automatic repeal. This ordinance section shall become effective 20 days after its passage, as provided in the City of Sturgis Charter. In the event the sponsor does not receive an award of a low-income housing tax credit for the housing development from the authority on or before August 31, 2022, this section shall be automatically repealed without further action of the city.

#### Sec. 2-308. - Tax exemption for Monroe Street Lofts and fee in lieu of taxes.

(a) Purpose. It is acknowledged that it is a proper public purpose of the State of Michigan and its political subdivisions to provide housing for its low income persons and families and to encourage the development of such housing by providing for a service charge in lieu of property taxes in accordance with the Act. The City of Sturgis is authorized by this Act to establish or change the service charge to be paid in lieu of taxes by any or all classes of housing exempt from taxation under this Act at any amount it chooses, not to exceed the taxes that would be paid but for this Act. It is further acknowledged that such housing for low income seniors is a public necessity, and as the City of Sturgis will be benefited and improved by such housing, the encouragement of the same by providing real estate tax exemption for such housing is a valid public purpose. It is further acknowledged that the continuance of the provisions of this section for tax exemption and the service charge in lieu of all ad valorem taxes during the period contemplated in this section are essential to the determination of economic feasibility of the housing development that is constructed with financing extended in reliance on such tax exemption.

The City of Sturgis acknowledges that the sponsor (as defined below) has offered, subject to receipt of an allocation under the LIHTC Program by the Michigan State Housing Development Authority, to construct, own and operate a housing development identified as Monroe Street Lofts to serve low income seniors, and that the sponsor has offered to pay the city on account of this housing project an annual service charge for public services in lieu of all ad valorem property taxes. Monroe Street Lofts will be established on certain property located at 200 E. Chicago Road, parcel identification number 052-040-218-00, and 111 N. Monroe Street, parcel identification number 052-040-214-00, in the City of Sturgis; these parcels may in the future be combined as provided for under Michigan State law and the City of Sturgis Code of Ordinances.

(m) Effective date and automatic repeal. This ordinance section shall become effective 20 days after its passage, as provided in the City of Sturgis Charter. In the event the sponsor does not receive an award of a low-income housing tax credit for the housing development from the authority on or before August 31, 2022, this section shall be automatically repealed without further action of the city.

Klinger to approve the Professional Services Agreement with Fishbeck, Inc. for design phase services for the St. Joseph Street Reconstruction Project in the amount of one hundred eighteen thousand, four hundred ninety dollars (\$118,490.00) and authorize City Manager Michael Hughes to sign all necessary documents.

#### **Current Zoning Map**



#### **Purchase of New Aerial Apparatus**

The proposed budget for fiscal year 2021/2022 will include the purchase of a new aerial fire apparatus for the City of Sturgis. This purchase is consistent with the 20-year replacement plan recommended by the motor vehicle committee, which established the department contributions to the motor vehicle fund. In preparation for this purchase Fire Department staff have been reviewing multiple apparatus models and their manufacturers over the past year to provide the best possible recommendation, balancing both the quality of the equipment and fiscal responsibility.

The City of Sturgis Fire Department has had a ladder apparatus/aerial in its fleet since 1942 when the City purchased an American LaFrance 65-foot ladder apparatus. The American LaFrance was replaced in 1979 with a Mack Ladder apparatus that was the predecessor to our current Pierce 95' mid-mount aerial. As with all firefighting equipment, ladder trucks have evolved over the years and now offer additional capabilities that not only greatly increase firefighter safety, but also provide additional life saving features. The City of Sturgis has multiple buildings in town with two or more stories including factories, schools, and residential and commercial buildings. The need for proper, safe equipment to reach these heights during an emergency is imperative to mitigate risk to lives and property.

Our current apparatus is a 2000 95' Pierce mid-mount that was purchased as a demo unit in December of 2001. This unit has been very reliable over the last 20 years but as with any piece of equipment it is starting to develop costly issues due to age and use. Since 2017 our current apparatus has been repaired 11 times for a variety of issues including repairs to the waterway, fuel injectors and multiple hydraulic leaks. Replacing this apparatus at the time planned not only

diminishes our risk for significant out of service time, costly repairs, and increased risk of failures on an emergency scene, but also represents a fiscally prudent approach.

A primary factor in our request to replace this unit after 20 years of service is the expiration of the ladder warranty. The current apparatus has a 20-year ladder/aerial warranty that that expires in December of 2021. As part of NFPA 1911 and OSHA standards for emergency vehicle use, all fire apparatuses must be annually inspected/tested for their intended use. A ladder/aerial apparatus requires testing of the ladder for structural and hydraulic integrity. If the ladder fails inspection due to structural integrity issues, the cost to refurbish/replace the ladder components would approach one million dollars. In addition, we would be without a ladder/aerial apparatus in our fleet for the better part of a year. It's worth noting that if the ladder fails inspection, the resale value of the vehicle would decrease to near scrap value. Based on current market values of similar apparatuses, the anticipated resale value if sold in the next year or two is between \$100,000 and \$250,000.

As we work to identify the best vehicle to recommend for purchase several key factors should be evaluated to develop bid specifications including ladder height, vehicle overall length and height, operations capabilities, safety features, drivability and mechanical reliability. In addition, we consulted with City Mechanic Dennis Hetman to gather his input regarding the engine and transmission of the vehicle. Dennis recommended a Cummins X15 engine due to its design as a high mileage/high idle time engine as well as its serviceability. Dennis also recommended a 5<sup>th</sup> generation Allisson 6 speed 4000 EVS transmission. Both options will be included as priority items in the bid specifications.

As part of our work up to this point we established an anticipated timeline for this project. If approval is received to move forward with the bidding process, we anticipate sending out bid request on January 15<sup>th</sup> and conducting the bid opening on February 15<sup>th</sup>. We hope to be able to bring a recommendation to the commission in early March. With an anticipated build time of 12-14 months, we would be looking at delivery in early summer of 2022.
