## 9. Unfinished Business

## A. Downtown Public Art Agreement

### Staff: Andrew Kuk

At the July 27<sup>th</sup> City Commission meeting, the Commission approved a license agreement with Jamie and Sharon Crites for use of property to place a piece of public art downtown.

The Downtown Development Authority and Sturgis Area Community Foundation are collaborating to bring the piece of public art to downtown Sturgis commemorating the Foundation and its work in the community. The DDA worked with a local artist to commission a metal sculptured tree mounted to a large boulder; a plaque honoring the Sturgis Area Community Foundation and its members will be placed in front of the sculpture. The overall art piece will be approximately 7.5 feet tall.

In order to legally place the public art, Community Development staff worked with the DDA on how to properly approve the placement through zoning. They felt permitting it as a City sign would place the highest requirements on the sign and meet several conditions in the process. As such use of Mr. Crites' property for the piece needed to be controlled by the City.

Following discussion with the DDA and Foundation regarding ownership of the art piece, it was determined that the DDA would be the owner of the art piece and responsible for maintenance of the piece. As the piece will be on property under use of the City, an Public Artwork Services Agreement between the City and DDA outlines responsibility for the artwork.

Under the agreement the DDA will be responsible for monitoring the art any maintenance associated with the project, with the City's contribution allowing use of the property. The DDA would be required to hold the City harmless and maintain insurance on the piece where the City is additionally insured. A copy of this agreement is included in your packet.

## 10. New Business

## A. Franks Substation Maintenance Bids

## Staff: Chris McArthur

As part of the Electric Department's preventative maintenance program, it is recommended that all substation equipment is tested once every five years. It was decided to perform preventative maintenance on Franks Substation due to some issues discovered during routine inspections including the oil level gauge not working on Transformer #1 and a suspected oil leak between the Load Tap Changer (LTC) and transformer on Transformer #1.

City staff issued a bid for testing and maintenance services on the substation. The work included a comprehensive inspection, diagnosis of the oil leak, and repair of the gauge using parts supplied by the City. The low bid for the project was from Premier Power Maintenance of Brighton, Michigan in the amount of \$24,292.26.

In addition to the bid as-read, staff is recommending approval of a not-to-exceed budget of \$26,000.00 for the project. This covers the cost for needed internal wear parts for the LTC at an estimated cost of \$15,000.00, and the repairs for the oil leak at estimated at approximately \$11,000.00. Premier Power Maintenance would complete the oil leak repair after diagnosis on a time and materials basis.

The preventative maintenance for this project is budgeted as part of the repair and maintenance line item of the Electric Department's FY 2021-22 substation budget.

## **Proposed Motion:**

Move that the Sturgis City Commission APPROVE/DENY the bid from Premier Power Maintenance for testing services for the Franks Substation in the amount of twenty-four thousand, two hundred and ninety-two dollars and twenty-six cents (\$24,292.26) and APPROVE/DENY a budget for parts and repairs for the project in an amount not-to-exceed twenty-six thousand dollars (\$26,000.00).

## **10.** New Business

## B. MPPA 2023-2025 Clean Energy Program

## Staff: Chris McArthur

State of Michigan Public Act 342 of 2016 (PA 342) required all electric utilities, including municipal utilities, to offer Energy Waste Reduction (EWR) programs to their ratepayers, hire an independent evaluation company to validate the programs and report on the programs to the State of Michigan. Sturgis, through the Michigan Public Power Association (MPPA) contracted with Franklin Energy to manage this program for the City.

The goal of PA 342 was to help electric customers save energy by offering incentives to use more energy efficient devices and remove older energy wasteful devices from the system.

Following the sunset of PA 342 at the end of 2021, MPPA partnered with Franklin Energy to develop and implement the 2022 Clean Energy Program. This program mimics PA 342 in many respects, but participation is optional and there is no mandatory reporting to the State. However, most MPPA members are voluntarily reporting to the State as requested by the Michigan Public Service Commission. Members of the 2022 Program requested that past EWR programs continue to be offered while also adding custom programs in the LED street lighting and Electric Vehicle spaces. Last December the Sturgis City Commission approved participation in the 2022 MPPA Clean Energy Program, which was contracted for one year.

Seven months in, Franklin Energy has exceeded year-to-date kWh savings goals and has increased their level of local community involvement for participating MPPA members relative to previous years. MPPA is now planning to enter into a new Clean Energy Program agreement with Franklin Energy for a three-year period (2023-2025) and is requesting interest from members on their plans to participate. Included in your packet is information on the program from the MPPA, along with a timeline for the 2023-2025 program. At this point the MPPA is only soliciting interest in the program; a formal agreement to join the program would be presented to the Commission later in the year.

Currently, staff has budgeted \$332,290.00 in the FY 2022-23 Electric Department General & Administration budget for an EWR program like the MPPA Clean Energy Program. This amount includes both the cost to participate in the MPPA program and receive the associated program administration by Franklin Energy, but also the cost to reimburse customers taking advantage of the rebates offered as part of the program.

This expense is balanced against budgeted revenue from an energy waste reduction surcharge included as part of the City's electric rates for FY 2022-23. Staff has budgeted \$198,000.00 in revenue from this surcharge. This surcharge dates back to the implementation of PA 342 and was reduced to the current level back in 2018 as part of a spend-down of EWR resources. Staff is recommending maintaining surcharges at current levels.

#### 8C. Golf Cart Ordinance Amendment Second Reading

CONSIDER this the second reading of and APPROVE an amendment to the City Code of Ordinances, section 58-164 pertaining to registration of golf carts, effective September 1st, 2022.

#### AMENDMENT TO THE CITY CODE OF ORDINANCES PERTAINING TO REGISTRATION OF GOLF CARTS

An Ordinance to amend Chapter 58 – Traffic and Vehicles, Article V. – Golf Carts, Section 58-164. – Registration of the Ordinances of the City of Sturgis pertaining to registration of golf carts and to provide for an effective date of this Ordinance.

WHEREAS, the City Commission has determined that it is in the best interest of the residents

of the City to modify Section 58-164 regarding the registration of golf carts.

NOW, THEREFORE, the City of Sturgis, St. Joseph County, Michigan ordains:

Chapter 58 – Traffic and Vehicles, Article V. – Golf Carts, Section 58-164. – Registration of the Ordinances of the City of Sturgis is hereby modified as follows effective September 1, 2022:

#### Sec. 58-164. - Registration.

- (A) A golf cart operated on a city street under this article is not required to be registered under the Michigan Vehicle Code for purposes of MCL 500.3101.
- (B) All golf carts intended for street use shall be registered with the Sturgis Police Department by the owner(s) or operator(s) of those golf carts shall register such golf carts prior to operating the same on any city street.
- (C) To be registered, all golf carts must be inspected for and meet the requirements of section 58-163.
- (D) A registration plate and sticker shall be provided by the Sturgis Police Department. The registration plate and sticker must be affixed in plain view on the rear of the golf cart at all times it is operated on city streets. A one-time registration fee, as set by the City Commission, shall be paid prior to obtaining a registration plate and sticker.

#### 8D. B-N Zoning Ordinance Amendment Second Reading

CONSIDER this the second reading of and APPROVE an amendment to the City Code of Ordinances, Appendix A – Zoning, Section 1.0409.1 - B-N – Business Neighborhood, effective September 1st, 2022.

#### AMENDMENT TO BUSINESS NEIGHBORHOOD (B-N) DISTRICT

An Ordinance to amend Appendix A - Zoning, Section 1.0409.1 - B-N - BusinessNeighborhood of the Ordinances of the City of Sturgis pertaining to the Business Neighborhood District (B-N) and provide for an effective date of this Ordinance.

WHEREAS, the City Commission, upon recommendation from the Planning Board, has determined that it is in the best interest of the residents of the City to modify Section 1.0409 adding additional language.

NOW, THEREFORE, the City of Sturgis, St. Joseph County, Michigan ordains:

Appendix A - Zoning, Section 1.0409.1 – B-N – Business Neighborhood of the Ordinances of the City of Sturgis is hereby modified as follows effective September 1, 2022:

#### 1.0409.1. - B-N – Business Neighborhood

•••

- 1) Compatibility with adjacent properties. The following conditions shall apply to approved non-residential uses in the B-N district when those uses are adjacent to residential uses or residentially zoned property:
  - a. Rear and side setbacks from residential property lot lines shall be 45 feet. Where an existing non-residential use is located less than 45 feet from a residential property line, such structure shall be considered a Class A non-conforming structure as described in 1.0802-1.0804 of this zoning ordinance, and the principal building may be expanded or accessory buildings may be added under the following conditions:
    - i. The proposed expansion or addition receives required Site Plan Approval pursuant to Article XII of this ordinance.
    - ii. The degree of nonconformity is not increased.
    - iii. This Class A designation shall expire when the use changes. At that time, the new use would be required to request Class A non-conforming structure designation from the Planning Commission.
  - b. Screening of residential uses to restrict view from residential property shall be provided by a privacy fence six feet in height, or an obscuring planting strip 15 feet in width and six feet in height at planting. Planting strip must not exceed six feet in height. A request may be made to the Planning Commission to waive the screening requirement due to site constraints.
  - c. All exterior doors on the sides of buildings adjacent to residential property shall be for emergency exit only.
  - d. All shipping and deliveries to and from the establishment shall occur between the hours of 7:00 a.m. and 9:00 p.m.
  - e. All exterior lighting shall be directed along exterior building walls and away from residential property.
  - f. All outside storage of vehicles shall be screened from any adjacent residential property, and such storage shall occur only within areas secured by fencing.
- 2) Area and bulk requirements. See article V, schedule of regulations, of this zoning ordinance limiting the height and bulk of buildings, the minimum size of lot by permitted land use, and providing minimum yard setback requirement.
- 3) Design Standards. Requirements for approved design.
  - a. To the extent reasonably feasible, the building and site shall be consistent with the character with the character of the area (as defined in section 1.1301 this ordinance), including lot coverage, type and style of structure, traffic flow and pattern, and density/intensity of the use.
  - b. Architectural style is not restricted. Evaluation of appearance of a project shall be based on quality of its design and relationship to surroundings.
  - c. Materials shall:
    - i. have good architectural character
    - ii. be of durable quality
    - iii. be selected for harmony of the building with adjoining buildings.
  - d. Inappropriate materials and methods, and those which will produce inconsistency with the structure of the building, shall be avoided.
  - e. Building components, such as windows, doors, eaves, and parapets, shall have good proportions and relationship to one another.
  - f. Colors shall be harmonious, and not used to draw attention, e.g., serving as a sign.

- g. Mechanical equipment or other utility hardware on roof, ground, or buildings shall be screened from public view with materials harmonious with the building, or they shall be located so as not to be visible from any public ways.
- h. Exterior lighting, including external and interior lighted signs, shall be part of the architectural concept. Fixtures, standards, and all exposed accessories shall be harmonious with building design.
- i. Refuse and waste removal areas, service yards, storage yards, and exterior work areas shall be screened from view from public ways, using materials as stated in criteria for equipment screening.
- j. If the building official cannot determine whether the project meets the standards, the building official shall refer the project to the design review committee for its determination and recommendation to the planning board.

Community Development Director Will Prichard provided details regarding a request from C3 Industries, LLC for a zoning district change for the property located at 2770 S. Discussion followed regarding the intended use of the property, the marihuana ordinance limiting the number of retail licenses in the BH1 district, and other items.

Cass Root, Constantine Products, explained that he does not support the rezoning.

Landon Bartley, representing the prospective buyer of the parcel, explained that it is a request for rezoning to manufacturing in addition to other details on the property and proposed use.

A letter was read from Kara Falkenstein in opposition to the rezoning.

#### PUBLIC ARTWORK SERVICES AGREEMENT

THIS PUBLIC ARTWORK SERVICES AGREEMENT is entered into as of this \_\_\_\_\_ day of \_\_\_\_\_, 2022, by and between:

- The City of Sturgis, a Michigan municipal corporation, with offices at 130 N. Nottawa, Sturgis, Michigan 49091 (the "City"); and
- The Sturgis Downtown Development Corporation, an authority established under Act 57 of the Michigan Public Acts of 2018, as amended ("Act 57"), with offices at 306 W. Chicago Rd., Sturgis, Michigan 49091 (the "DDA"); and

with reference to the following:

- A. The DDA has decided to incorporate works of art into the downtown, including an artwork commissioned by the DDA as detailed in Exhibit A of this Agreement (the "Public Art Project") that the DDA wishes to place at 301 W. Chicago Rd.;
- B. The City has entered into a License Agreement with Jamie Crites and Sharon Crites (the "License Agreement") for the use of a portion of their property at 301 W. Chicago Rd. (the "Property") for placement of the Public Art Project, with a copy of the License Agreement being incorporated as Exhibit B of this Agreement;
- C. The City has applied for an been granted a permit for a public sign by the Sturgis Planning Commission on June 21, 2022 which will allow placement of the Public Art Project on the Property; and
- D. The parties wish to memorialize their understandings about the Project in a binding contract.

NOW, THEREFORE, in consideration of the mutual covenants set forth in this Agreement, the parties agree as follows:

#### **ARTICLE I: GENERAL OBLIGATIONS**

1.1 <u>City's Obligations</u>. The City shall provide to the DDA use of the Property for placement of the Public Art Project.

- 1.2 <u>DDA's Obligations</u>. The DDA shall:
  - (a) Hold ownership of the Public Art Project.

- (b) Be responsible for the placement of the Public Art Project on the Property as per the approval of the Planning Commission.
- (c) Monitor the Public Art Project to ensure that it is properly maintained and in conformity with any laws or regulations regarding its maintenance, placement, or other similar conditions.
- (d) Be responsible for all maintenance, repair, restoration, movement or removal of the Public Art Project as per the terms of this Agreement.

#### **ARTICLE II: USE OF PROPERTY**

2.1 <u>Use of the Property</u>. The City authorizes placement of the Public Art Project on the Property by the DDA. Such use shall be in conformity with the License Agreement, Planning Commission approval, and any applicable laws or regulations regarding the maintenance, placement, or other similar conditions of the Public Art Project and the Property. If the City determines that these conditions are not being met, they can require the DDA to meet these conditions with written notice.

2.2 <u>Removal of the Project</u>. At any time the City may require removal of the Public Art Project by the DDA from the Property with written notice. The DDA shall have a period of forty-five (45) days to remove the Public Art Project and restore the property as per this Article. The City may extend this period at their discretion.

2.3 <u>Restoration of the Property.</u> If at any time the Public Art Project is moved or removed, or there is otherwise damage to the Property, the DDA shall restore the Property to the condition it was in prior to placement or to a like condition that is acceptable to the City and meets the conditions of the License Agreement.

2.4 <u>Ability to Require Conditions be Met</u>. If the DDA fails to meet any of the conditions under this Article following proper notice, the City may cause these conditions to be met. Any costs incurred by the City resulting from actions to meet these requirements will be reimbursed by the DDA.

#### **ARTICLE III: MISCELLANEOUS**

3.1 <u>Indemnification of Parties by DDA</u>. The DDA shall defend, release, indemnify, and save and hold harmless the City from any and all claims, demands, suits, liabilities, actions, causes of action, or legal or equitable proceedings of any kind or nature, caused by the Public Art Project.

3.2 <u>Maintenance of Insurance</u>. The DDA shall hold liability insurance on the Public Art Project in an amount acceptable to the City while the Public Art Project is located on the Property. The City and owners under the License Agreement shall be included as additionally insured under the policy.

3.2 <u>Sale or Donation of the Public Art Project</u>. If the DDA decides to donate or sell the Public Art Project, the donee or buyer of the Project will assume all of the duties and expenses of the DDA under this Agreement. The donee or buyer shall be given a copy of this executed Agreement at the time of the donation or sale. The DDA will notify the City of such donation and sale and of the identity of the donee or buyer.

3.3 <u>Assignment</u>. This Agreement may not be assigned by any of the parties without the prior written consent of all of the other parties, which shall not be unreasonably withheld.

3.4 <u>Amendment</u>. This Agreement contains the entire understanding and agreement of the parties as to the subject matter hereof and may be amended only by written agreement of all parties.

3.5 <u>Notices</u>. Any notice, request, or other communication given under this Agreement to any party must be in writing and will be deemed given either when delivered personally or by express courier or by registered or certified U.S. mail or by email (with return email confirming receipt) to such party at the address set forth below, unless the receiving party has designated in writing a different address by providing notice in compliance with this Section:

If to the DDA:

City of Sturgis Downtown Development Corporation 130 N. Nottawa Sturgis, Michigan 49091 Attention: Andrew Kuk akuk@sturgismi.gov

3.6 <u>Waiver</u>. No delay on the part of any party hereto in the exercise of any right or remedy shall operate as a waiver of such right or any other right; a waiver on any one occasion

shall not be construed as a bar to or waiver of any subsequent breach of the same or any other provision of this Agreement on a future occasion.

3.7 <u>Enforceability</u>. This Agreement shall be enforceable only by the parties hereto and no other person shall have the right to enforce any provision contained herein.

3.8 <u>Severability</u>. In case any one or more of the provisions contained in this Agreement or any document, instrument, or agreement required hereunder should be declared invalid, illegal, or unenforceable in any respect, the validity, legality and enforceability of the remaining provisions contained herein or therein will not be affected or impaired in any way.

3.9 <u>Governing Law</u>. This Agreement and the rights and obligations of the parties under this Agreement is to be governed by, and construed and interpreted in accordance with, the laws of the State of Michigan.

3.10 <u>Recording of Agreement</u>. This Agreement may be recorded with the St. Joseph County Register of Deeds at the election of any Party.

3.11 <u>Counterparts</u>. This Agreement may be executed in any number of counterparts, each of which, when so executed and delivered, will be deemed to be an original, but all such counterparts taken together constitute but one and the same agreement.

The parties have executed this Agreement as of the date set forth above.

MMEA Membership,

Following the sunset of PA342 on 12/31/21, MPPA partnered with Franklin Energy to develop and implement the 2022 Clean Energy Program ("Program"). <u>This year's voluntary Program participation level and budget has remarkably</u> <u>surpassed all previous PA342 mandated Energy Waste Reduction ("EWR") program offerings (offered for the past 10+ years).</u>

Members of the 2022 Program requested that (most) past EWR programs continue to be offered while also adding custom programs in the LED street lighting and Electric Vehicle (EV) spaces. Seven months in, Franklin Energy has exceeded year-to-date kWh savings goals and has increased their level of local community involvement for Members relative to previous years – doing so at industry-wide competitive pricing.

Looking to the future, MPPA is strongly encouraging both current 2022 Program Members and all non-Members to join MPPA's 2023 - 2025 Clean Energy Program, which will be implemented by Franklin Energy.

In order to achieve a successful transition into the 2023 Clean Energy Program, a timeline (enclosed) of key milestones must be achieved.
