A. Sidewalk Repair on Main Street Public Hearing

OPEN PUBLIC HEARING

The City of Sturgis Engineering Department is initiating a Sidewalk Repair Special Assessment District in accordance with the Public Sidewalk Construction Policy approved by the City Commission in 2011. The district is being considered in conjunction with the reconstruction of W. Main and E. Main Streets between N. Clay Street and George Street. The intent of the assessment district is to repair existing sidewalk segments along both sides of West and East Main Street within the project boundaries. Attached is the preliminary Special Assessment district including the property tax ID number, owner, address, and estimated assessment amount.

A letter has been sent to each property owner listed in the preliminary assessment district notifying them of the public hearing date and estimated assessment cost. If approved, a form will be prepared listing each property tax ID number, owner, address, and estimated assessment amount. The form will be recorded at the St. Joseph County Register of Deeds so a title search on a prospective sale will indicate the special assessment information.

B. Storm Sewer Cleaning/Video Bids

Staff: Barry Cox

Prior to 2019, the City had not done significant storm sewer system cleaning for several years. Proper drainage of any road network is the most important element in maintaining the road network condition, and the storm sewer system is an important part of this effort. In order to improve the system's ability to accept stormwater runoff, the City begin a program of cleaning all storm sewer structures, catch basin leads, and storm sewer mains 15 inches in diameter and smaller starting in 2019. This program began with work in Ward 4 and storm sewer cleaning and televising of 18 inch and smaller pipes occurred in 2021 in Ward 3. A map of the wards is included in your packet.

Working with Fleis and Vandenbrink Engineering, Inc., bidding documents were developed to complete the cleaning and televising of larger diameter pipes in Ward 3 (greater than 18 inch) and Ward 4 (greater than 15 inch). The project was advertised for bids in early February. Bids were received on February 26th. Nine bids were received ranging in cost from \$60,210.00 to \$464,675.00. Five bids were below the Engineer's Estimate of \$98,938.00. The low bid was from M&K Jetting & Televising, LLC in the amount of \$60,210.00. A Recommendation of Award letter from Fleis & VandenBrink Engineering, Inc. for the low bidder is included in your packet.

The Fiscal Year 2023-24 budget has \$200,000.00 allocated for the project; \$100,000.00 each from the Major and Local Street funds. Given the highly variable nature of storm sewer cleaning needs, staff is recommending a contingency budget of \$6,000.00, approximately 10% of the bid for the project.

C. Parking Lot #6 Improvement Bids

Staff: Andrew Kuk

The City has been working over several years to complete improvement to downtown parking lots and has budgeted for work to be completed in 2024. resolved to repair multiple downtown parking lots in 2024. The City received two large sources of funding to move forward with this project. One, a federal earmark for \$1 million dollars and two, a \$942,500.00 RAP Grant through the State of Michigan.

As part of these grant funds, the City will be looking to complete work on a number of downtown parking lots including lots 2, 4 (including pavement of the old Sigrist storage building lot), 6, 7, the public safety building lot, and a new parking lot designated parking lot 12 at the empty lot at the corner of N. Jefferson and US-12. A parking lot map is included in your packet.

Design of Parking Lot #6 was prioritized in order to get the project out for bid over the winter and begin construction close to the completion of The Watershed project occurring in that same block. The remaining parking lots in the project will be bid out next month. Work in Lot #6 includes reconstruction of the lot itself, improvements to the alley walking area adjacent to businesses, and associated non-electric utility work.

Construction of Parking Lot #6 was advertised for bids on January 26, 2024. Bids were received on March 4th. Three bids were received for the project. The bid tabulation is included in your packet. A low bid of \$644,490.75 was submitted by Swarthout Excavating. The Engineer's Estimate for the project was \$741,900.00.

Neither Fleis and Vandenbrink Engineering, Inc. or the City has previous experience with Swarthout Excavating. F&V completed a post-bid interview to ascertain Swarthout's understanding of the project and their capability to complete the project. A letter of award recommendation has been received from

Fleis and Vandenbrink Engineering stating they believe Swarthout has the capability and capacity to complete the project.

The Fiscal Year 2023-24 budget has allocated \$2.6 million in Capital funds for the entire downtown parking lot project. A project and cost spreadsheet is included in your packet.

A contingency budget of \$64,000.00 (approximately 10% of the bid) is being recommended for the project. A construction engineering task order will be brought to the City Commission at the April 10th meeting.

Proposed Motion:

Move that the Sturgis City Commission APPROVE/DENY the bid from Swarthout Excavating for Parking Lot #6 Improvements in the amount of six hundred forty-four thousand, four hundred, and ninety dollars and seventy-five cents (\$644,490.75) and AUTHORIZE the City Manager to sign all necessary documents on behalf of the City.



RESOLUTION APPROVING AMENDMENTS TO DEVELOPMENT PLAN AND TAX INCREMENT FINANCING PLAN FOR THE LOCAL DEVELOPMENT FINANCE AUTHORITY OF THE CITY OF STURGIS

WHEREAS, the Recodified Tax Increment Financing Act, Act 57 of the Public Acts of Michigan of 2018, Document 57-2018-4. (collectively, the "Act") authorizes the City to establish and amend the Local Development Finance Authority of the City of Sturgis (LDFA); and

WHEREAS, the LDFA was established in 2008 and previously amended in 2018; and

WHEREAS, the LDFA is amending its boundaries, Development Plan, and Tax Increment Financing (TIF) Plan to include the two parcels at Stateline Business Park for the benefit of the eligible properties within the Authority District; and

WHEREAS, on December 13, 2023, the City Commission held a public hearing on the Plan Amendments pursuant to Act 57, Public Acts of Michigan, 2018, as amended; and,

WHEREAS, the City Commission has given the taxing jurisdictions in which the District is located an opportunity to meet with the City Commission and to express their views and recommendations regarding the Plan Amendments, as required by the Act; and

WHEREAS, the LDFA Board has recommend for approval the amendments to the District boundaries, Development Plan and TIF Plan attached here as Exhibit A (the "Plan Amendments").

NOW THEREFORE BE IT RESOLVED, the Sturgis City Commission approves amendments to the LDFA District Boundaries, LDFA Development Plan, and LDFA TIF Plan as presented.
