### 8C. 2024 Memorial Day Parade

The local VFW and American Legion are requesting use of South Nottawa Street for the Memorial Day Parade. The route will run from the VFW post on Fawn River Road north on South Nottawa Street to Oak Lawn Cemetery. They request that barricades be dropped off for the parade by DPS at intersections along the route, specifically South Street and E. Fawn River Rd. The groups will provide road guards to set up and take down barricades for the parade. They are also requesting a police escort for the parade. The route is the same one approved by the Commission in past years. They are requesting a greeting from the Mayor at 10:00 a.m. and the parade will start at the VFW at 10:30 a.m. on Memorial Day (May 27<sup>th</sup>).

The VFW and American Legion are also requesting the use of Oaklawn Park during the event, as well as setup and use of the sound system, and waiver of fees for these activities.

### 9. Unfinished Business

### A. Urban Chicken Ballot Language

### Staff: William Prichard

Dating back to 2011, both the City Commission and Planning Commission have periodically engaged in discussion regarding the potential for allowing urban chickens within the City limits. Over the past year, these discussions have reengaged, with the Planning Commission, at City Commission request, reviewing and offering proposed language for an urban chicken ordinance and associated amendments.

This process included several opportunities for public input, as well as a public hearing on the issue at the Planning Commission. While the Planning Commission ultimately did not recommend to the Commission allowing urban chickens, they did have consensus that if the City Commission were to move forward with an urban chicken ordinance, they would strongly recommend it to be placed on a future ballot for a vote of the people.

Final ordinance language and associated ordinance amendment proposals were brought to the City Commission at the February 14, 2024 Commission meeting. Commissioners requested this information be brought back to a future meeting for discussion along with the recommended process to place the issue on the ballot.

Included in your packet are copies of the proposed ordinance language, amendments to the zoning ordinance, Fine Schedule, and Fee Schedule concerning urban chickens. Also included is proposed ballot language. The language provides a summary of the proposed City Code of Ordinance section 10.65 – Urban Chickens. This is the language that would appear on the ballot; it includes a reference to the entirety of section 10.65, which would be available for voter review both at City Hall and at the polling place during the election process.

This ballot language (and the associated section 10.65 language) needs to be reviewed and approved by the Commission prior to placement on the ballot. If approved for the ballot, the language in 10.65 would be the language that would

become law if approved by the voters. Any proposed changes to the language of 10.65 should be made prior to approval for inclusion on the ballot.

If the ballot proposal is successful and passes, staff would recommend that the City Commission approve amendments to the following ordinance sections:

- Amendments to City Code of Ordinances Section 10.64. Keeping of animals, fowl, etc. restricted
- Amendment to City Code of Ordinances Appendix A. Zoning Code Section 1.1105. – Accessory buildings, structures and uses relating to "Chicken Coops"
- Amendment to City Code of Ordinances Appendix A. Zoning Code Section 1.1401. – Building Permits; language to exempt separate permits for accessory structures and fences that are included as part of an urban chicken permit.
- Amendment to City Code of Ordinances Appendix B. Fine Schedule; adding fines related to the Urban Chickens

Red-lined copies of all the most recent proposed language amendments are included in your packet. Staff is recommending these changes be given first readings now, and if the ballot measure passes, they would be brought back to the Commission for a second reading and action.

Finally, included in your packet are also Addition of Urban Chickens to Fee Schedule. These changes do not require a first and second reading as they are not part of the code of ordinances; they would be considered for approval at the same time as the second reading of the ordinance amendments.

Since the language was last brought to the Commission, only one change has been made; to include language in the proposed section 10.65 allowing for the Commission to amend that section with a 2/3rds majority vote. Without this provision, the only way that section could be changed is by future referendum.

### 10. New Business

### A. Sturgis Fest 2024

Staff: Andrew Kuk

The Sturgis Area Chamber of Commerce will again hold Sturgis Fest on June 20<sup>th</sup> through the 24<sup>th</sup>. As in the past, the Chamber and other event organizers are requesting City assistance and participation for the festival. This includes road closures and the use of City staff and facilities. A detailed list of requests for the week is included in your packet.

The major requests for the use of City services are associated with Wednesday, Thursday, and Friday, June 19<sup>th</sup>-21<sup>st</sup>. Wednesday will be Family Night again this year, however activities will be taking place at Sturgis High School, limiting City support to supplying barricades. Activities there will again include carnival rides, the Sturgis Biscuits baseball game, and an outdoor movie. Also on Wednesday will be a new event, a "Gran Bilae" for adults will take place at Free Church Park featuring music and dancing from the Hispanic community as well as food and beer/wine; this is in place of the Wine Night that has occurred in the past. Thursday will again be Bike Night and Friday will be the car show and the now-traditional night parade.

Other festival activities will include the Sturgis Fest Dinner on Tuesday and a 3-on-3 Basketball Tournament on Saturday. Fireworks will be held at Kirsch Municipal Airport on Saturday night.

The Chamber is requesting closure of US-12 (Chicago Road) on Thursday and Friday which will be contingent upon approval from the Michigan Department of Transportation. Alcohol sales will take place on Wednesday and Thursday at Free Church Park; this will be subject to Michigan Liquor Control Commission licensing and regulation, including perimeter fencing. The North Street and Pleasant St. Sub-Areas of the Downtown Social District would be active on Friday as part of those road closures.

### B. Main Street Bids & Construction Engineering Task Order

### **Staff: Barry Cox**

On Monday, April 8, 2024 the City opened bids for the Main Street Utility & Street Improvements project. The project boundaries run along Main Street, between N. Clay and George Street.

Work on this area of the utility system is necessary due to noted sanitary sewer capacity needs. The City's Asset Management Plan (AMP), as well as other studies and capacity surveys indicated the current sanitary sewer size along W. Main and E. Main was near or at capacity with expansion necessary. The Main Street project, as designed, is a utility/street improvement project; it alleviates the sanitary sewer capacity issues in this area of the collection system and also includes replacement of lead water services within the project limits, abandonment of undersized water main, and replacement and consolidation of storm sewer infrastructure.

The bid summary and letter of recommendation for award are included in your packet. One bid was received. The bidder was Concord Excavating and Grading, Inc. from Concord, Michigan in the amount of \$2,218,182.36. The Engineer's Estimate of probable cost was \$1,793,000.00.

The project was budgeted for this fiscal year from three funds; Wastewater, Water, and the Street & Sidewalk Improvement Fund. The approximate split is 57.5% from the Wastewater Fund, 11.1% from the Water Fund, and 31.4% from the Street and Sidewalk Improvement Fund. A budget and costs spreadsheet is included in your packet.

In addition to the construction costs, staff is recommending a contingency budget of \$222,000.00 (approximately 10% of the construction costs) for the project, as well as construction engineering expenses.

Included in your packet is Task Order 11b for construction phase engineering services for the project. As outlined in the task order, Fleis and Vandenbrink, Inc. will provide an onsite resident project representative during construction, schedule progress meetings, prepare contractor pay estimates and any contract modifications, maintain project files, provide recordkeeping of construction activities, and address resident complaints during construction, and coordinate scheduling materials testing with a contracted third-party company. Cost for these services is \$234,000.00.

As shown in the budget and costs spreadsheet, the Water Fund portion of the project is on budget. The Wastewater Fund is \$612,654.86 over budget and the Street and Sidewalk Improvement Fund (which includes storm sewer work) is just under \$400,000.00 over budget. Staff plans to cover these budget overages with funds from already-budgeted projects not projected to be completed.

In the Wastewater Fund, \$2,000,000.00 was budgeted for an "alternative BIOSOLIDS Strategy"; this was for possible land acquisition. At this point staff has indicated this will not happen in this fiscal year and that future evaluation of needs will be considered next year. Funds for the Wastewater project overage will be drawn from this project.

In the Street & Sidewalk Improvement Fund, \$1,242,461.00 was budgeted for St. Joseph Street replacement work. This project was budgeted contingent upon low interest loan funding being available for utility work associated with the project. Since loan funds were not granted, this project will not be occurring this fiscal year and budgeted dollars from the Street & Sidewalk Improvement fund will be used to cover the overage for the Main Street Project.

It was noted within Concord Excavating's bid they are projected to use a concrete subcontractor City staff has had previous experience with on the 2021 Small Urban project along Vinewood Avenue & E. Congress Street. The experience was not positive. In discussions with Concord, they received a bid from a second concrete subcontractor City staff has had a positive experience with on the 2023 Street Rehabilitation project. While it is possible to request use of the alternate subcontractor, the estimated cost increase to the project would be about

\$50,000.00. The majority of that amount coming from the Street & Sidewalk Improvement Fund. Quality of finish work, timeliness of work, and ability to work with the contractor are three reasons staff is requesting City Commission to consider this option.

### C. Transfer of Properties from Fawn River Township Agreement #3

### **Staff: Barry Cox**

In 1999, the City of Sturgis and the Township of Fawn River approved an agreement titled "Agreement for Conditional Transfer of Property from Fawn River Township to the City of Sturgis (Agreement #3)". The Agreement covered properties in the Southwest Quarter of Section 7 of Fawn River Township. The Effective Date of the Agreement was 12:01 AM on March 15, 1999.

Per the agreement, at the end of 25 years from the Effective Date of the Agreement (March 15, 1999):

"...all parcels in the Term Area which have not transferred to the City for full jurisdiction by the end of the Term as provided in Article IV shall be transferred at such time to the City's jurisdiction for all purposes in accordance with Section 4.2."

Since this threshold has been obtained, all remaining parcels subject to the agreement are set to be transferred. Included in your packet are Exhibit A and Exhibit B which describe and provide a map of the property to be transferred. The area includes five parcels, all of which are currently farmland.

Attached is a resolution which the City Commission may adopt, completing that process. The sequence is as outlined below.

Step 1: The City Commission adopts the resolution.

Step 2: The resolution is filed with the Office of the Great Seal and the St. Joseph County Clerk.

### D. Dog Running at Large Ordinance Review

### Staff: Andrew Kuk

At the March 11<sup>th</sup> City Commission meeting, the Commission discussed potential changes to the City's ordinance relating to dogs running at large to require more control of dogs on private property. There was consensus to bring the issue back at a future meeting after staff had a chance to review the topic.

Included in your packet is a spreadsheet reviewing pertinent sections of ordinances from nearby cities related to dogs running at large. While many of the nearby cities have similar language to our current ordinance regarding a dog on the property of its owner not being considered at large, there were some differences in language that could improve our current ordinance.

Included in your packet is redlined version of Chapter 10 - Animals of the City Code of Ordinances, sections 10-1 through 10-31. This redlined version includes language proposed by staff to address greater requirements on dogs on private property, requiring they be located in a house, in a legally fenced area, or be securely tethered on that property in order to not be considered "at large".

Additional amendments proposed by the language include adding two conditions of when a dog is not at large: first, if the dog is within a motor vehicle and second, if it is within a space designated by the City as an "off leash area" (i.e. a dog park). These provisions were identified in the ordinance review as being sensible additions if the Commission wishes to move forward with changes to this ordinance.

Should the City of Sturgis change (Amend) the City Code of Ordinances Chapter 10 – Animals, Article III - Livestock and Fowl to provide as follows?

To allow for the keeping, regulating, permitting of up to 6 female chickens within the R-1, R-2, R-3, R-4 zoning districts where the principal use is for single residential use only, subject to all private covenants and restrictions of record. The keeping of chickens shall comply with all regulation to include but not limited to the following restrictions: No roosters, crowing hens or guinea chickens; All chickens must remain fully cooped in an enclosed area to be maintained in the rear yard and subject to property line setbacks and minimum distancing from neighboring residences. Any future amendments to this ordinance may be made by a 2/3rds vote of the City Commission.

City Code of Ordinance Chapter 10 – Animals, Article III. – Livestock and Fowl

. . .

Sec. 10-64. - Keeping of animals, fowl, etc. restricted.

No horse, cow, calf, swine, sheep, goat, geese, ducks, donkeys, fowl unless permitted by section 10-65, or pigeons shall be kept in any dwelling or part thereof. No such animals or fowl shall under any circumstances be kept on the same lot or premises with a dwelling unless they are maintained in connection with the operation of a bona fide farm. Notwithstanding the foregoing, it shall be permissible to own, keep, or harbor not more than two adult rabbits per household, together with not more than eight young rabbits until they attain the age of four months. The keeping of chickens shall be permitted with a valid permit issued by the City of Sturgis as per section 10-65.

### Section 10-65. – Urban Chickens

- (a) No person shall keep chickens unless they obtain an urban chicken permit and comply with all City ordinances. No permit will be issued unless the following has been completed:
  - (1) Urban chicken permit application has been submitted.
  - (2) All fees have been paid.
  - (3) An inspection of property has been completed to verify compliance with the ordinance.
- (b) Permit applications shall be submitted to the Community Development Department on a form provided by the City for review and approval. The application must be completed with all information requested. The following additional items shall be included with your permit application:
  - (1) A sketch plan which indicates the location of any chicken coop, chicken runs, and fencing (including height and style) as well as setbacks from all property lines and structures on same property and adjoining residential structures.
  - (2) Inspections will be conducted after the permit application has been reviewed and all fees have been paid. Application will not be approved, and permit will not be issued until property is found to be in compliance with City ordinances. The first inspection is included with the cost of the permit application fee. Any additional inspections to verify compliance will require an additional inspection fee to be paid prior to scheduling of the inspection.
- (c) The applicant's first (initial) urban chicken permit is valid until June 1 of the following year. If a person wishes to continue keeping chickens, they shall obtain a new permit before their current permit expires. Renewal permits are valid for two (2) years with all permits expiring on June 1.

Renewal permit applications shall be submitted a minimum of 30 days prior to the expiration of the permit. Inspections shall be completed and approved prior to the issuance of the renewal permit. Application for a renewal permit shall be pursuant to the procedures and requirements that are applicable at the time the person applies.

- (1) No permit shall be issued without the written authorization from the owner of the property consenting to the application and the keeping of urban chickens.
- (2) Permits are not transferrable to another applicant. When an applicant vacates a property, the permit is revoked and all structures, including chicken coop and enclosures, that were permitted as part of the permitting process must be removed.
- (d) The keeping of chickens is permitted only on a lot where the principal use is a single-family dwelling in the following zoning districts: R-1, R-2, R-3, R-4. No multi-family dwelling(s), multiple single-family dwellings on a single lot, duplex, or apartment(s) shall be permitted urban chickens.
- (e) Notwithstanding the issuance of a permit by the City, private restrictions on the use of property shall remain enforceable and take precedence over a permit. Private restrictions include but are not limited to deed restrictions, condominium master deed restrictions, restrictive covenants for the neighborhood, neighborhood association by-laws, and covenant deeds. A permit issued to a person whose property is subject to private restrictions that prohibit the keeping of chickens is void. The interpretation and enforcement of the private restriction is the sole responsibility of the private parties involved.
- (f) A person who has received a permit for urban chickens on their property shall comply with all of the following requirements:
  - (1) Maintain a valid permit as required under this section.
  - (2) Keep no more than six (6) female chickens per property.
  - (3) All chickens shall have a City-issued identification band on their leg. Leg bands will be provided by the City of Sturgis when the permit is issued. Renewal permits will not require new bands. Replacement bands can be obtained for a fee from the City of Sturgis.
  - (4) The principal use of the applicant's property is a single-family dwelling.
  - (5) No person shall keep any rooster, crowing hens, or guinea chickens.
  - (6) No person shall slaughter any chickens in public view.
  - (7) Chickens shall be always provided and remain within a fully enclosed coop and/or fenced enclosure with a top and/or cover.

- (8) The coop shall be a single structure not to exceed sixty (60) square feet in area and eight (8) feet in height. The minimum run size per chicken shall be eight (8) square feet with a maximum area of 300 square feet. The coop shall meet the standards for accessory structures (section 1.1105 of the zoning ordinance) and the enclosure shall meet the standards for fences (section 1.1106 of the zoning ordinance).
- (9) The use of corrugated metal/fiberglass, sheet metal, plastic tarps, scrap lumber or similar materials not in keeping with the appearance of other accessory buildings in the immediate area of the property as determined by the Zoning Administrator is prohibited.
- (10) The coop and enclosure may be movable only if the dimensional/setback restrictions required in this section are maintained.
- (11) A person shall not keep chickens in any location on the property other than in the rear yard.
- (12) The coop or enclosure shall not be located closer than forty (40) feet to the nearest residence on an abutting lot. For the purpose of this section, "residence" shall be defined to include both the principal structure and any decks, porches, sunrooms, or similar areas attached to the principal structure. This requirement shall be met at the time of initial permit issuance and is not meant to be retroactively applied in the event a residence on an abutting lot constructs an addition of some type that encroaches upon an existing chicken coop or enclosure.
- (13) No coop or enclosure shall be located closer than ten (10) feet to any property line of an abutting lot.
- (14) No coop or enclosure shall be located closer than ten (10) feet to the principal structure or three (3) feet an accessory structure on the same property.
- (15) Coops and enclosures must be clean, dry, odor-free and kept in a neat and sanitary condition and in compliance with all City ordinances.
- (16) All enclosures shall be constructed or repaired to prevent rats, mice, other rodents, or predators from being harbored underneath, within, or within the walls of the enclosure.
- (17) All feed and other items associated with the keeping of chickens shall be kept in a vermin and predator proof sealed container.
- (18) Waste materials (feed, manure, and litter) must be disposed of in an environmentally responsible manner. Piling waste materials on the property is not permitted. Litter must be kept dry.
- (19) If the above requirements are not complied with, the City may revoke any permit granted under this section and /or initiate prosecution for a civil

infraction violation.

# (g) Enforcement and penalties:

- (1) Any person who keeps chickens without a valid permit as required by this ordinance or who otherwise violates any of the provisions of this section shall be deemed guilty of a civil infraction and be issued a notice of violation. If the violation is not corrected within the timeframe referenced in this subsection, a citation may be issued and fine applied in accordance with the fine schedule of the City code of ordinances.
- (2) The City may revoke any permit granted under this section if any of the requirements of this section are not complied with.
- (3) A person who has been issued a notice of violation shall be given up to seven (7) days to correct the violation unless an extension has been granted by the zoning administrator.
- (4) A person who remains in violation after the timeframe for correction shall have their permit revoked and shall immediately discontinue the keeping of chickens at the permitted premise.

# (h) Amendments to this section:

(1) In adherence to the ballot proposal, any proposed amendments mandate a 2/3s majority vote from the City of Sturgis Commission.

(B) Accessory building or accessory structures in a residential district.

- (8) There shall be no more than two accessory buildings on any one parcel excluding play houses, dog houses, chicken coops not exceeding 30 square feet, pergolas or gazebos not exceeding 150 square feet, or buildings of similar uses.
- (10) Chicken coops shall not exceed eight (8) feet in height and sixty (60) square feet in area. Chicken coops shall be removed if a valid urban chicken permit as per section 10.65 of the City of Sturgis code of ordinances is not maintained.

No sign, parking area, fence, building, or other structure regulated by this zoning ordinance shall be erected, razed, moved, extended, enlarged, altered, or changed in use, and no exterior of any commercial building in the central business district shall be painted until a building permit has been issued by the building department, except the following:

- 1. Touch-up painting of the same color of any commercial building in the central business district.
- 2. Accessory structures and fences that are included as part of an urban chicken permit, section 10.65 of the City of Sturgis code of ordinances.





# Ordinance Review - Dogs Running at Large

Coldwater	No owner of any female dog shall permit that female dog to go beyond the premises of the owner when she is in heat, unless the female dog is held properly in leash, and no owner shall allow any dog to stray beyond his or her premises unless it is under the reasonable control of some person. For purposes of this chapter, a dog shall be deemed to be under "reasonable control" when the dog is on leash, in an enclosed vehicle or container, or with the owner, or some member of the owner's family, or some other person with the permission of the owner, provided the dog is amenable to orders and comments of the person in charge thereof.
Three Rivers	4-21.5 Dogs under Reasonable Control of Owner or Keeper.  (A) It is unlawful for any person who owns or keeps a dog to allow the dog to be upon the streets, alleys, or other places, public or private within the City, unless the dog is at all times, under reasonable control of its owner, keeper, or some member of the owner's family. Any person harboring, keeping, possessing, or in charge of a dog shall immediately collect and dispose of in a sanitary manner all excrement or droppings left by such dog on any public property or on any private property not owned or lawfully occupied by such person.
	(B) It is unlawful for the owner or keeper of any female dog to permit it to go beyond the premises of the owner or keeper when it is in heat unless the dog is held properly in leash.

## ARTICLE I. IN GENERAL

## Sec. 10-1. Penalty.

Unless provided otherwise by law or in this chapter, violations of this chapter are a municipal civil infraction. (Ord. of 2-28-2001, § 90.99; Ord. of 7-25-2001, § 4.09)

## Sec. 10-2. Notice to owner of dog or cat violation.

The chief of policePublic Safety Director or his designate may serve, or cause to be served, upon the owner or person harboring any dog or cat in violation of the provisions of this chapter a written notice, setting forth the time, date, place and circumstances of the violation and directing such owner or person harboring the dog or cat to comply with the provisions of this chapter.

### Sec. 10-3. Removal of defecation.

No owner or person having custody of any dog or other animal shall permit such dog or other animal to defecate on any school grounds, public street, alley, sidewalk, terrace, park, other public grounds or private property in the city, other than on the premises of such owner or person, unless such defecation is promptly removed.

# Sec. 10-31. Owner not to allow dog to run at large; impounding.

- (a) No person shall own, harbor, or keep a dog which runs at large at any time, beyond the limits of the lands owned or possessed by its owner, keeper, or harborer, or on the public streets, sidewalks, alleys, or on other public property.
- (b) For the purpose of this section, a dog shall not be considered to be running loose or at large whenever one of the following conditions are met:
  - 1. It is within the limits of the lands owned or possessed by its owner, keeper, or harborer or is on other private property with permission of that property's owner and is:
    - Inside a structure that the dog cannot freely exit; or
    - ii. Is in an outdoor area that is legally physically or electronically fenced in such a way that the dog cannot freely exit the area; or
    - ii. Is legally securely tethered outdoors by means of a leash, chain, cord, or rope such that the dog cannot go beyond the limits of those lands, including onto public sidewalk.

- 2.—it is under control at all times of any person by means of a leash, chain, cord, or rope of not more than six feet in length.
- 3. It is within a motor vehicle and secured in such a way that the dog cannot freely exit the vehicle.
- 4. It is within a public space designated by the City and identified by appropriate signage as an "off leash area" with rules and regulations of the area for the keeping of dogs posted.
- (c) Any dog found running at large may be impounded by any police officer and turned over to the county animal control officer for disposition as prescribed by the statutes of the state and policies adopted by the city and county.
