### **A. Public Hearing for Vinewood & E. Congress Sidewalk Repair**

#### **OPEN PUBLIC HEARING**

The City of Sturgis Engineering Department initiated Sidewalk Special Assessment District #2021-01 to repair sidewalks in conjunction with the Small Urban Street Improvement Project along Vinewood Avenue and E. Congress Street.

Special Assessment District #2021-01 was established by the City Commission at the February 24, 2021 City Commission meeting. The sidewalks have been repaired and the costs identified for the properties within Assessment District #2021-01. A letter has been sent to each property owner of the properties listed in the roll notifying them of the Public Hearing and the proposed final cost. The proposed final sidewalk assessment roll is included in your packet. The final cost was \$7.19 per square foot.

Also included in your packet is a summary spreadsheet identifying the estimated amount of work to be done and estimated cost provided to the property owner in 2021 as compared to the final amount of work done and cost. For all but two properties the final cost was below the estimated cost; for those properties where costs exceeded the estimate, staff is proposing to charge the owner the estimated amount. The difference to the City for both properties is \$230.04.

As has been past practice, staff is recommending that costs for the roll be spread over five years. Residents can choose to pay the cost up front, but if they choose to pay over the five-year timeframe, staff is recommending they be charged interest of five percent (5%) charged on the remaining balance on an annual basis.

### **B. Public Hearing for Vinewood & E. Congress New Sidewalk**

**Staff: Barry Cox**

#### **OPEN PUBLIC HEARING**

The City of Sturgis Engineering Department initiated Sidewalk Special Assessment District #2021-02 to build new sidewalks in conjunction with the Small Urban Street Improvement Project along Vinewood Avenue and E. Congress Street.

Special Assessment District #2021-02 was established by the City Commission at the February 24, 2021 City Commission meeting. The sidewalks have been installed and the costs identified for properties within the assessment district. A letter has been sent to each property owner of the properties listed in the roll notifying them of the Public Hearing and the proposed final cost. The proposed final sidewalk assessment roll is included in your packet. The final cost was \$7.31 per square foot.

Also included in your packet is a summary spreadsheet identifying the estimated amount of work to be done and estimated cost provided to the property owner in 2021 as compared to the final amount of work done and cost. For all but one property the final cost was below the estimated cost; for this property staff is proposing to charge the owner the estimated amount. The difference to the City is \$118.00. In addition, one property was originally estimated to have sidewalk work completed but ultimately did not.

As has been past practice, staff is recommending that costs for the roll be spread over five years. Residents can choose to pay the cost up front, but if they choose to pay over the five-year timeframe, staff is recommending they be charged interest of five percent (5%) charged on the remaining balance on an annual basis.

### **C. AEP 69kV Pole Line Bill of Sale**

**Staff: Chris McArthur**

As part of Indiana Michigan Power Company (I&M)'s system upgrade which moved the City of Sturgis' feeds to the new Stubey Road Substation, I&M is no longer in need of the Howe 69kV line that feeds into the Central Substation. This line runs from the state line to the Central Substation at the Diesel Plant near Jacob St.; a map is included in your packet identifying the route of the line and the pole locations along the line.

City staff has been working with I&M to assume this line and the associated easements that come with it. I&M has been open to this request as they would need to abandon and remove much of the line if they do not transfer it to the City. In some areas they would even need to maintain the line (without direct benefit to them) as our system still has active connections, including one of the 12kV feeders that connects to the solar field.

Assuming the line has value to the City as it will connect the new Stateline substation as part of the 69kV loop feeding other substations in town. This line also provides the City a solid trunkline for future electrical usage at the south end of town.

Included in your packet is a draft Bill of Sale from I&M to the City for the line. Consideration for the agreement from the City to I&M is \$1.00. As per the Bill of Sale, the City would assume responsibility for the line and poles "as is" and would bear all future maintenance of the line. The City also receives the rights to existing easements for the line, particularly where it runs on Meijer and Wal-Mart properties. This transfer is memorialized with an Assignment and Assumption of Easements agreement included in your packet.

### **D. Electric Department Staffing**

**Staff: Chris McArthur**

As discussed as part of the FY 2025-2026 budget, Electric Department staff has evaluated positions and have determined the need for a Technical Project Manager. This position will provide the Electric Department with the expertise in managing our many projects on the horizon. These projects include the construction of the new Stateline Substation project, battery storage project, addition of new generation assets, voltage upgrade, and many more. This position will also be able to utilize the new Milsoft software to complete system studies when new customers request service or when current customers request an upgrade.

The goal is for these tasks assigned to the Technical Project Manager to be completed in-house versus having to go to outside engineers as is the case currently. With outside engineers often sitting with full workloads, staff projects being able to bring tasks in-house will be both a cost- and time-savings in the long run.

As noted above, the draft FY 2025-2026 budget includes the addition of this position at a salary range of \$100,000.00-\$115,000.00. Staff is requesting the advertise and hire the position prior to the start of the FY 2025-2026 budget, with the potential for up to two months of salary in the FY 2024-2025 budget. Based on current budgetary levels, this change would not exceed the current electric department salary budget for FY 2024-2025.

### **E. Sewer Inspection Camera Replacement**

**Staff: Brandon Schrader**

Included in the FY 2024-2025 Capital Improvement Budget for Wastewater is the purchase of a mainline sewer inspection camera and crawler to replace the current unit. The current camera and crawler were purchased in 2017 as a used demo unit for \$20,750.00 from Jack Doheny Supplies. Prior to acquiring this camera, the City was limited to contracting out televising services for collection systems.

The mainline inspection camera has been proven to be a vital piece of equipment for the City in detecting failure of infrastructure, areas of concern, penetrations of service lines, and obstructions causing changes in flow channels. In addition, it has been valuable in providing condition assessments of sanitary and storm sewer pipelines. Having the ability visually access points of concern, locate, and document these areas eliminates the use of contracted services for most televising needs.

Staff evaluated several different mainline inspection cameras beginning in January of this year. Four different demonstrations were conducted (MTech, Pipe Trekker, Minicam and Aries), giving staff hands-on experience with each piece of equipment. Ultimately the Minicam and Aries units were identified as those that best fit the needs of the City.

Minicam checked all the boxes with the Proteus 140MM Crawler and Camera package, which is the new step-up model from our current unit. This Crawler and Camera package offers a motorized cable reel, motorized lift, portable enclosed controller with 12" display screen, back eye with auxiliary light, and multi-frequency sonde. Information on the unit is included in the packet.

The Proteus package also allows for portability and Minicam also has some interchangeable components that can be utilized between both current and new models, lowering costs for purchasing additional items. Fredrickson Supply, a

Sourcewell vendor, provided a quote of \$99,976.00 for the Minicam Proteus Crawler and Camera package.

The comparable Aries system is the Voyager Mobile unit. Compared to the Minicam Proteus this unit is more expensive, quoted at \$145,325.00 (quote included in the packet), and works as more of a stationary unit dedicated to a specific vehicle or trailer. Based on these factors, staff is recommending the purchase of the Minicam Proteus unit.

The Wastewater capital budget includes \$80,000.00 allocated for the purchase of a sewer replacement camera. Although the proposed Minicam unit is over budget by \$19,976.00, anticipated cost savings of \$23,424.00 for the Intermediate Pump Replacement project approved in May will cover the overage of this recommended purchase. A Budget and Cost spreadsheet is included in your packet.

### **F. Michigan Gas Utilities Franchise Ordinance First Reading**

The City of Sturgis has had authorizations in place, at least since 1954, that grants Michigan Gas Utilities the right to operate its natural gas system within the City. That franchise has expired and Michigan Gas Utilities has reached out to City Staff to replace the previous authorization with a similar ordinance authorizing its franchise.

To facilitate the adoption of the new ordinance, Michigan Gas Utilities sent proposed language that is substantially similar to the current authorizing language; staff used this language as the basis for a new ordinance section and included some minor changes of its own. Included in your packet is a draft version of the ordinance, which would be included under Chapter 62 – Utilities, in a new Article V. – Michigan Gas Utilities Franchise.

Based on City Charter, franchise authorizations and reauthorizations should be adopted as official City Ordinances and included in the Code of Ordinances, however, dating back to records prior to recodification of the ordinance in the mid-1990's the Franchise approval for Michigan Gas Utilities has not appeared there. The previous approval, based on Commission Meeting Minutes from 1994, was an adopted resolution for the renewal approved by the Commission and presented as an "ordinance", though it does not appear to have been officially adopted as an ordinance by our procedures.

Changes made in the new draft ordinance from the previous language approved include:

- References to the corporate name of Michigan Gas Utilities Corporation (under the previous approval it was UtiliCorp United Inc.),
- Some language related to the effective date of the franchise,

- Language in the Hold Harmless section which does not require Michigan Gas Utilities to hold us harmless if an issue arises from our negligence,
- A section relating to repeal of prior authorizations, and
- A change in where they can place utilizes from “other public places” to “authorized easements”.

In addition, several sections relating to effective date, publication, and recording of the ordinance were removed as they are redundant or obsolete based on the City Charter. A copy of the 1994 Commission Meeting minutes showing the last approved renewal language is included in your packet.

This draft ordinance will be reviewed by Michigan Gas Utilities to ensure no additional changes are necessary. A final version will be presented to the City Commission at a future meeting for a second reading and approval.

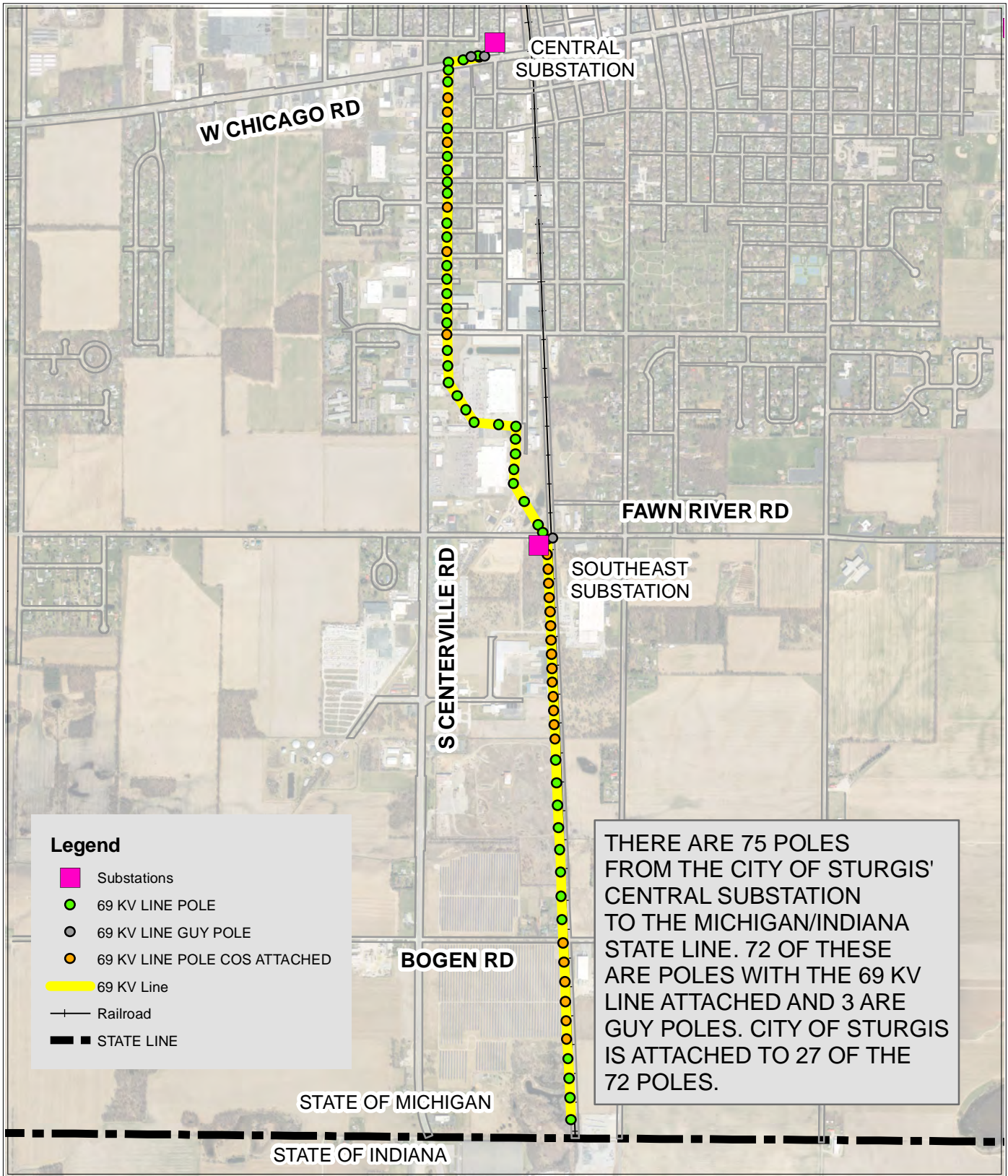

## ASSIGNMENT AND ASSUMPTION OF EASEMENTS

This Assignment and Assumption of Easements ("**Assignment**") is made to be effective as of \_\_\_\_\_, 2025 ("**Execution Date**") by and between INDIANA MICHIGAN POWER COMPANY, an Indiana corporation ("**Assignor**"), and CITY OF STURGIS, a Michigan municipal corporation ("**Assignee**"). Assignor and Assignee may be referred to herein each as a "**Party**" or collectively as the "**Parties.**"

### 1. ASSIGNMENT OF EASEMENT

- 1.1 In consideration of Ten and no/100 (\$10.00) Dollars and the mutual covenants set forth herein and other good and valuable consideration, the receipt and sufficiency of which the Parties acknowledge, Assignor transfers, conveys, sells and assigns to Assignee all of Assignor's right, title and interest in and to, and liabilities, obligations and duties (the "**Easement Rights**") contained in those certain easements and rights of way (individually, each an "**Easement**" and collectively the "**Easements**") described in Exhibit A, attached hereto and made a part hereof for all purposes. This conveyance is exempt from Michigan real estate transfer tax under MCL 207.526(a) and MCL 207.505(a).
- 1.2 This Assignment is made pursuant to the Bill of Sale ("**Bill of Sale**") of even date herewith, by and between Assignor (as Seller) and Assignee (as Buyer), and incorporated herein by reference.

### 2. EASEMENT AREA

The easement area is the area described in the easements over which the assignor was granted the easement rights.

### 3. USE OF EASEMENT

Assignee agrees that Assignee shall use each Easement only in accordance with the rights, liabilities, obligations and duties set out in the pertinent Easement and consistent with the terms of such Easement.

**4. WARRANTY OF TITLE**

As part of the consideration for this Assignment, Assignee assumes all liabilities, obligations and duties of Assignor pertaining to the Easement Rights. By assuming such liabilities, obligations and duties, Assignee releases and discharges Assignor from all liabilities, obligations and duties pertaining to the Easement Rights. It is acknowledged and agreed that Assignor shall not be responsible for the discharge and performance of any duties or obligations to be performed or discharged in connection with the Easement Rights on and after the Execution Date. ## Bill of Sale

This Bill of Sale is entered into as of [DATE] (“**Execution Date**”) between Indiana Michigan Power Company, an Indiana corporation (“**Seller**”), and City of Sturgis, a Michigan municipal corporation (“**Buyer**”).

### RECITALS

- A. Seller owns certain transmission line assets listed on **Exhibit A** attached to and made a part of this Bill of Sale (“**Assets**”).
- B. Seller intends to sell and Buyer intends to purchase the Assets pursuant to this Bill of Sale.

Now therefore, for good and valuable consideration, the receipt and sufficiency of which is hereby acknowledged, the parties agree as follows:

1. Conveyance. For good and valuable consideration in the amount of \$1.00 (the “**Purchase Price**”), the receipt and adequacy of which Seller hereby acknowledges, Seller hereby irrevocably sells, assigns, transfers, conveys, grants, bargains and delivers to Buyer, all of its right, title and interest in and to the Assets. Title to, and risk of loss of, the Assets shall pass to Buyer as of the first moment, local time in [LOCATION OF ASSETS], on the Execution Date.

2. Indemnification. **TO THE EXTENT PERMITTED BY LAW:**

(a) **BUYER SHALL INDEMNIFY, DEFEND AT ITS EXPENSE, AND HOLD SELLER HARMLESS, FROM ANY LIABILITIES, COSTS AND CLAIMS, INCLUDING JUDGMENTS RENDERED AGAINST, AND FINES AND PENALTIES IMPOSED UPON, SELLER AND REASONABLE ATTORNEYS’ FEES AND ALL OTHER COSTS OF LITIGATION, ARISING OUT OF OR RELATED TO THE OWNERSHIP OF THE ASSETS ON AND AFTER THE EXECUTION DATE, INCLUDING INJURIES, DISEASE OR DEATH TO PERSONS, OR DAMAGE TO PROPERTY, INCLUDING ENVIRONMENTAL CLAIMS AND LIABILITIES CAUSED BY BUYER, ITS EMPLOYEES, AGENTS OR CONTRACTORS, OR IN ANY WAY ATTRIBUTABLE TO THE PERFORMANCE OF THIS BILL OF SALE, EXCEPT THAT BUYER’S OBLIGATION TO INDEMNIFY SELLER SHALL NOT APPLY TO THE EXTENT ANY LIABILITIES ARISE FROM SELLER’S SOLE NEGLIGENCE. WITH RESPECT TO CLAIMS AGAINST SELLER BY BUYER’S EMPLOYEES, BUYER AGREES TO EXPRESSLY WAIVE ITS IMMUNITY AS A COMPLYING EMPLOYER UNDER ANY WORKERS’ COMPENSATION LAW, BUT ONLY TO THE EXTENT THAT SUCH IMMUNITY WOULD BAR OR**

**AFFECT RECOVERY UNDER OR ENFORCEMENT OF BUYER'S INDEMNIFICATION OBLIGATIONS; AND**

**(b) SELLER SHALL INDEMNIFY, DEFEND AT ITS EXPENSE, AND HOLD BUYER HARMLESS, FROM ANY LIABILITIES, COSTS AND CLAIMS, INCLUDING JUDGMENTS RENDERED AGAINST, AND FINES AND PENALTIES IMPOSED UPON, BUYER AND REASONABLE ATTORNEYS' FEES AND ALL OTHER COSTS OF LITIGATION, ARISING OUT OF OR RELATED TO THE OWNERSHIP OF THE ASSETS PRIOR TO THE EXECUTION DATE, INCLUDING INJURIES, DISEASE OR DEATH TO PERSONS, OR DAMAGE TO PROPERTY, INCLUDING ENVIRONMENTAL CLAIMS AND LIABILITIES CAUSED BY SELLER, ITS EMPLOYEES, AGENTS OR CONTRACTORS, EXCEPT THAT SELLER'S OBLIGATION TO INDEMNIFY BUYER SHALL NOT APPLY TO THE EXTENT ANY LIABILITIES ARISE FROM BUYER'S SOLE NEGLIGENCE. WITH RESPECT TO CLAIMS AGAINST BUYER BY SELLER'S EMPLOYEES, SELLER AGREES TO EXPRESSLY WAIVE ITS IMMUNITY AS A COMPLYING EMPLOYER UNDER ANY WORKERS' COMPENSATION LAW, BUT ONLY TO THE EXTENT THAT SUCH IMMUNITY WOULD BAR OR AFFECT RECOVERY UNDER OR ENFORCEMENT OF SELLER'S INDEMNIFICATION OBLIGATIONS.**

3. Representations and Warranties. Seller represents and warrants that: (a) Seller is conveying good and valid title to all Assets, free and clear of all encumbrances, debts, mortgages, attachments, pledges, charges, claims and liens of any kind; and (b) Seller has the right to sell the Assets to Buyer and shall warrant and defend the right against the lawful claims and demands of all persons.

4. Disclaimer of Warranties. **EXCEPT FOR THE WARRANTIES SET FORTH IN SECTION 3 ABOVE, SELLER MAKES NO REPRESENTATION OR WARRANTY WHATSOEVER WITH RESPECT TO THE ASSETS, INCLUDING ANY (a) WARRANTY OF MERCHANTABILITY; (b) WARRANTY OF FITNESS FOR A PARTICULAR PURPOSE; OR (c) WARRANTY AGAINST INFRINGEMENT OF INTELLECTUAL PROPERTY RIGHTS OF A THIRD PARTY; WHETHER ARISING BY LAW, COURSE OF DEALING, COURSE OF PERFORMANCE, USAGE OF TRADE OR OTHERWISE. BY ACCEPTING THIS BILL OF SALE, (x) BUYER ACKNOWLEDGES THAT IT HAS NOT RELIED ON ANY REPRESENTATION OR WARRANTY MADE BY SELLER, OR ANY OTHER PERSON ON SELLER'S BEHALF, EXCEPT AS SET FORTH IN SECTION 3 ABOVE; (y) BUYER ACCEPTS THE ASSETS "AS IS, WHERE IS" AND "WITH ALL FAULTS," INCLUDING TO THE EXTENT THE ASSETS DO NOT COMPLY WITH APPLICABLE LAW OR PERMITS; AND (z) BUYER ACKNOWLEDGES THAT IT IS RESPONSIBLE FOR THE USE, OPERATION,**

## Chapter 62 – UTILITIES

...

### ARTICLE V. - MICHIGAN GAS UTILITIES FRANCHISE

#### **Sec. 62-271. - Granting of Franchise to Use Highways, Streets, Alleys and Public Places.**

The City of Sturgis, County of St. Joseph, State of Michigan, (hereinafter called "City"), hereby grants to Michigan Gas Utilities Corporation, a Delaware corporation (hereinafter called "Grantee"), its successors and assigns, a franchise to use the highways, streets, alleys and authorized easements of the City of Sturgis, County of St. Joseph, State of Michigan, for the purpose of constructing, maintaining and operating a gas distribution system in said City with full right, power and authority to establish, construct, maintain, extend and operate a plant, stations, mains, pipes, conduits, valves, drips and all other appurtenances, apparatus and appliances within the corporate limits of the City of Sturgis, County of St. Joseph, State of Michigan, for the purpose of supplying and distributing to said City and its inhabitants gas for heating and other purposes and, for such purposes, to enter upon and use the highways, streets, alleys, and public lands of said City and lay, maintain, operate, repair and extend therein, through and thereunder such mains, pipes, conduits, valves, drips, apparatus, appliances and other appurtenances as may be necessary and proper for the distribution of gas throughout and beyond said City and for the purpose of conducting and operating a gas business in said City subject to the terms and conditions hereinafter provided.

#### **Sec. 62-272. - Non-Disturbance of Public Travel: Restoration: Construction Maintenance.**

In laying its pipes, mains and other appurtenances and repairing and maintaining the same, Grantee shall interfere as little as possible with public travel. After opening any portion of the highways, streets, alleys or other authorized easement, Grantee shall within a reasonable time restore the same as nearly as possible to the same condition as prevailed before opening. While any portion of the highways, streets, alleys or other authorized easement is open, Grantee shall maintain reasonable barriers and lights at night and other warnings to the users of said highways, streets, alleys or other authorized easement.

**Sec. 62-273. Hold Harmless.**

Grantee shall at all times hold City harmless from any loss, damage and expense of any kind on account of the laying, constructing, maintenance, and use of said mains, pipes, conduits and other appurtenances. However, Grantee need not save City harmless from claims, losses and expenses arising out of the negligence of the City, its employees, contractors or agents.

**Sec. 62-274. Rates Established by Michigan Public Service Commission.**

The rates to be charged by Grantee and all rules of service shall be those which are established from time to time by the Michigan Public Service Commission or such other body which shall succeed to the jurisdiction, rights, powers and authority of said Commission.

**Sec. 62-275. Term: Effective Date.**

The rights granted in this franchise shall continue in full force and effect for a period of thirty (30) years from the effective date thereof. The effective date of this franchise shall be the latter of the date of the acceptance of the franchise by Grantee, which if accepted, shall be filed by the Grantee, in writing, within sixty (60) days after the enactment of this ordinance or the day following the date of publication of the ordinance.

**Sec. 62-276. Franchise Revocable; Irrevocability Upon Approval of Electors.**

The franchise herein granted shall be revocable at the will of the governing body of this City, provided, however, that the same shall become irrevocable if and when confirmed by a majority of the electors voting upon the question at the next general election or at any special election called for that purpose. Such special election shall be held at the request of said Grantee and the expenses thereof shall be paid for by the Grantee.

**Sec. 62-277. Repeal of Prior Authorizations.**

The Franchise Renewal adopted on October 12, 1994 by the City and all amendments thereto, are hereby repealed. The repeal of the above authorization and its amendments does not affect or impair any act done, offense committed, or right accruing, accrued, or acquired or liability, penalty, forfeiture, or punishment incurred prior to the time enforced, prosecuted, or inflicted.

AN ORDINANCE GRANTING TO UTILICORP UNITED INC., A DELAWARE CORPORATION DOING BUSINESS IN THE STATE OF MICHIGAN UNDER THE ASSUMED NAME MICHIGAN GAS UTILITIES, ITS SUCCESSORS AND ASSIGNS, THE RIGHT, POWER, AUTHORITY AND PERMISSION TO USE THE HIGHWAYS,

STREETS, ALLEYS AND OTHER PUBLIC PLACES OF THE CITY OF STURGIS, COUNTY OF ST. JOSEPH, STATE OF MICHIGAN, FOR THE PURPOSE OF LAYING AND MAINTAINING GAS PIPES, MAINS, CONDUITS, VALVES, DRIPS AND ALL NECESSARY APPURTENANCES IN, UNDER AND ALONG THE HIGHWAYS, STREETS, ALLEYS AND OTHER PUBLIC PLACES, OF SAID CITY, AND THE RIGHT, POWER AND PERMISSION TO CONDUCT AND OPERATE A GENERAL GAS BUSINESS AND DISTRIBUTION SYSTEM IN SAID CITY OF STURGIS, COUNTY OF ST. JOSEPH, STATE OF MICHIGAN FOR A PERIOD OF THIRTY (30) YEARS.

THE CITY COUNCIL OF THE CITY OF STURGIS, COUNTY OF ST. JOSEPH, STATE OF MICHIGAN HEREBY ORDAINS:

Section 1. Granting of Franchise to Use Highways, Streets, Alleys and Public Places. The City of Sturgis, County of St. Joseph, State of Michigan, (hereinafter called "Grantor"), hereby grants to UtiliCorp United Inc., a Delaware corporation doing business in the State of Michigan under the assumed name Michigan Gas Utilities, (hereinafter called "Grantee"), its successors and assigns, a franchise to use the highways, streets, alleys and other public places of the City of Sturgis, County of St. Joseph, State of Michigan, for the purpose of constructing, maintaining and operating a gas distribution system in said City with full right, power and authority to establish, construct, maintain, extend and operate a plant, stations, mains, pipes, conduits, valves, drips and all other appurtenances, apparatus and appliances within the corporate limits of the City of Sturgis, County of St. Joseph, State of Michigan, for the purpose of supplying and distributing to said City and its inhabitants gas for heating and other purposes and, for such purposes, to enter upon and use the highways, streets, alleys, and public lands of said City and lay, maintain, operate, repair and extend therein, through and thereunder such mains, pipes,



conduits, valves, drips, apparatus, appliances and other appurtenances as may necessary and proper for the distribution of gas throughout and beyond said City and for the purpose of conducting and operating a gas business in said City subject to the terms and conditions hereinafter provided.

Section 2. Non-Disturbance of Public Travel; Restoration; Construction Maintenance. In laying its pipes, mains and other appurtenances and repairing and maintaining the same, Grantee shall interfere as little as possible with public travel. After opening any portion of the highways, streets, alleys or other public place, Grantee shall within a reasonable time restore the same as nearly as possible to the same condition as prevailed before opening. While any portion of the highways, streets, alleys or other public place is open, Grantee shall maintain reasonable barriers and lights at night and other warnings to the users of said highways, streets, alleys or other public place.

Section 3. Hold Harmless. Grantee shall at all times hold Grantor harmless from any loss, damage and expense of any kind on account of the laying, constructing, maintenance, and use of said mains, pipes, conduits and other appurtenances.

Section 4. Rates Established by Michigan Public Service Commission. The rates to be charged by Grantee and all rules of service shall be those which are established from time to time by the Michigan Public Service Commission or such other body which shall succeed to the jurisdiction, rights, powers and authority of said Commission.

Section 5. Term; Effective Date. The rights granted in this franchise shall continue in full force and effect for a period of thirty (30) years from the effective date thereof. The effective date of this franchise shall be the date of the acceptance of the franchise by Grantee, which acceptance shall be filed by the Grantee, in writing, within sixty (60) days after the enactment of this ordinance.

Section 6. Franchise Revocable; Irrevocability Upon Approval of Electors. The franchise herein granted shall be revocable at the will of the governing body of this City, PROVIDED, however, that the same shall become irrevocable if and when confirmed by a three-fifths (3/5) majority of the electors voting upon the question at the next general election or at any special election called for that purpose. Such special election shall be held at the request of said Grantee.

Section 7. Expenses of Election Paid by Grantee. In the event of a special election, the expenses thereof shall be deposited with the Clerk of this City by the Grantee.

Section 8. Ordinance Effective Date. This ordinance shall take effect on the twenty-first (21st) day following the date of publication of the ordinance.

Section 9. Publication. The City Clerk is hereby directed to cause a true copy of this ordinance to be published in *The Sturgis Journal*, a newspaper printed and circulated within the community which this ordinance affects within one week of its passage.

Section 10. Recording of Ordinance. Within one week after the passage of this ordinance, the City Clerk shall record the ordinance within the books and records of the City kept by the Clerk for such purpose and the recording shall be authenticated by the signatures of the Mayor and the City Clerk.
