## **Requirements for Compliance**

- 1. **REGISTRATION FORM AND FEES:** Property owners shall register any and all rental units within the City limits. Said registration shall be effective for one year and it shall be the responsibility of the property owner or responsible local agent to re-register said rental unit on the first day of the month immediately preceding the expiration of the registration.
- 2. **INSPECTION**: Prior to occupying a rental unit, the property must be inspected by a City of Sturgis Code Official. When all repairs for that property are completed and fees paid a Certificate of Compliance can be issued.

## **Signature**

The individual signing below affirms that all information included on this form is accurate at the time of signing to the best of their knowledge. If the signer is the Owner of the property and lists a Manager on the above form, this also certifies that the Manager is an Agent authorized to take action with the City of Sturgis on behalf of this rental.
